MASTER'S REPORT

FINDINGS OF FACT

- 1. Michael R. Bourke (Bourke) is the record owner of claims 41S 10573-00, 41S 16500-00, 41S 16501-00, and 41S 16502-00.
- 2. Claims 41S 10573-00, 41S 16500-00, 41S 16501-00, and 41S 16502-00 were decreed with DNRC issue remarks:

Claim 41S 10573-00:

• THE CLAIMS LISTED FOLLOWING THIS STATEMENT MAY BE A MULTIPLE USE OF THE SAME RIGHT. THESE CLAIMS MAY NEED A MULTIPLE USE REMARK. 41S 10573-00, 41S 16501-00.

Claim 41S 16500-00:

MEANS OF DIVERSION WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA
WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM,
THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK

- THE DNRC MEMORANDUM FILED ON 11/30/2005 STATES THAT AN ONSTREAM RESERVOIR IN THE NWSWSW SEC 11, TWP 15N, RGE 14E JUDITH BASIN CO SHOULD BE ADDED TO THE POINT OF DIVERSION. THIS WILL BE HEARD AFTER PROPER NOTICE ON THE NEXT OBJECTION LIST.
- THE JUDITH BASIN COUNTY WATER RESOURCES SURVEY (1963) APPEARS TO INDICATE 0.00 ACRES IRRIGATED.
- USDA AERIAL PHOTOGRAPH NO(S). 30045-179-169, DATED 09/17/1979, APPEARS TO INDICATE 14.20 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.
- 3. Bourke was ordered to meet with the DNRC to address unresolved issue remarks. (Doc. 11.00).
- 4. DNRC Water Resource Specialist Carli Bluhm filed a Memorandum stating the Claimant failed to contact the DNRC. (Doc.² 3.00). Ms. Bluhm indicated she reviewed abstracts, scanned claim files, aerial photos, and the Judith Basin Water



Resources Survey aerial images and field notes. Maps and proposed abstracts were attached to the Memorandum.

- 5. **41S 10573-00:** Ms. Bluhm confirmed that consistent with the multiple-use information remark decreed on claims 41S 10573-00 and 41S 16501-00, the claims are multiple uses and she recommended removing the multiple-use issue remark.
- 6. **41S 16501-00:** As noted for claim 41S 10573-00, Ms. Bluhm recommended the multiple-use issue remark be removed from this claim.

Ms. Bluhm also confirmed the decreed point of diversion and indicated the point of diversion issue remark should be removed with no modification to the element.

Ms. Bluhm indicated that the DNRC found "a maximum of 31.70 acres of irrigation" and recommended the following modifications be made to claim 41S 16501-00:



7. **41S 16502-00:** Ms. Bluhm confirmed the claimed irrigated acres for claim 41S 16502-00. Ms. Bluhm recommended the means of diversion be modified to:

8. To determine if Claimant Michael R. Bourke agreed or disagreed with Ms. Bluhm's recommendations, an Order setting a deadline for the Claimant to agree or disagree with the changes recommended by Ms. Bluhm was issued. The Order indicated that if nothing were filed by the deadline, this Water Master would conclude the Claimant

agreed with the recommended changes. The following language was included in the Order:

Failure to comply with the terms of this Order may result in sanctions, <u>up to and including entry of default and termination of a water right claim or dismissal of objections</u>. Rule 22, W.R.Adj.R.

Nothing was filed.

PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court must address all issue remarks decreed on a claim. Section 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 3. The means of diversion issue remark decreed on claim 41S 16500-00 is a notice-type remark and provided notice of an opportunity to object to the claim. No objections were filed, and no further proceedings are required.

RECOMMENDATIONS

- 1. The following modifications should be made to the claims in this Case:
 - Claim 41S 10573-00: No changes to elements.
 - Claim 41S 16500-00: No changes to elements.
 - Claim 41S 16501-00:
