You may file a written objection to this Master's Report within **10 days** of the stamped date if you disagree or find errors with the Master's findings of fact, conclusion of law, or recommendations. Rule 23, W.R.Adj.R. If the Master's Report was mailed to you, the Montana Rules of Civil Procedure allow an additional 3 days to be added to the 10-day objection period. Rule 6(d), M.R.Civ.P. If you file an objection, you must mail a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

#### **MASTER'S REPORT**

Mulvey Gulch Ranch LLC objected to claim 41E 93879-00. Each of these claims appeared in the Preliminary Decree with one or two issue remarks which need to be addressed. On July 22, 2024 the claimant filed a Motion To Resolve Objection And DNRC Issue Remarks. This settlement document is viewable in the Court's FullCourt Enterprise case management system.

#### **APPLICABLE LAW**

"All issue remarks to claims that are not resolved through the filing of an objection as provided in 85-2-233 must be resolved as provided in this section." Section 85-2-248(2), MCA.

A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content pursuant to section 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect including for claimants objecting to their own claims. Rule 19, W.R.Adj.R.

#### FINDINGS OF FACT

1. For claim 41E 93879-00, the Preliminary Decree includes the following issue remark:

THE FLOW RATE OF THIS WATER RIGHT HAS BEEN REDUCED TO THE 17 GPM PER ACRE
GUIDELINE. THE FLOW RATE MAY BE CONTESTED BY PROPER OBJECTION.

The Preliminary Decree states the flow rate is 3.86 CFS. The flow rate should be 5.00 CFS. The issue remark should be removed as addressed and resolved.

The Preliminary Decree states that the period of diversion and period of use are each APRIL 15 TO OCTOBER 1. They should each be APRIL 15 TO OCTOBER 4.

2. For claim 41E 93880-00, the Preliminary Decree includes the following issue remark:

THE LEGAL LAND DESCRIPTION FOR POINT OF DIVERSION NO. 2 COULD NOT BE REFINED FROM INFORMATION IN THE FILE. THIS CLAIMED POINT OF DIVERSION CANNOT BE CONFIRMED.

The claimant reviewed and confirmed that the legal description for point of diversion number 2 is correct as it appeared in the Preliminary Decree. The issue remark should be removed as addressed and resolved.

3. For claim 41E 94209-00, the Preliminary Decree includes the following issue remark:

THE POINT OF DIVERSION APPEARS TO BE INCORRECT. THE POINT OF DIVERSION APPEARS TO BE IN THE SWNWSE SEC 2 TWP 4N RGE 3W JEFFERSON COUNTY.

The Preliminary Decree states that the point of diversion legal description is the NWSE section 2, T4N, R3W, JEFFERSON. The legal description should be the SWNWSE section 2, T4N, R3W, JEFFERSON. The issue remark should be removed as addressed and resolved.

The Preliminary Decree also includes the following notice remark:

THE TIMELY FILED OBJECTION OF TOM CAREY CATTLE COMPANY WAS AMENDED BY AGREEMENT OF THE PARTIES TO INCLUDE PLACE OF USE. BECAUSE THIS ELEMENT WAS NOT INCLUDED ON THE OBJECTION LIST, ANY WATER USER WHOSE RIGHTS MAY BE ADVERSELY AFFECTED BY ENFORCEMENT OF THIS CHANGE MAY PETITION THE APPROPRIATE COURT FOR RELIEF OR MAY FILE AN OBJECTION AT THE PRELIMINARY DECREE.

This remark provides notice of this amendment made during the Temporary Preliminary Decree proceedings and does not raise an unresolved issue which needs to be addressed. The remark should be removed as having served its notice purpose.

4. For claim 41E 94211-00, the Preliminary Decree includes the following issue remark:

THE POINT OF DIVERSION APPEARS TO BE INCORRECT. THE POINT OF DIVERSION APPEARS TO BE IN THE NESES SEC 3 TWP 4N RGE 3W JEFFERSON COUNTY.

The claimant reviewed and confirmed that the legal description for point of diversion number 2 is correct as it appeared in the Preliminary Decree. The issue remark should be removed as addressed and resolved.

5. For claim 41E 94217-00, the Preliminary Decree includes the following issue remark:

THE POINT OF DIVERSION APPEARS TO BE INCORRECT. THE POINT OF DIVERSION APPEARS TO BE IN THE SWNWNW SEC 22 TWP 4N RGE 3W JEFFERSON COUNTY.

The Preliminary Decree states that the point of diversion legal description is the NWNW section 22, T4N, R3W, JEFFERSON. The legal description should be the SWNWNW section 22, T4N, R3W, JEFFERSON. The issue remark should be removed as addressed and resolved.

6. For claim 41E 192939-00, the Preliminary Decree includes the following issue remark:

7. For claim 41E 214741-00, the Preliminary Decree includes the following issue remark:

THE POINT OF DIVERSION APPEARS TO BE INCORRECT. THE POINT OF DIVERSION APPEARS TO BE IN THE SWSWNW SEC 13 TWP 5N RGE 4W JEFFERSON COUNTY.

The Preliminary Decree states that the point of diversion legal description is the NWNWSW section 13, T5N, R4W, JEFFERSON. The legal description should be the SWSWNW section 13, T5N, R4W, JEFFERSON. The issue remark should be removed as addressed and resolved.

The Preliminary Decree also includes the following notice remark:

DITCH NAME WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

This remark provides notice of a change made prior to issuance of the Preliminary Decree and does not raise an unresolved issue which needs to be addressed. The remark should be removed as having served its notice purpose.

8. For claim 41E 215667-00, the Preliminary Decree includes the following issue remark:

THE JEFFERSON COUNTY WATER RESOURCES SURVEY (1956) APPEARS TO INDICATE 320.00
ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.

The Preliminary Decree states that the maximum acres is 675.00 and the place of use includes various parcels in sections 11, 12, 13, and 14, T4N, R3W, JEFFERSON totaling 675.00 acres. The claimant reviewed and confirmed that the maximum acres and place of use are correct as they appeared in the Preliminary Decree. This is a late claim, filed after issuance of the Temporary Preliminary Decree in 1985. The prior owners, Claudette S. Shervin and Harold Shervin, amended the maximum acres and place of use in 1997. The February 3, 1997 letter from Marshall Sewell, Montana Department of Natural Resources and Conservation Water Resource Specialist in the Helena Regional Office, includes this statement: "I have redone the mylar, and refigured the acres. It appears that the total acres should be 675 for this claim." Exhibit L, attached to the July 22, 2024 Motion To Resolve Objection And DNRC Issue Remarks. The issue remark should be removed as addressed and resolved.

The Preliminary Decree also includes the following notice remarks:

CLAIM FILED LATE 06/26/96. IN ADDITION TO BEING SUBORDINATE TO ALL INDIAN AND FEDERAL RESERVED WATER RIGHTS AND ALL VALID TIMELY FILED CLAIMS BASED ON STATE LAW, THIS RIGHT MAY ALSO BE SUBORDINATE TO CERTAIN PERMITS AND RESERVATIONS OF WATER. SEE SECTION 85-2-221 MCA.

POINT OF DIVERSION AND DITCH NAME WERE MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

This remark provides notice of a change made prior to issuance of the Preliminary Decree and does not raise an unresolved issue which needs to be addressed. The remark should be removed as having served its notice purpose.

9. For claim 41E 216333-00, the Preliminary Decree includes the following issue remark: THE IRRIGATION TYPE IS MISSING.

THE POINT OF DIVERSION APPEARS TO BE INCORRECT. THE POINT OF DIVERSION APPEARS TO BE IN THE SWNWSE SEC 2 TWP 4N RGE 3W JEFFERSON COUNTY.

The Preliminary Decree does not include the irrigation type. It should be FLOOD. The irrigation type issue remark should be removed as addressed and resolved.

The Preliminary Decree states that the point of diversion legal description is the NWSE section 2, T4N, R3W, JEFFERSON. The legal description should be the SWNWSE section 2, T4N, R3W, JEFFERSON. The point of diversion issue remark should be removed as addressed and resolved.

10. For claim 41E 216334-00, the Preliminary Decree includes the following issue remark:

THE POINT OF DIVERSION APPEARS TO BE INCORRECT. THE POINT OF DIVERSION APPEARS TO BE IN THE NESESE SEC 3 TWP 4N RGE 3W JEFFERSON COUNTY.

NO IRRIGATION TYPE WAS CLAIMED

The Preliminary Decree does not include the irrigation type. It should be FLOOD. The irrigation type issue remark should be removed as addressed and resolved.

The claimant reviewed and confirmed that the legal description for the point of diversion is correct as it appeared in the Preliminary Decree. The point of diversion issue remark should be removed as addressed and resolved.

11. For claim 41E 216335-00, the Preliminary Decree includes the following issue remark:

NO IRRIGATION TYPE WAS CLAIMED

The Preliminary Decree does not include the irrigation type. It should be FLOOD. The issue remark should be removed as addressed and resolved.

The Preliminary Decree also includes the following notice remark:

DITCH NAME WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

This remark provides notice of a change made prior to issuance of the Preliminary Decree and does not raise an unresolved issue which needs to be addressed. The remark should be removed as having served its notice purpose.

#### **CONCLUSION OF LAW**

The settlement filed by the claimant is sufficient to contradict and overcome the prima facie claims and to resolve the issue remarks without evidentiary hearing. Sections 85-2-248(3) and (11), MCA.

#### RECOMMENDATIONS

Based upon the above Findings of Fact and Conclusion of Law, this Master recommends that the Court grant the Motion and make the changes specified in the Findings of Fact to correct the Preliminary Decree for this Basin. A Post Decree Abstract of Water Right Claim for each claim is served with this Report to confirm the recommended changes have been made in the state's centralized record system.
