You may file a written objection to this Master's Report within **10 days** of the stamped date if you disagree or find errors with the Master's findings of fact, conclusions of law, or recommendations. Rule 23, W.R.Adj.R. If the Master's Report was mailed to you, the Montana Rules of Civil Procedure allow an additional 3 days be added to the 10-day objection period. Rule 6(d), M.R.Civ.P. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

All water right claims that appeared in the Preliminary Decree for Sun River (Basin 41K) were subject to "issue remarks" resulting from pre-decree examination by

the DNRC, objections, and counterobjections. Each claim received issue remarks during the DNRC's review of the claims.

The claims were consolidated into Case 41K-0146-R-2024 and a filing deadline was set by the Water Court to resolve the issue remarks.

FINDINGS OF FACT

1. Claim 41K 92173-00 received the following substantive issue remark: THE POINT OF DIVERSION APPEARS TO BE INCORRECT. THE POINT OF DIVERSION APPEARS TO BE IN THE NWNENW SEC 5 TWP 20N RGE 7W LEWIS AND CLARK COUNTY.

Claim 41K 182316-00 received the following substantive issue remark: THE IRRIGATION TYPE IS MISSING.

- 2. On July 11, 2024, claimant James E. Breeden Jr. filed a *Response*. The *Response* states that the modification to the point of diversion for claim 41K 92173-00, proposed in the above-listed issue remark, is correct and the point of diversion for claim 41K 92173-00 should be modified to the NWNENW of Sec 5, Twp 20N, Rge 7W in Lewis and Clark County. The *Response* also states that the historical irrigation type for claim 41K 182316-00 is "flood."
- 3. Claims 41K 92164-00, 41K 92173-00, 41K 92174-00, 41K 92175-00, 41K 182316-00, and 41K 182317-00 also received notice-type issue remarks during the DNRC claims reexamination. No objections were filed.

PRINCIPLES OF LAW

- 1. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA; Rule 10, W.R.Adj.R.
- 2. Prima facie proof may be contradicted and overcome by a preponderance of the evidence. Rule 19, W.R.Adj.R.
- 3. A preponderance of the evidence is evidence that shows a fact is "more probable than not." *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 438, 240 P.3d 628.

- 4. If prima facie status is overcome, the burden shifts back to the claimant to demonstrate historical use. *79 Ranch v. Pitsch*, 204 Mont. 426, 432-33, 666 P.2d 215, 218 (1983).
- 5. Section 85-2-248(2), MCA, requires that the Water Court resolve all issue remarks that are not resolved through the objection process. *See also* Rule 7, W.R.Adj.R.
- 6. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. Sections 85-2-227, -231(2), MCA.
- 7. When resolving issue remarks, the Water Court must weigh the information resulting in the issue remark and the issue remark against the claimed water right. Section 85-2-247(2), MCA. The factual evidence on which an issue remark is based must meet the preponderance of evidence standard before the prima facie status of a claim is overcome. 43Q 200996-00 et al., Order Establishing Volume and Order Closing Case, at 18, June 8, 2015.

CONCLUSIONS OF LAW

- 1. The proposed modifications agreed to in Mr. Breeden's *Response* resolve the substantive issue remarks appearing on claims 41K 92173-00 and 41K 182316-00. Based on the information contained in the *Response*, the claims should be modified as described in Finding of Fact No. 2. The substantive issue remarks should be removed from the claims.
- 2. The notice-type issue remarks appearing on each of the claims served their notice purpose and should be removed from the claims.

RECOMMENDATIONS

Based on the foregoing Findings of Fact and Conclusions of Law, this Master recommends that the Court adopt the changes as outlined above.

Post decree abstracts of the water right claims reflecting the recommended changes are attached to this Report.
