## **MASTER'S REPORT**

# FINDINGS OF FACT

- 1. Janelle L. Bergum and Raymond A. Luther (Claimants) are the record co-owners of claim 41S 101857-00. Bergum is the record owner of claims 41S 101858-00, and 41S 101859-00.
- 2. Claims 41S 101857-00, 41S 101858-00, and 41S 101859-00 were decreed with DNRC issue remarks:

#### 41S 101857-00:

 USDA AERIAL PHOTOGRAPH NOS. 30027-278-74 AND 30027-278-76, DATED 09/25/1979, APPEAR TO INDICATE 60.60 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.


#### 41S 101858-00:

- THE FERGUS COUNTY WATER RESOURCES SURVEY ( 1970 ) APPEARS TO INDICATE 0.00 ACRES IRRIGATED.
- USDA AERIAL PHOTOGRAPH NO(S). 30027-278-4, DATED 09/25/1979, APPEARS TO INDICATE 30.00 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.
- THE POINTS OF DIVERSION MAY BE INCORRECT. THE LOCATIONS OF THE HEADGATES CANNOT BE IDENTIFIED FROM AVAILABLE DATA.

- THE MEANS OF DIVERSION DOES NOT APPEAR TO BE STANDARDIZED. THE MEANS OF DIVERSION FOR POINT OF DIVERSION NO. 1 APPEARS TO BE A DAM.
- IT APPEARS THE RESERVOIR ASSOCIATED WITH THE ORIGINAL APPROPRIATION MAY NO LONGER BE USED FOR THIS RIGHT.
- THE SOURCE NAME DOES NOT APPEAR TO BE STANDARDIZED. IT APPEARS THE SOURCE NAME SHOULD ACTUALLY BE SUBIRRIGATION, UNNAMED TRIBUTARY OF MEADOW CREEK.
- THE CLAIMED VOLUME APPEARS TO BE EXCESSIVE FOR THE CLAIMED PURPOSE. THE CLAIMED VOLUME EQUALS 73.9 TIMES THE CAPACITY OF THE RESERVOIR.
- THE CLAIMANT DID NOT IDENTIFY THE PERIOD OF DIVERSION FOR THIS RIGHT. A PERIOD OF DIVERSION HAS BEEN ADDED TO MATCH THE PERIOD OF USE. IF NO OBJECTIONS ARE RECEIVED TO THE PERIOD OF DIVERSION OR PERIOD OF USE, THOSE ELEMENTS WILL BE DECREED AS SHOWN ON THIS ABSTRACT AND THIS ISSUE REMARK WILL BE REMOVED FROM THIS CLAIM.
- RESERVOIR RECORD WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA
  WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS
  CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND
  THE REMARK WILL BE REMOVED FROM THE CLAIM.

- 3. The Claimants were ordered to meet with the DNRC to address the unresolved issue remarks decreed on the claims.
- 4. On July 22, 2024, DNRC Water Resource Specialist Carli Bluhm filed a Memorandum stating she met with the Claimants on June 25, 2024. (Doc.\* 2.00). Ms. Bluhm indicated she reviewed scanned claim files, aerial photos, and the Fergus County and Judith Basin County Water Resources Surveys to prepare the Memorandum. Maps and proposed abstracts were included with the Memorandum.
- 5. **Claim 41S 101857-00:** To address the issue remark and historical use of claim 41S 101857-00, Ms. Bluhm recommended claim 41S 101857-00 be reduced to 97.00 acres, as follows:



- 6. Claim 41S 101858-00: Ms. Bluhm reported that the 1970 aerial photograph did not show irrigation at the claimed place of use and "The claimant explained they have no memory of irrigation present on this claimed land." Ms. Bluhm recommended claim 41S 101858-00 be dismissed.
- 7. **Claim 41S 101859-00:** Ms. Bluhm recommended the following modifications be made to claim 41S 101859-00, addressing the unresolved issue remarks:

8. An Order was issued setting a deadline for Claimants Raymond A. Luther and Janelle L. Bergum to file statements agreeing or disagreeing with the proposed modifications to the claims in this Case. The Order also set a deadline for Claimant Janelle L. Bergum file a statement agreeing or disagreeing the claims be modified as recommended by Ms. Bluhm. The Order indicated that if nothing were filed by the deadline this Water Master would conclude the Claimants agree the claims should be modified as described. The following language was included in the Order:

Failure to comply with the terms of this Order may result in sanctions, <u>up to and including entry of default and termination of a water right claim or dismissal of objections</u>. Rule 22, W.R.Adj.R.

Nothing was filed.

# PRINCIPLES AND CONCLUSIONS OF LAW


- 1. The Water Court must address all issue remarks decreed on a claim. Section 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect.

This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.

3. The period of diversion and reservoir record issue remarks decreed on claim 41S 101859-00 are notice-type remarks. No objections were filed, and no further proceedings are required.

# RECOMMENDATIONS

1. Claim 41S 101857-00 should be modified as follows:



Claim 41S 101858-00 should be dismissed. And claim 41S 101859-00 should be modified as follows:
