# FINDINGS OF FACT

- 1. Bokma Grain Inc. (hereinafter referred to as "Bokma" and "the Claimant") is the record owner of claims 41S 3324-00, 41S 3325-00, 41S 3326-00, 41S 3327-00, 41S 3329-00, 41S 3330-00, 41S 3331-00, and 41S 3332-00.
- 2. Bokma was ordered to meet with the DNRC to address unresolved issue remarks decreed on Claims 41S 3324-00, 41S 3325-00, 41S 3326-00, 41S 3327-00, 41S 3328-00, 41S 3329-00, 41S 3330-00, 41S 3331-00, and 41S 3332-00:








6. Claim 41S 3326-00: Claim 41S 3326-00 was claimed for 160.00 acres of irrigation from Wolf Creek. During verification of the claim, the DNRC reduced the place of use to 5.00 acres and never reinstated the claimed 160.00-acre place of use. Mr. Ahlgren recommended the following modifications be made to claim 41S 3326-00, addressing the issue remarks:



7. Claim 41S 3327-00: Claim 41S 3327-00 was claimed for 160.00 acres of irrigation from an Unnamed Tributary of Spring Creek. During verification of the claim, the DNRC reduced the place of use to 55.00 acres and never reinstated the claimed

160.00-acre place of use. Mr. Ahlgren recommended the following modifications be made to claim 41S 3327-00, addressing the issue remarks:



In addition to the place of use and corresponding flow rate issue remarks, claim 41S 3327-00 was decreed with an issue remark indicating that DNRC was unable to locate the headgate. DNRC failed to provide any information to substantiate the basis of the issue remark.

- 8. Claim 41S 3328-00: Claim 41S 3328-00 was claimed for 40.00 acres of irrigation from Spring Creek. Using the available resources, Mr. Ahlgren could not confirm irrigation at the claimed place of use. Additionally, Mr. Ahlgren reported that the point of diversion sits at a lower elevation than the claimed place of use. Mr. Ahlgren recommended claim 41S 3328-00 be dismissed.
- 9. Claim 41S 3329-00: Claim 41S 3329-00 was claimed for 280.00 acres of irrigation from Spring Creek. During verification of the claim, the DNRC reduced the place of use to 139.00 acres and never reinstated the claimed 280.00-acre place of use. Mr. Ahlgren recommended the following modifications be made to claim 41S 3329-00, addressing the issue remarks:

Claim 41S 3330-00 was also decreed with a volume issue remark that this Water Master neglected to include in the May 28, 2024 issue remark resolution Memorandum:


THE CLAIMED VOLUME APPEARS TO BE EXCESSIVE FOR THE CLAIMED PURPOSE. THE CLAIMED VOLUME EQUALS 41.88 TIMES THE CAPACITY OF THE RESERVOIR.

On July 9, 2024, this Water Master requested Mr. Ahlgren send a recommendation to address the volume issue remark, and Mr. Ahlgren responded:

Regarding 41S 3330-00, this claim is for an onstream reservoir. When an onstream reservoir is involved, DNRC guidelines for volume are "the capacity of the reservoir x 2.5 fills". Since this reservoir is 7.0 Acre Feet in size, times 2.5 fills, it results in a volume of 17.5 Acre-Feet. The DNRC recommends the volume of the claim be reduced to 17.5 Acre-Feet. If the Court accepts this, the DNRC recommends the issue remark be removed.


(Doc. 3.00). Mr. Ahlgren recommended the volume for claim 41S 3330-00 be reduced to 17.50 acre-feet, resolving the volume issue remark decreed on the claim.

12. Claim 41S 3332-00: Claim 41S 3332-00 was claimed for 160.00 acres of irrigation from Wolf Creek. During verification of the claim, the DNRC reduced the place of use to 90.00 acres and never reinstated the claimed 160.00-acre place of use.

Mr. Ahlgren recommended the following modifications be made to claim 41S 3332-00, addressing the issue remarks:



13. An Order was issued to determine if Bokma agreed or disagreed with Mr. Ahlgren's recommendations regarding the claims. The Order indicated that if nothing were filed by the deadline, this Water Master would conclude that Claimant Bokma Grain Inc. agreed that claim 41S 3328-00 should be dismissed and the other claims should be modified as recommended by Mr. Ahlgren. The following language was included in the Order:

Failure to comply with the terms of this Order may result in sanctions, <u>up to and including entry of default and termination of a water right claim or dismissal of objections</u>. Rule 22, W.R.Adj.R.

Nothing was filed.

# PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court must address all issue remarks decreed on a claim. Section 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 3. The period of diversion and means of diversion issue remarks decreed on claim 41S 3330-00 are notice-type remarks. No objections were filed, and no further proceedings are required.


4. The issue remarks decreed on claims 41S 3324-00, 41S 3325-00, 41S 3326-00, 41S 3327-00, 41S 3328-00, 41S 3329-00, 41S 3330-00, and 41S 3332-00 indicating the "maximum combined acres for this group of supplemental claims may require modification..." is not relevant because supplemental rights remarks no longer include a quantified acreage figure. Furthermore, supplemental rights remarks will be removed at the final decree stage.
