MASTER'S REPORT

FINDINGS OF FACT

- 1. Claims 41S 28144-00, 41S 135584-00, 41S 135585-00, 41S 135586-00, 41S 135587-00, 41S 135588-00, 41S 30123669, and 41S 30123670 are owned by variations of the following owners: Jerry D, Hanley, Jamie L. Hanley, Connie J. Hyde, Niki K. Hyde, and Peggy J. Twedt
- Claims 41S 28144-00, 41S 135584-00, 41S 135585-00, 41S 135586-00,
 41S 135587-00, 41S 135588-00, 41S 30123669, and 41S 30123670 were decreed
 with Montana Department of Natural Resources (DNRC) issue remarks, all issue remarks
 must be resolved.
 - 3. Claim 41S 28144-00 was decreed with the following issue remark:

 MEANS OF DIVERSION WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER

 COURT DESPANDING TO THE SECOND AND THE

COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

The remark explains that DNRC modified the means of diversion during reexamination of claim 41S 28144-00.

4. Claims 41S 135584-00, 41S 135585-00, 41S 135586-00, 41S 135587-00, and 41S 135588-00 were decreed with the following DNRC issue remark:

THE POINT OF DIVERSION MAY BE INCORRECT. THE LOCATION OF THE HEADGATE CANNOT BE IDENTIFIED FROM AVAILABLE DATA.

The DNRC did not provide information explaining why the point of diversion issue remark was placed on the claims.

- 5. Claims 41S 30123669 and 41S 30123670 were decreed with an issue remark explaining that they were not included in the 1984 decree in this Basin.
 - 6. No objections were filed.

PRINCIPLE OF LAW

1. The Water Court must address all issue remarks decreed a claim. Section 85-2-248, MCA.

2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.

CONCLUSION OF LAW

- 1. The issue remarks decreed on claims 41S 139440-00, 41S 139442-00, and 41S 139445-00 are not supported by evidence sufficient to overcome the prima facie status afforded the point of diversion of the claim.
- 2. The means of diversion issue remark (41S 28144-00) and exempt claim issue remarks (41S 30123669 and 41S 30123670) decreed on some claims in this Case are notice-type issue remarks. As no objections were filed, no further proceedings are required.

RECOMMENDATIONS

1. The issue remarks should be removed from the claims in this Case with no changes to the elements of the claims.
