MASTER'S REPORT

FINDINGS OF FACT

1. B Bar Ranch LLC stock claim 43BV 136309-00 was decreed with DNRC issue remarks:

THE FLOW RATE IS MISSING.

THIS INTERBASIN TRANSFER CLAIM WAS NOT INCLUDED IN THE 43B BASIN TEMPORARY PRELIMINARY DECREE ISSUED 01/16/1985.

AS OF 09/30/1996, THIS WATER RIGHT APPEARS TO BE OWNED BY WES HENTHORNE, 1273 OTTER CREEK RD, BIG TIMBER, MT, 59011-7759.

POINT OF DIVERSION, DITCH NAME, MEANS OF DIVERSION, AND RESERVOIR RECORD WERE MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

THE PRIORITY DATE MAY BE QUESTIONABLE. THIS CLAIM IS FOR A USE RIGHT ON SWEET GRASS CREEK WITH A PRIORITY DATE PREDATING CASE NO. 342, SWEET GRASS COUNTY.

All issue remarks must be resolved. Many of the issue remarks decreed on claim 43BV 136309-00 are notice-type remarks and do not require further analysis.

2. Claim 43BV 136309-00 appeared in the Preliminary Decree for Basin 43BV without a flow rate. The April 29, 1982 Statement of Claim for claim 43BV 136309-00 indicated the flow rate is 10.00 miner's inches (112.20 gallons per minute):

3. An ownership remark indicated that as of September 30, 1996, claim 43BV 136309-00 was owned by another owner. Montana Cadastral indicates that the places of use to which claim 43BV 136309-00 is appurtenant are owned by the record owner and the ownership issue remark is outdated.

PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court is required to resolve the issues raised by each issue remark. Section 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont. 86, 95; 329 P.3d 558, 564. The existence of an issue remark alone does not overcome the prima facie

statement of claim. The issue remark decreed on claim 43BV 136309-00 is not supported by evidence sufficient to overcome the prima facie status afforded the flow rate of the claim.

- 3. The priority date issue remark decreed on claim 43BV 136309-00 indicated that the claim was not included in Case No. 342, Sweet Grass County. The record does not indicate why claim 43BV 136309-00 was not included in the Case. The lack of objections or notices of intent to appear indicates no other water users take issue with the priority date. The priority date issue remark is not supported by evidence sufficient to overcome the prima facie proof afforded the priority date for claim 43BV 136309-00. The issue remark has provided notice to claimants and other water users, and the remark can be removed from claim 43BV 136309-00.
- 4. The interbasin transfer and point of diversion, ditch name, means of diversion, and reservoir record issue remarks decreed on claim 43BV 136309-00 are notice-type issue remarks. As no objections were filed, no further proceedings are required.

RECOMMENDATIONS

- 1. The 112.20 gallons per minute flow rate (10.00 miner's inches) should be restored for claim 43BV 136309-00.
 - 2. The issue remarks should be removed from the claim.
