If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

Water right claim 43Q 208884-00 is livestock claim to water from a spring known as Emerald Springs. The record owners of the claim are Ed and Lisa Trout. On August 20, 2024, the Trouts filed a Verified Motion to Amend the water right. The Motion seeks to correct the legal land description of the point of diversion.

The Motion included an August 13, 2024, letter from Mark Elison, Regional Manager of the Billings office of the Department of Natural Resources and Conservation ("DNRC"). The DNRC letter states that DNRC conducted a site visit and identified the correct location for the point of diversion for the claim.

FINDINGS OF FACT

- 1. Claim 43Q 208884-00 correctly identifies its point of diversion in Lot 7, Block 4, Emerald Hills Subdivision. However, DNRC incorrectly modified the legal land description to the NESENW of Section 27, T1N, R27E during its examination.
- 2. The point of diversion legal land description should be corrected to the location requested in the Motion to Amend and confirmed by the DNRC site visit:

CONCLUSIONS OF LAW

- 1. Pursuant to § 85-2-233(6), MCA, claimants may file motions to amend their own claims and objectors may file motions to amend their own objections. Rule 10, W.R.Adj.R. A properly filed claim of an existing right or an amended claim of existing right is prima facie proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R. The modifications requested in the Motion to Amend are supported by a preponderance of the evidence and overcome the prima facie status of the claim.
- 2. When the Water Court receives a motion to amend, it reviews the motion to determine what, if any, additional notice of the motion is necessary. Rule 10, W.R.Adj.R. The Court conducts this review under § 85-2-233(6), MCA. When a party moves to

amend a claim filed after the issuance of a temporary preliminary decree or preliminary decree, the Court must evaluate whether the motion to amend "may adversely affect other water rights." *Id.* Because this claim already correctly identifies the point of diversion by its lot and block, the correction to the legal land description only clarifies an ambiguity on the face of the claim and does not have the potential to harm other water users.

RECOMMENDATIONS

Based on the foregoing Findings of Fact and Conclusions of Law, this Master recommends that the Court modify the claim as described above.

A Post Decree Abstract of Water Right Claim reflecting the recommended changes is attached to this Report for review.
