MASTER'S REPORT

FINDINGS OF FACT

1. Stock claim 41I 89418-00 and domestic claim 41I 89419-00 were decreed with a Montana Department of Natural Resources (DNRC) issue remark:

THE PRIORITY DATE MAY BE QUESTIONABLE. THE DATE OF FILING THE FORM GW2, NOTICE OF COMPLETION OF GROUNDWATER APPROPRIATION, IS 09/05/1969.

The DNRC added the remark to the claims during claim examination.

2. Dustin O'Connell objected to claims 41I 89418-00 and 41I 89419-00 indicating he is the proper owner of the claims. A Status Conference was conducted on June 20, 2024, only Objector Dustin E. O'Connell attended the Conference; the Minutes state:

The Court and the Objector discussed Mr. O'Connell's ownership objection to the claims in this case. It was determined that the Mr. O'Connell should be provided 60 days to file a Form 608 ownership update and any required supporting documentation with the DNRC.


If the remaining Claimants disagree with Mr. O'Connell's objection that he is the sole owner of the claims in this case, they must contact the Court by the deadline below. If nothing is received by the deadline, the Court will conclude the Claimants do not claim an ownership interest in the claims, and there is no dispute over ownership for the Water Court to resolve.


- 3. The DNRC processed ownership updates in September 2024, and the present record ownership of claims 41I 89418-00 and 41I 89419-00 reflects only Dustin O'Connell and Allison O'Connell as the record owners of the claims. The ownership updates appear to address Dustin O'Connell's ownership Objections.
- 4. Claims 41I 89418-00 and 41I 89419-00 were claimed and decreed as "filed" rights with June 13, 1968 priority dates. Both claims were also decreed with remarks questioning the priority date. All issue remarks must be addressed.

It appears the claimed June 13, 1968 priority dates reflect the date Jack Martinez noted on the Notice of Completion of Groundwater Appropriation by Means of Well

Form (GW2) (hereinafter "Notice of Completion") – the date the claimed well was completed.



The issue remark references the date the Notice of Completion was filed at the Lewis and Clark County Clerk and Recorder's Office – September 5, 1969:



PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court is required to address all issue remarks decreed on a claim as well as any objections the claim receives. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.
- 2. A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R.

The information in the claim file and provided by the claimant is sufficient to overcome the prima facie status of the claim. Claims 41I 89418-00 and 41I 89419-00 should be modified to modify the priority date to September 5, 1969.

- 3. Between January 1, 1962 and July 1, 1973, appropriators of groundwater were required to file both a Notice of Appropriation (GW1) and a Notice of Completion to have a claim's priority date relate back to when water was first diverted and used. At present, the record for claim 41I 89418-00 and 41I 89419-00 only includes a Notice of Completion; if only a Notice of Completion was filed, the priority date is the date of filing. Section 89-2913(e), RCM (1965). Based on the requirements of the 1961 Groundwater Code, the priority date for claims 41I 89418-00 and 41I 89419-00 should be September 5, 1969.
- 4. All parties subject to the jurisdiction of the Montana Water Court in this adjudication have the obligation to comply with Orders of this Court, including Orders issued by a Master appointed by the Court. If a claimant fails to comply with an Order issued by the Court in its review of issue remarks, the Court may amend the claim to conform with information found in the claim file and information before the Court. Section 85-2-248(9)(a), (b), MCA.

RECOMMENDATIONS

- 1. The priority date for claims 41I 89418-00 and 41I 89419-00 should be modified to September 5, 1969
- 2. The issue remarks should be removed from claims 41I 89418-00 and 41I 89419-00.
- 3. The Objections to claims 41I 89418-00 and 41I 89419-00 should be dismissed.
