## **MASTER'S REPORT**

The above-captioned claims appeared in the Preliminary Decree for the Judith River (Basin 41S) with substantive issue remarks.

The claims were consolidated into Case 41S-0445-R-2024 on October 18, 2024 and on June 5, 2025 the Department of Natural Resources and Conservation ("DNRC") filed a Memo ("Memo") (Doc. 1 8.00).

THE POINTS OF DIVERSION MAY BE INCORRECT. THE LOCATIONS OF THE HEADGATES CANNOT BE IDENTIFIED FROM AVAILABLE DATA.

SOURCE NAME FOR POINT OF DIVERSION NO. 1 COULD NOT BE CORRECTED AS IT IS A SPRING AS DIRECTED BY WATER COURT, NOT TO BE CORRECTED. IT APPEARS FROM THE TOPOGRAPHICAL MAP MOORE SW, THE SOURCE NAME SHOULD BE UNNAMED TRIBUTARY OF DRY CREEK.

- 20. Using the Fergus Co. WRS and USDA aerial photograph 30027-278-74, Mr. Ahlgren identified 0.00 acres of irrigation for claim 41S 134323-00.
- 21. Mr. Ahlgren found:
  - Due to the DNRC and the claimant not being able to substantiate any historic irrigation in the claimed place of use, the DNRC recommends this claim be dismissed.

THE FLOW RATE, VOLUME, MAXIMUM ACRES, AND PLACE OF USE DID NOT APPEAR ON THE ABSTRACT OF THIS CLAIM IN THE TEMPORARY PRELIMINARY DECREE DUE TO THE ISSUE REMARK CONCERNING THE VALIDITY OF THIS CLAIM. THE ELEMENTS AS CLAIMED HAVE BEEN ADDED. THE WATER COURT HAS MADE NO DETERMINATION OF THE VALIDITY OF THESE ELEMENTS.

THE POINT OF DIVERSION MAY BE INCORRECT. THE LOCATION OF THE HEADGATE CANNOT BE IDENTIFIED FROM AVAILABLE DATA.

- 40. Using the Fergus Co. WRS and USDA aerial photograph 30027-278-88, Mr. Ahlgren identified 0.00 acres of irrigation for claim 41S 134327-00.
- 41. Mr. Ahlgren found:
  - Due to the DNRC and the claimant not being able to substantiate any historic irrigation in the claimed place of use, the DNRC recommends this claim be dismissed.
- 42. The Court set a deadline for Claimant to state their position on Mr. Ahlgren's recommendations. (Doc. 9.00). The order stated that if nothing was filed by the deadline, Mr. Ahlgren's recommendations would be adopted. On June 18, 2025 Three Bar Ranch filed a notice of agreement (Doc. 10.00).

## PRINCIPLES OF LAW

- 1. The Montana Water Court has the authority to determine the extent of all water rights in the state as they existed prior to July 1, 1973. *Fellows v. Saylor*, 2016 MT 45, ¶ 25, 382 Mont. 298, 367 P.3d 732; §§ 85-2-233, -102(13), MCA.
- 2. A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the

elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R.

3. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. §§ 85-2-227, -231(2), MCA.

## **CONCLUSIONS OF LAW**

- 1. The issue remarks should be removed from claim 41S 134320-00 as discussed above.
  - 2. Claim 41S 134321-00 should be dismissed as discussed in Finding of Fact No. 10.
  - 3. Claim 41S 134322-00 should be dismissed as discussed in Finding of Fact No. 16.
  - 4. Claim 41S 134323-00 should be dismissed as discussed in Finding of Fact No. 21.
- 5. The issue remarks should be removed from claim 41S 134324-00 as discussed above.
- 6. The issue remarks should be removed from claim 41S 134325-00 as discussed above.
- 7. The issue remarks should be removed from claim 41S 134326-00 as discussed above.
  - 8. Claim 41S 134323-00 should be dismissed as discussed in Finding of Fact No. 41.

## RECOMMENDATION

1. Upon review of the record in this case, the claims should be modified as discussed above.
