# **MASTER'S REPORT**

# PROCEDURAL HISTORY

Proceedings in Cases 43A-0011-R-2020, 43A-0015-R-2020, 43A-0081-R-2020, 43A-0082-R-2020, 43A-0118-R-2020, and 43A-0395-R-2025 have been ongoing for several years; for much of that time, Cases 43A-0011-R-2020, 43A-0015-R-2020, 43A-0081-R-2020, 43-0082-R-2020, 43A-0118-R-2020 were in mediation.

On November 4, 2024, the parties in Cases 43A-0011-R-2020, 43A-0015-R-2020, 43A-0081-R-2020, 43A-0083-R-2020, and 43A-0118-R-2020 filed an Agreement Addressing Water Rights Associated with Jordan-Arthun Reservoir ("Stipulation"). (Doc. 149.00). The Stipulation was entered into between: Arthun Ranch, Inc. ("Arthun Ranch"); Rollin River Ranch, LLC ("Rollin River"); Levers Family Trust, Amend 2006, John G. Sessoms, and Trust for Matthew B. Levers (collectively, "Levers/Sessom"); Henry Guth Inc. ("Guth"); and 4 Diamond Ranch at Wallrock, LLC ("4 Diamond). The Stipulation resolves the various objections, counterobjections, and notices of intent to appear filed in Cases 43A-0011-R-2020, 43A-0015-R-2020, 43A-0081-R-2020, 43A-0082-R-2020, and 43A-0118-R-2020, and claim 43A 117118-00 (Case 43A-0395-R-2021)<sup>2</sup>. The Stipulation memorializes water management practices, a prior Reservoir Operation Agreement, and an Exchange Agreement; parties should look to the record for those details. The Stipulation standardizes elements of Jordan-Arthun Reservoir claims.

Case 43A-0395-R-2021 has been running alongside the other captioned cases as the parties waited for mediation to conclude.

The Stipulation also addressed claims that were previously consolidated in other Water Court Cases that were closed, along with claims not previously in front of the Court; those claims were consolidated into Case 43A-0400-R-2025. (Doc. 62.00). The claims in Case 43A-0400-R-2025 are addressed in this Master's Report.

An Order Setting Filing Deadline was issued on June 12, 2025, with the Master's Report attached in draft form. The Draft Master's Report process gave all parties, including those not previously involved in the process, the opportunity to agree or disagree with proposals set forth by the Stipulating parties:

...the deadline for all parties to review the enclosed Draft Master's Report and attached abstracts and file comments is July 31, 2025. Failure to file comments will be viewed as agreement with the findings, conclusions and recommendations found in this

**Draft Master's Report.** Any comments should be specific and must be filed on all parties.

Failure to comply with the terms of this Order may result in sanctions, <u>up to and including entry of default and termination of a water right claim or dismissal of objections</u>. Rule 22, W.R.Adj.R. (emphasis in original)

(Doc. 62.00).

Arthun; 4 Diamond; the Jacqueline Marie Shiplet Surviving Spouse's Trust, Robert Shiplet Marital Exemption Trust, Robert W. Shiplet, and Steven W. Shiplet (collectively "Shiplets"); and Guth responded by the July 31, 2025 deadline. Arthun and 4 Diamond indicated agreement with the Draft Masters Report and provided information as to where issue remarks had previously already been addressed in the record. (Doc. 63.00 and Case 43A-0015-R-2020, Doc. 72.00). The Shiplets indicated their agreement with the Draft Master's Report. (Case 43A-0015-R-2020, Doc. 71.00). Guth indicated it:

has reviewed the Draft Master's Report and attachments and does not agree with all that is stated therein, but in the interest of avoiding further litigation will not contest the Draft Master's Report.

(Case 43A-0400-R-2025, Doc. 4.00). Nothing was filed by other parties.

# FINDINGS OF FACT

# Withdrawals:

- 1. **Claim 43A 190929-00** (Case 43A-0011-R-2020): On May 21, 2021, Arthun Ranch, Inc. withdrew claim 43A 190929-00. (Doc. 19.00).
- 2. **Claim 43A 192122-00** (Case 43A-0081-R-2020): 4 Diamond withdrew claim 43A 192122-00 on January 29, 2021. (Case 43A-0081-R-2020, Doc. 7.00).
- 3. **Claim 43A 213209-00** (Case 43A-0082-R-2020): 4 Diamond withdrew claim 43A 213209-00 on February 2, 2021. (Case 43A-0082-R-2020, Doc. 7.00).

The remarks do not require further attention.

5. Claims 43A 190569-00, 43A 190570-00, 43A 190571-00, 43A 190572-00, 43A 190573-00, 43A 190574-00, 43A 190575-00, 43A 190576-00, 43A 190577-00, 43A 190578-00, 43A 190579-00, and 43A 190580-00 (Case 43A-0081-R-2020): In its January 29, 2021 Proposed Resolution of Objections and Remarks, 4 Diamond stated the following regarding the point of diversion for claim 43A 190569-00:

POD - Four PODs are listed on the preliminary decree abstract, summarized below. A map of the PODs and ditches is provided as Exhibit 4. The preliminary decree abstract also includes an issue remark stating that the legal land descriptions of PODs #3 and #4 cannot be confirmed.

- POD #1, Govt Lot 15 of Section 4, T4N R9E, corresponds to the Big Ditch diversion as listed on the preliminary decree abstract. There are no issues with this POD legal land description and no corrections are needed.
- POD #2, SESWSW Section 21, T4N R9E, corresponds to the Antelope Ditch diversion. The legal land description of this POD is accurate. However, a ditch name of "Antelope Ditch" should be added to POD #2.
- O POD #3 was claimed, and is listed on the preliminary decree abstract, as the SESESE of Section 20, T4N R9E. However, this POD is actually located at the Highway Ditch diversion in the SWSESW of Section 21 (see Exhibit 4). The legal land description of POD #3 should be corrected to the SWSESW of Section 21, T4N R9E, and a ditch name of "Highway Ditch" should be added to POD #3.
- POD #4, SESWNE of Section 29, T4N R9E, is a secondary POD from the Highway Ditch and should be removed from the 43A 190569 00 abstract.

4 Diamond proposed the same point of diversion modifications for claims 43A 190570-00, 43A 190571-00, 43A 190572-00, 43A 190573-00, 43A 190574-00, 43A 190575-00, 43A 190576-00, 43A 190577-00, 43A 190578-00, 43A 190579-00, and 43A 190580-00, addressing the point of diversion issue remarks decreed on the claims. (Case 43A-0081-R-2020, Doc. 7.00).

In addition to the point of diversion issue remarks, claims 43A 190570-00, 43A 190571-00, 43A 190572-00, 43A 190573-00, 43A 190574-00, 43A 190575-00, 43A 190576-00, 43A 190577-00, 43A 190578-00, 43A 190579-00, and 43A 190580-00 were decreed with notice-type issue remarks that do not require further attention.

The January 29, 2021 filing proposed other modifications to the claims in Case 43A-0081-R-2020 to resolve 4 Diamond's self-objections. The January 29, 2021 filing was a proposed resolution, in later opportunities to determine if the proposed resolution to the self-objections should be implemented, 4 Diamond did not take the opportunity to incorporate the proposals (see for example the Stipulation and the Order Setting Filing Deadline for the Draft Master's Report. The Stipulation (discussed at Findings of Fact Nos. 8 to 10) resolves 4 Diamond's objections.

6. **43A 190838-00** (Case 43A-0015-R-2020): Claim 43A 190838-00 was decreed with the following issue remark:

THE POINT OF DIVERSION APPEARS TO BE INCORRECT. THE POINT OF DIVERSION APPEARS TO BE IN THE SENESW SEC 4 TWP 4N RGE 9E PARK COUNTY.

Arthun addressed the issue remark in its October 25, 2021 Joint Motion for Mediation and Request for Stay Pending Mediation. (Doc. 28.00):

Claim 43A 190838-00 received an objection from Arthun Land, LLC and an issue remark concerning the point of diversion. The point of diversion associated with this claim is on Big Ditch, which is the same diversion as several reservoir claims for which the location of the point of diversion is being standardized by the parties. Thus, the point of diversion should match the location reflected on the reservoir claims once the abstracts are finalized. This correction should resolve the issue remark and Arthun withdraws its objection to any other elements of the claim.

Based on the record, the point of diversion for claim 43A 190838-00 should be modified to the E2E2SW of Section 4, T4N, R9E and the Ditch name is "Big Ditch."


7. **43A 213372-00** (Case 43A-0015-R-2020): Claim 43A 213372-00 was decreed with various issue remarks. Arthun addressed the following issue remarks decreed on claim 43A 213372-00 in its June 4, 2025 Motion to Resolve Issue Remarks (Case 43A-0015-R-2020, Doc.15.00):

THE PARK COUNTY WATER RESOURCES SURVEY (1951) APPEARS TO INDICATE 95.00 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.

THE POINT OF DIVERSION LEGAL LAND DESCRIPTION COULD NOT BE REFINED FROM INFORMATION IN THE CLAIM FILE

The Motion was supported by an Affidavit of Les Arthun who substantiated the decreed place of use and requested the following corrections to the claim to reflect the historically accurate point of diversion:

# Point of Diversion and Means of Diversion:



# The Stipulation:

- 8. According to the Stipulation, claims 43A 190582-00 and 43A 190584-00 should include the following standardizations:
  - Identification of the water right as a high water or flood water right with an information remark: "THIS RIGHT IS LIMITED TO HIGH OR FLOOD WATER OF SHIELDS RIVER."
  - The reservoir name is "Jordan-Arthun Reservoir".
    - o The legal land description is the NW of Section 17, T4N, R9E.
    - The reservoir record reflects that the dam height is 38.00 feet, surface area is 87.00 acres, and the capacity is 1,260.00 feet.
  - Point of Diversion No. 1 for Big Ditch is in the E2E2SW of Section 4, T4N, R9E, and references to Shields River Co. Canal are removed.
  - The periods of diversion and use are March 1 to November 30.

Additionally, Exhibit C indicates the volume of claims 43A 190582-00, and 43A 190584-00 should be modified to 1,555.80 acre-feet and the following remark should be added to claims 43A 190582-00 and 43A 190584-00: "THIS WATER RIGHT IS SUBJECT TO A PRIVATE EXCHANGE AGREEMENT AND STIPULATION ENTERED IN CASES 43A-0011-R-2020, 43A-0015-R-2020, 43A-0081-R-2020, 43A-0082-R-2020, 43A-0118-R-2020, 43A-0119-R-2020, and 43A-0395-R-2021."

- 9. According to the Stipulation, the "Stored Water Exchange Rights" (claims 43A 117118-00, 43A 190688-00, 43A 190841-00, and 43A 192631-00) should include the following standardizations:
  - The claim should include the following information remark: "THIS WATER RIGHT IS SUBJECT TO A PRIVATE EXCHANGE AGREEMENT AND STIPULATION ENTERED IN CASES 43A-0011-R-2020, 43A-0015-R-2020, 43A-

- 0081-R-2020, 43A-0082-R-2020, 43A-0118-R-2020, 43A-0119-R-2020, AND 43A-0395-R-2021."
- The claim should include the following information remark: "PURSUANT TO A PRIVATE EXCHANGE AGREEMENT, STORED WATER MAY BE USED ON THE PLACE OF USE OF WATER RIGHTS 43A 190685-0 THROUGH 43A 190697-00, 43A 117119-00, AND 43A 23720-00, 43A 23731-00, AND 43A 191258-00."




# PRINCIPLES OF LAW

- 1. The Water Court is required to address all issue remarks decreed on a claim as well as any objections the claim receives. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.
- 2. A properly filed claim of an existing right or an amended claim of existing right is prima facie proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R.
- 3. Pursuant to Rule 22, W.R.Adj.R., if a claimant, objector, or intervenor fails to appear at a scheduled conference or hearing or fails to comply with an order issued by the Water Court, the Water Court may issue such orders of sanction with regard thereto as are just.

- 4. The Water Use Act requires the Water Court to adjudicate the elements of each water right and include "any other information necessary to fully define the nature and extent of the right." *Bergtoll* at \*28-29 (Citing § 85-2-234(6)(a)-(h), MCA). "This provision recognizes the practical reality that sometimes additional explanation about how a water right was historically used, or the terms of a settlement agreement is required to ensure water rights are administered correctly." *Id*.
- 5. Claim 43A 213372-00 is a late claim. The late claim issue remark decreed on claim 43A 213372-00 gave notice that the claim could be subordinate and therefore junior to certain permits and reservations of water. Any party asserting a superior claim to water based on a permit or reservation was required to object to the late claim during the Basin 43A objection period. Because no such objections were filed, the late claim remark can now be removed from the claim.
- 6. Under Section 3-7-224, MCA the Water Court is directed to conduct hearings in the same manner as for other civil actions. The Water Court applies the Montana Rules of Civil Procedure (M.R.Civ.P.), the Montana Rules of Evidence (M.R.Evid.) and the Montana Uniform District Court Rules. This Master considers stipulations filed with the Court as "other paper" under M.R.Civ.P. Rule 11(b)(3) which certifies that to the best of the parties' knowledge the factual contentions contained within the Stipulation are supported by evidence. Add to this rule the recognition that "the heart of a judicial process is the development of the truth through conflict between parties with adverse interests." *United States of America (USDI) –Bureau of Indian Affairs)-General Objection to Basin 42B and 42C Preliminary Decrees*, Case 42B-1, ¶ 3 at p. 14, (*Order Denying Motion June 27*, 2014). Considering these tenets, significant weight is given to the stipulation itself to establish the accurate historical use of claims.

# CONCLUSIONS OF LAW

1. The Stipulation resolves the issue remarks, Objections, Counterobjections, and Notice of Intent to Appear concerns for the claims in Cases 43A-0011-R-2020, 43A-0015-R-2020, 43A-0081-R-2020, 43A-0082-R-2020, 43A-0118-R-2020, 43A-0395-R-2021, and 43A-0400-R-400-2025.

- 2. The parties' request that information regarding the Jordan-Arthun Reservoir be standardized and remarks be added concerning historical water use and water management be documented so that the water rights associated with the Reservoir can be administered correctly is reasonable.
- 3. The May 21, 2021 withdrawal of claim 43A 190929-00 should be accepted; the January 29, 2021 withdrawal of claim 43A 192122-00 should be accepted; and the February 2, 2021 withdrawal of claim 43A 213209-00 should be accepted.
- 4. The modifications requested by the parties during proceedings in these Cases address substantive issue remarks decreed on the claims. Some claims were also decreed with notice-only remarks that have served their notice purpose and do not raise legal or factual issues for the Court to resolve. The issue remarks should be removed.
- 5. The issue remark decreed on claims 43A 213209-00 and 43A 213372-00 indicating the "maximum combined acres for this group of supplemental claims may require modification..." is not relevant because supplemental rights remarks on claims no longer include a quantified acreage figure.
- 6. The Findings of Fact are supported by a preponderance of the evidence and the claims should be modified accordingly.

# RECOMMENDATIONS

- 1. Claim 43A 190929-00 should be dismissed, as it has been withdrawn by Claimant Arthun Ranch, Inc. Claims 43A 192122-00, and 43A 213209-00 should be dismissed as they have been withdrawn by 4 Diamond Ranch at Wallrock, LLC.
- 2. The claims should be modified as contemplated in the Findings of Fact and as shown on the attached abstracts.
  - 3. The issue remarks should be removed.
