NOTICE OF FILING OF MASTER'S REPORT

This Master's Report was filed with the Montana Water Court on the above stamped date. Please review this report carefully.

You may file a written objection to this Master's Report within **10 days** of the stamped date if you disagree or find errors with the Master's findings of fact, conclusion of law, or recommendations. MASTER'S REPORT

Sunlight Ranch Co. and the United States, DOI Bureau of Indian Affairs each objected to claims 43O 30145545, 43O 30145546, 43O 30145547, 43O 30145548, and 43O 30145549. Some of these claims appeared in the Interlocutory Decree with issue remarks which must be addressed and resolved. On April 28, 2025 the parties filed a Stipulation addressing the objections and the issue remarks. The Stipulation is viewable in the Court's FullCourt Enterprise case management system, document number 6.

APPLICABLE LAW

"All issue remarks to claims that are not resolved through the filing of an objection as provided in 85-2-233 must be resolved as provided in this section." Section 85-2-248(2), MCA.

A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content pursuant to section 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect including for claimants objecting to their own claims. Rule 19, W.R.Adj.R.

THE CLAIMED VOLUME EXCEEDS THE 9.0 ACRE-FEET GUIDELINE FOR THIS PURPOSE. ITS ACCURACY CANNOT BE CONFIRMED DUE TO LACK OF DATA.

The first remark provides notice that the claim was not included in the Preliminary Decree. As John J. Hanft now appears as an owner of this claim, the second remark is moot. Both remarks should be removed.

The Interlocutory Decree states that the volume is 10.50 AC-FT. The volume should be 9.00 AC-FT. The issue remark should be removed as addressed and resolved.

The Interlocutory Decree states that the range for the point of diversion legal description and the place of use legal description is 33E. The range for both should be 35E.

CONCLUSION OF LAW

The settlement filed by the parties is sufficient to contradict and overcome the prima facie claims and to resolve the issue remarks without evidentiary hearing. Sections 85-2-248(3) and (11), MCA.

RECOMMENDATIONS

Based upon the above Findings of Fact and Conclusion of Law, this Master recommends that the Court make the changes specified in the Findings of Fact to correct the Preliminary Decree for this Basin. A Post Decree Abstract of Water Right Claim for each claim is served with this Report to confirm the recommended changes have been made in the state's centralized record system.
