NOTICE OF FILING OF MASTER'S REPORT

This Master's Report was filed with the Montana Water Court on the above-stamped date.

Please review this report carefully.

You have **13 days** from the service date of the notice of filing of this report to file a written objection or request an extension of the objection period. Rule 23, Water Right Adjudication Rules; Rule 6, Montana Rules of Civil Procedure. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

The State of Montana Board of Land Commissioners ["Trust Lands"] objected to each of these Buggy Creek Livestock LLLP claims. These claims appeared in the Interlocutory Decree with issue and/or notice remarks. On September 22, 2025 Buggy Creek Livestock LLLP filed a

Statement And Unopposed Motion To Amend Statements Of Claim To Resolve Issue Remarks (“Unopposed Motion”). As all the requested changes are to elements already at issue by objection or issue remark, this is not a motion to amend filed pursuant to section 85-2-233(6), MCA. On September 22, 2025 Trust Lands filed a Sworn Statement Of Non-Interest for all but one of the points of diversion and places of use on claim 400 30136579. These documents are viewable in the Court’s FullCourt Enterprise case management system.

APPLICABLE LAW

“All issue remarks to claims that are not resolved through the filing of an objection as provided in 85-2-233 must be resolved as provided in this section.” Section 85-2-248(2), MCA.

“‘Implied Claim’ means a claim authorized by the water court to be separated and individually identified when a statement of claim includes multiple rights.” Rule 2(a)(33), W.R.C.E.R.

From 41P-108 “Circle S Ranch, Inc.” Order On Motion To Modify Claims 5-16-19, at 2019 Mont. Water LEXIS 8, *15:

The Water Court recognizes implied claims in certain circumstances *In re Musselshell River below Roundup*, Case 40C-47, 1994 Mont. Water LEXIS 18, *78 (July 14, 1994). However, before the Court will recognize an implied claim, the claimant must prove that several factors exist. These include: (1) proof of two or more water rights in the original claim form or the material submitted with the claim form; (2) proof of historic use corroborating the implied claim; and (3) proof that recognizing the implied claim(s) will avoid causing a change to historic water use or increase the historic burden to other water users. *In re Foss*, Case 76HF-580, 2013 Mont. Water LEXIS 17, *32 (Jan. 31, 2013); *In re Martinell*, Case 41A-148, 2018 Mont. Water LEXIS 3, *6 (June 14, 2018). These standards assure that implied claims are not used to revive a claim that was forfeited as a matter of law by missing the filing deadline. Mont. Code Ann. § 85-2-226 (establishing conclusive presumption of abandonment of for claims not timely filed); *In re Climbing Arrow Ranch*, Case 41F-A19, 2019 Mont. Water LEXIS 1 (Mar. 6, 2019). The implied claim process also cannot be used to expand the elements of a statement of claim. *In re Eliasson Ranch Company*, Order Amending and Adopting Master’s Report, Case 40A-115, 2004 Mont. Water LEXIS 2, *6 (Jun. 28, 2004) (“*Eliasson*”).

A properly filed Statement of Claim for Existing Water Right is *prima facie* proof of its content pursuant to section 85-2-222, MCA. This *prima facie* proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the

elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect including for claimants objecting to their own claims. Rule 19, W.R.Adj.R.

FINDINGS OF FACT

1. Statement of Claim 400 30136579 and its attachments include both portions of the claimed right owned by Buggy Creek Livestock LLLP and owned by Trust Lands.
2. Claim 400 30136579 should be used for the Buggy Creek Livestock LLLP portion of the claimed right. Implied claim 400 30172462 should be used for the Trust Lands portion of the claimed right.
3. Claim 400 30136579 appeared in the Interlocutory Decree with the following remarks:

THE WATER RIGHTS LISTED FOLLOWING THIS STATEMENT APPEAR TO BE REDUNDANT FILINGS. IT APPEARS ONLY ONE WATER RIGHT IS INVOLVED. 400 30136579, 400 30136580.

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 400 DECREE ISSUED 05/24/1995.

THE WATER RIGHTS LISTED FOLLOWING THIS STATEMENT WERE FILED BY DIFFERENT PARTIES WHO CLAIM OVERLAPPING PLACES OF USE. 400 202157-00, 400 30136579.

THE OWNERSHIP OF THIS RIGHT MAY BE QUESTIONABLE. PART OF THE PLACE OF USE APPEARS TO BE ON STATE LAND.

THE PRIORITY DATE MAY BE QUESTIONABLE. ACCORDING TO INFORMATION IN THE CLAIM FILE, IT APPEARS WATER FROM THE SOURCE WAS FIRST USED IN 1915.

A PORTION OF THE CLAIMED POINT OF DIVERSION AND PLACE OF USE DOES NOT MEET THE DEFINITION OF AN EXEMPT RIGHT UNDER 85-2-222, MCA, AND INVOLVES AN ON-STREAM RESERVOIR.

The Interlocutory Decree states that the priority date is AUGUST 28, 1935. The priority date should be AUGUST 28, 1915. The priority date issue remark should be removed as addressed and resolved.

The Interlocutory Decree includes UNNAMED TRIBUTARY OF PORCUPINE CREEK as one of the sources. As the points of diversion and places of use on the Unnamed Tributary of Porcupine Creek are being removed, this source should be removed as well.

The Interlocutory Decree includes the following points of diversion and places of use:

These should be removed as requested in the Unopposed Motion. In addition, one of the duplicate places of use in section 27, T32N, R40E, VALLEY should be removed as unnecessary for the place of use. The issue remarks concerning redundant filings and ownership should be removed as addressed and resolved.

There is no reservoir included on this claimed right. The issue remark concerning a reservoir should be removed as irrelevant.

The second remark provides notice that this exempt claim was not in the 1995 Preliminary Decree. The third remark provides notice of possible issues to be pursued by objection or notice of intent to appear. They should be removed as having served their notice purposes.

4. The elements of implied claim 400 30172462 should be the same as 400 30136579, except the owner is the MONTANA STATE BOARD OF LAND COMMISSIONERS; the source is UNNAMED TRIBUTARY OF DRY FORK CREEK; and the point of diversion and place of use are both the SW section 16, T32N, R40E, VALLEY.

5. Claim 400 30136588 appeared in the Interlocutory Decree with the following remarks:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 400 DECREE ISSUED 05/24/1995.

THE OWNERSHIP OF THIS RIGHT MAY BE QUESTIONABLE. PART OF THE PLACE OF USE APPEARS TO BE ON STATE LAND.

THE OWNERSHIP OF THIS RIGHT MAY BE QUESTIONABLE. PART OR ALL OF THE PLACE OF USE APPEARS TO BE ON FEDERAL LAND.

The first remark provides notice that this exempt claim was not in the 1995 Preliminary Decree. It should be removed as having served its notice purpose.

The Interlocutory Decree states that the owner is BUGGY CREEK LIVESTOCK LLLP. The owner should be MONTANA STATE BOARD OF LAND COMMISSIONERS. The issue remark concerning state land should be removed as addressed and resolved.

Paragraph 1.c. of the Unopposed Motion states that none of the claimed points of diversion or places of use are on federal land. The issue remark concerning federal land should be removed as erroneous.

6. Claim 400 30136648 appeared in the Interlocutory Decree with the following remarks:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 400 DECREE ISSUED 05/24/1995.

THE WATER RIGHTS LISTED FOLLOWING THIS STATEMENT WERE FILED BY DIFFERENT PARTIES WHO CLAIM OVERLAPPING PLACES OF USE. 400 30106755, 400 30136648, 400 30137029, 400 30143250.

THE OWNERSHIP OF THIS RIGHT MAY BE QUESTIONABLE. PART OF THE PLACE OF USE APPEARS TO BE ON STATE LAND.

The first remark provides notice that this exempt claim was not in the 1995 Preliminary Decree. The second remark provides notice of possible issues to be pursued by objection or notice of intent to appear. They should be removed as having served their notice purposes.

The Interlocutory Decree states that the owner is BUGGY CREEK LIVESTOCK LLLP. The owner should MONTANA STATE BOARD OF LAND COMMISSIONERS. The issue remark concerning state land should be removed as addressed and resolved.

CONCLUSION OF LAW

Statement of Claim 400 30136579 and its attachments plus the documents filed by the parties are sufficient to generate an implied claim and resolve the issue remarks without evidentiary hearing. The Unopposed Motion is sufficient to resolve the issue remarks on claims 400 30136588 and 400 30136648 without evidentiary hearing. Section 85-2-248(3) and (11), MCA.

RECOMMENDATIONS

Based upon the above Findings of Fact and Conclusion of Law, this Master recommends that the Court generate implied claim 400 30172462 and make the changes specified in the Findings of Fact to correct the Interlocutory Decree for this Basin. A Post Decree Abstract of Water Right Claim for each claim is served with this Report to confirm the recommended changes have been made in the state's centralized record system.
