**NOTICE OF FILING OF MASTER'S REPORT**

This Master's Report was filed with the Montana Water Court on the above-stamped date.  
Please review this report carefully.

You have **13 days** from the service date of the notice of filing of this report to file a written objection or request an extension of the objection period. Rule 23, Water Right Adjudication Rules; Rule 6, Montana Rules of Civil Procedure. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

**MASTER'S REPORT**

The United States, DOI Bureau of Land Management ("BLM") either objected to or filed a notice of intent to appear for each of these claims. The claims appeared in the Interlocutory Decree with various notice remarks and issue remarks. On March 25, 2024 Montana State

Board of Land Commissioners – Forestry and Trust Lands Division [“Trust Lands”] filed a Sworn Statement Of Non-Interest concerning claim 400 30136086. On August 14, 2025 Cornwell Ranch’s Statement And Unopposed Motion To Amend Claims To Resolve Issue Remarks And Objections [“Unopposed Motion”] was filed. As all the requested changes are to elements already at issue by issue remark or objection, this is not a motion to amend filed pursuant to section 85-2-233(6), MCA. On August 27, 2025 the United States’ Notice Of Resolution Of Objections was filed. These documents are viewable in the Court’s FullCourt Enterprise case management system.

#### APPLICABLE LAW

“All issue remarks to claims that are not resolved through the filing of an objection as provided in 85-2-233 must be resolved as provided in this section.” Section 85-2-248(2), MCA.

A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content pursuant to section 85-2-222, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect, including for claimants objecting to their own claims. Rule 19, W.R.Adj.R.

The third remark concerning ownership should be removed as addressed and resolved.

#### CONCLUSION OF LAW

The documents filed by the parties are sufficient to contradict and overcome the prima facie claims and to resolve the issue remarks without evidentiary hearing. Section 85-2-248(3) and (11), MCA.

#### RECOMMENDATIONS

Based upon the above Findings of Fact and Conclusion of Law, this Master recommends that the Court make the changes specified in the Findings of Fact to correct the Interlocutory Decree for this Basin. A Post Decree Abstract of Water Right Claim for each claim is served with this Report to confirm the recommended changes have been made in the state's centralized record system.
