NOTICE OF FILING OF MASTER'S REPORT

This Master's Report was filed with the Montana Water Court on the above-stamped date. Please review this report carefully.

You have **13 days** from the service date of the notice of filing of this report to file a written objection or request an extension of the objection period. Rule 23, Water Right Adjudication Rules; Rule 6, Montana Rules of Civil Procedure. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

Kevin L. Kovanda objected to each of these claims. On October 30, 2025 the claimant filed his Response To Resolve Objections. The Response is viewable in the Court's FullCourt Enterprise case management system.

APPLICABLE LAW

A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content pursuant to section 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect including for claimants objecting to their own claims. Rule 19, W.R.Adj.R.

FINDINGS OF FACT

1. For claim 43QJ 191535-00, the Second Preliminary Decree states that the flow rate is 0.78 GPM. The flow rate should be 2.00 GPM.
2. There are no changes to be made to the elements of claim 43QJ 191537-00.
3. For claim 43QJ 191538-00, the Second Preliminary Decree states that the flow rate is 1.50 GPM. The flow rate should be 10.00 GPM.
4. For claim 43QJ 191540-00, the Second Preliminary Decree states that the flow rate is 0.84 GPM. The flow rate should be 2.00 GPM.
5. For claim 43QJ 191541-00, the Second Preliminary Decree states that the priority date is JUNE 28, 1973. The priority date should be FEBRUARY 2, 1942.
6. For claim 43QJ 191557-00, the Second Preliminary Decree states that the flow rate is 1.62 GPM. The flow rate should be 7.00 GPM.
7. For claim 43QJ 191561-00, the Second Preliminary Decree states that the flow rate is 2.00 GPM. The flow rate should be 7.00 GPM.
8. For claim 43QJ 191562-00, the Second Preliminary Decree states that the flow rate is 2.95 GPM. The flow rate should be 6.00 GPM.

The Second Preliminary Decrees states that the period of diversion and period of use are both JANUARY 1 TO MAY 1. Both should be JANUARY 1 TO DECEMBER 31.

9. For claim 43QJ 191563-00, the Second Preliminary Decree states that the flow rate is

0.22 GPM. The flow rate should be 5.00 GPM.

CONCLUSION OF LAW

The settlement filed by the claimant is sufficient to contradict and overcome the prima facie claims.

RECOMMENDATIONS

Based upon the above Findings of Fact and Conclusion of Law, this Master recommends that the Court make the changes specified in the Findings of Fact to correct the Second Preliminary Decree for this Basin. A Post Decree Abstract of Water Right Claim for each claim is served with this Report to confirm the recommended changes have been made in the state's centralized record system.
