**ORDER CONFIRMING GLACIER NATIONAL PARK  
WATER RIGHT ABSTRACTS  
FOR BASIN 40F AND BASIN 40T FINAL DECREES**

On July 28, 1994, the United States and the State of Montana filed a motion with the Water Court asking the Court to enter Preliminary and Final Decrees incorporating provisions of the United States Park Service – Montana Compact (“NPS Compact”). The NPS Compact settles claims of the United States Department of Interior, National Park Service (“NPS”) on various NPS units in Montana, including Glacier National Park. The NPS Compact, as ratified by the Montana Legislature, is codified at Section 85-20-401 *et seq.*, MCA.

On December 10, 1996, the Court issued Findings of Fact, Conclusions of Law, and Order for Commencement of Special Proceedings for Consideration of the NPS Compact. The Water Court opened case WC-0001-C-1994 (aka case WC-94-1) to address these proceedings as part of Montana’s statewide general stream adjudication.

On April 11, 2005, the Court issued Findings of Fact and Conclusions of Law Approving and Confirming the NPS Compact. (“Approval Order”). The Approval Order sets forth the background to the NPS Compact and the Court’s ruling.

As part of the process for finalizing the Compact, the Water Court issued an order on November 19, 2007 dismissing 198 water right claims. These claims consisted of a combination of statements of claim, reserved rights, provisional permits, and groundwater certificates that the parties to the Compact agreed should be dismissed.

On June 11, 2018, the Water Court issued an Order Granting Rule 54(b) Certification and Final Judgment (“Certification Order”) in this case. The Certification Order was issued following work between NPS and the Department of Natural Resources and Conservation (“DNRC”) to correct errors and legal discrepancies in abstracts that previously had been prepared. The Certification Order confirms the parties’ report to the Court that the abstracts were finalized. However, the abstracts were not included with the Certification Order. Instead, the Certification Order states the Water Court retains jurisdiction to facilitate the administrative process of inserting NPS Compact provisions in the State’s centralized water rights record system.

Under the provisions of Montana’s Water Use Act, the Water Court is charged with the responsibility to issue final decrees in each of Montana’s hydrologic basins. As part of that obligation, the Court must include the provisions of compacts in final decrees, including specific information about water rights arising under the laws of the United States addressed in compacts. Section 85-2-234, MCA.

The Water Court recently issued the Final Decree for Basin 40T, the St. Mary River Basin. The Court also expects to soon issue the Final Decree for Basin 40F, the Milk River Basin above Fresno Reservoir. Both basins include water rights appurtenant to the portions of Glacier National Park addressed in the NPS Compact.

As part of the process for completing the Basin 40T and 40F decrees, the Court consulted with DNRC and learned that two versions of the NPS Compact abstracts for Glacier National Park had been created in the State’s centralized water rights record system. At the request of the Court, DNRC investigated this issue and provided a list of the accurate versions of the abstracts, as confirmed by NPS. The water right claim numbers for these abstracts are specified on the following Table 1:

## **ORDER**

Therefore, it is ORDERED that each of the claims listed on Table 1 are CONFIRMED and APPROVED for purposes of inclusion in the final decrees for Basins 40T or 40F according to their basin designation. Final decree versions of the abstracts in on Table 1 shall be made part of the Basin 40T Final Decree and the Basin 40F Final Decree.

It is further ORDERED that each of the claims listed on Table 2 are DISMISSED. Post decree versions of the water right claims listed on Table 2 are included with this Order to confirm the modifications have been made in the State's centralized water rights record system.

This Order closes adjudication proceedings for each of these claims.

A copy of this Order shall be placed in the basin files for Basins 40T and 40F.
