MASTER'S REPORT

The above-captioned claims appeared in the Preliminary Decree for the Sun River (Basin 41K). The claims were consolidated into Case 41K-0164-R-2023 and the above-captioned claimants were ordered to work with the Department of Natural Resources and Conservation to resolve the issue remarks on the claims. On June 27, 2024, a Memorandum ("Memo") was filed (Doc. 15.00). Attached to the Memo were proposed abstracts as well as maps of the places of use. The Memo stated that the claimants had failed to contact the DNRC as required. On August 13, 2024, an Order Setting Filing Deadline was issued requiring the claimants to file documentation stating their position on the recommendations in the Memo. The Order stated that "[i]f nothing is filed, it will be viewed as agreement that the recommendations in the Memo should be adopted". Nothing was filed in response to the Order.

PRINCIPLES OF LAW

- 1. The Montana Water Court has the authority to determine the extent of all water rights in the state as they existed prior to July 1, 1973. *Fellows v. Saylor*, 2016 MT 45, ¶ 25, 382 Mont. 298, 367 P.3d 732; §§ 85-2-233, -102(13), MCA.
- 2. A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R.
- 3. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. §§ 85-2-227, -231(2), MCA.

CONCLUSION OF LAW

1. The claims should be modified as discussed above.

RECOMMENDATION

1. Upon review the record in this case, the claims should be modified as discussed above. The modifications to the claims resolve the issue remarks and the issue remarks should be removed.

EACH RIGHT IS LIMITED TO THE FLOW RATE AND PLACE OF USE OF THAT INDIVIDUAL RIGHT. THE SUM TOTAL VOLUME OF THESE WATER RIGHTS SHALL NOT EXCEED THE AMOUNT PUT TO HISTORICAL AND BENEFICIAL USE.
