(Doc. 13.00). Ms. Bluhm indicated that she spoke with Chance Evans on December 3, 2024.



6. 41S 134236-00: Ms. Bluhm explained she was able to locate the historical point of diversion based on information provided by Chance Evans and using the map in the claim file. Additionally, Ms. Bluhm reported that based on information available to her, she confirmed 79.00 acres of irrigation at the claimed place of use. Ms. Bluhm recommended modifications to claim 41S 134236-00. Upon comparing the recommendations for claims 41S 134235-00 and 41S 134236-00, the place of use legal land descriptions proposed by Ms. Bluhm differed, but the mapping was identical; it appeared Ms. Bluhm made clerical errors in the recommended place of use legal land description for claim 41S 134236-00, and it should be identical to the place of use legal land description for claim 41S 134235-00. Based on the record, it appeared the following modifications were appropriate for claim 41S 134236-00:

7. **41S 134237-00:** Ms. Bluhm confirmed the claimed acreage. Additionally, according to Ms. Bluhm, after investigation and speaking with Chance Evans, she found the correct point of diversion for claim 41S 134237-00, and she recommended the following modification:

- 8. **41S 134238-00:** Ms. Bluhm indicated that she confirmed the claimed acreage for claim 41S 134238-00.
- 9. **41S 134239-00:** Ms. Bluhm indicated that she confirmed the claimed acreage for claim 41S 134239-00.
- 10. **41S 134240-00:** Ms. Bluhm indicated that she confirmed the claimed acreage. Additionally, Ms. Bluhm confirmed the claimed point of diversion for claim 41S 134240-00.
- 11. An Order was issued to determine if Claimant Franzen agreed or disagreed with the recommendations made by Ms. Bluhm. (Doc. 4.00). The Order indicated that if nothing were filed by the deadline, this Water Master would conclude the Claimants agreed with the recommended modifications. The following language was included in the Order:

Failure to comply with the terms of this Order may result in sanctions, <u>up to and including entry of default and termination of a water right claim or dismissal of objections</u>. Rule 22, W.R.Adj.R.

12. Claimant Chance J. Evans filed a Response forwarding email communications between Mr. Evans and Ms. Bluhm and expressed appreciation for Ms. Bluhm's service. (Doc. 5.00).

Nothing was filed by other parties.

PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court must address all issue remarks decreed on a claim. Section 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 3. Pursuant to Rule 22, W.R.Adj.R., if a claimant, objector, or intervenor fails to appear at a scheduled conference or hearing or fails to comply with an order issued by the Water Court, the Water Court may issue such orders of sanction with regard thereto as are just.
- 4. The issue remarks decreed on claims 41S 134235-00, 41S 134236-00, 41S 134237-00, 41S 134239-00 and 41S 134240-00 indicating the "maximum combined acres for this group of supplemental claims may require modification..." is not relevant because supplemental rights remarks on claims no longer include a quantified acreage figure.

RECOMMENDATIONS

1. Claims 41S 134235-00, 41S 134236-00, and 41S 134237-00 should be modified as described in Findings of Facts 5 through 7. No modifications are being recommended to the elements of claims 41S 134238-00, 41S 134239-00, and 41S 134240-00.

2. The issue remarks should be removed from claims 41S 134235-00, 41S 134236-00, 41S 134237-00, 41S 134238-00, 41S 134239-00, and 41S 134240-00.
