MASTER'S REPORT

FINDINGS OF FACT

- 1. Butte LLP is the record owner of stock claim 39F 30139272.
- 2. Claim 39F 30139272 was decreed with DNRC issue remarks:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 39F DECREE ISSUED 05/23/2019.

THE OWNERSHIP OF THIS RIGHT MAY BE QUESTIONABLE. PART OR ALL OF THE PLACE OF USE APPEARS TO BE ON FEDERAL LAND.

The first issue remark is a notice-type remark, indicating the claim was not included in the 2019 decree Preliminary Decree; the remark does not require further attention. The second remark provides notice that an ownership update may be warranted. Ownership updates may be filed at any time; the remark does not require further attention.

3. Butte LLP objected to claim 39F 30139272, stating:

This claim includes additional points of diversion and places of use located in SWSWNE-27-5S-61E and SESENW-27-5S-61E.

Evidence supporting the historical use of the claim, as identified in the Objection was not included with the Objection, nor was a map, or proposed abstract.

4. On June 28, 2024, Butte LLP filed its Response to Order Setting Filing Deadline. (Doc. 12.00). The Response explained that at filing, errors were made for the point of diversion and place of use legal land description for this livestock direct from source claim. The errors placed portions of the claim on federal land and incorrect private land and omitted portions of the claim on Butte LLP land. Butte LLP attached a Motion to Amend, an Affidavit of Butte LLP manager, Jim McGinnis, a proposed abstract, and a map, to correct the errors. According to the record, the following modifications should be made to claim 39F 30139272, resolving the Objection:

PRINCIPLES AND CONCLUSIONS OF LAW

- 1. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 2. If a claimant agrees to reduce or limit a claim, the Water Court may accept the reduction or limitation without reviewing further evidence, unless an unresolved issue remark remains. Rule 17(c), W.R.Adj.R.
- 3. The notice-type issue remarks decreed on claim 39F 30139272 have served their purpose. As no objections were filed, no further proceedings are required.

RECOMMENDATIONS

1. Claim 39F 30139272 should be modified as shown in Finding of Fact No.

4.

2. The issue remarks should be removed from claim 39F 30139272.
