#### **MASTER'S REPORT**

#### FINDINGS OF FACT

- 1. River Bottom Ranch, LLC (River Bottom) is the record owner of stock claims 39F 30139126, 39F 30139147, 39F 30139286, and 39F 30139292.
- 2. Claims 39F 30139126, 39F 30139147, 39F 30139286, and 39F 30139292 were decreed with a DNRC issue remark indicating the claims were not included in the 2019 decree Preliminary Decree. The remark does not require further attention. Additionally, the following issue remarks were decreed on claims:

#### 39F 30139126:

THE OWNERSHIP OF THIS RIGHT MAY BE QUESTIONABLE. PART OF THE PLACE OF USE APPEARS TO BE ON USDI BUREAU OF LAND MANAGEMENT.

#### 39F 30139147:

THE OWNERSHIP OF THIS RIGHT MAY BE QUESTIONABLE. PART OR ALL OF THE PLACE OF USE APPEARS TO BE ON FEDERAL LAND. (BLM)

- 3. River Bottom objected to claims 39F 30139126, 39F 30139147, 39F 30139286, and 39F 30139292. Generally, the Objections indicate additional points of diversion and places of use for the claims should be added. Evidence supporting the historical use of the claims as identified in the Objections was not included with the Objections, nor were maps, or proposed abstracts.
- 4. A deadline was set for River Bottom to file additional information supporting the Objections to claims 39F 30139126, 39F 30139147, 39F 30139286, and 39F 30139292. The BLM was added to that Order to provide notice of its potential ownership interest in at least part of claims 39F 30139126 and 39F 30139147.
- 5. On June 28, 2024, River Bottom filed its Response to Order Setting Filing Deadline. (Doc. 12.00).
- 6. **Claim 39F 30139126:** The Response explained that claim 39F 30139126 was filed entirely on federal land. A Request to Withdraw Statement of Claim was attached to the Response.

7. Claim 39F 30139147: The Response explained that when filing claim 39F 30139147 errors were made in the point of diversion and place of use legal land descriptions, placing a portion of the claim on federal land resulting in the ownership issue remark. River Bottom requested the following point of diversion and place of use legal land description modification be made to claim 39F 30139147 resolving the ownership issue remark:

Claim 39F 30139286: The Response explained that when filing claim 39F 30139286 errors were made in the point of diversion and place of use legal land descriptions, omitting a portion of Mud Creek from the claim. River Bottom requested the following point of diversion and place of use legal land description modification be made to claim 39F 30139286:

9. Claim 39F 30139292: The Response explained that when filing claim 39F 30139292 errors were made in the point of diversion and place of use legal land descriptions, omitting a portion of Roburge Creek from the claim and included land the creek does not flow through. River Bottom requested the following point of diversion and place of use legal land description modifications be made to claim 39F 30139292:

10. On July 19, 2024, potential owner BLM filed a Response in River Bottom Ranch Filing stating:

The United States believes that the modifications proposed by River Bottom Ranch resolve any issues related to the United States' interests in this case. If other changes to these two claims are proposed by the Court or the parties prior to the issuance of a final order in this case, the United States reserves its right to participate further in these proceedings.

(Doc. 4.00).

#### PRINCIPLES AND CONCLUSIONS OF LAW

- 1. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 2. If a claimant agrees to reduce or limit a claim, the Water Court may accept the reduction or limitation without reviewing further evidence, unless an unresolved issue remark remains. Rule 17(c), W.R.Adj.R.
- 3. The issue remarks noting that claims 39F 30139126, 39F 30139147, 39F 30139286, and 39F 30139292 were not included in the 2019 decree have served their purpose. As the Objections have been resolved, no further proceedings are required.

#### RECOMMENDATIONS

- 1. Claim 39F 30139126 should be dismissed as it has been withdrawn by River Bottom Ranch, LLC.
- 2. Claims 39F 30139147, 39F 30139286, and 39F 30139292 should be modified as shown in the Findings of Fact.

Abstracts are attached for review.
