### MASTER'S REPORT

The above-captioned claims appeared in the Preliminary Decree for the Judith River (Basin 41S) with issue remarks. Peter Nisbet filed objections to claims 41S 139624-00, 41S 139625-00, 41S 139626-00, 41S 139627-00 and 41S 139629-00.

The claims were consolidated into Case 41S-0018-R-2024 on February 16, 2024 and the claimants were ordered to work with the Department of Natural Resources and Conservation ("DNRC") to resolve the issue remarks on the claims. On June 20, 2024, a Memorandum ("Memo") was filed (Doc.¹ 2.00). On September 17, 2024, this Master issued an Order Setting Filing Deadline ("Order"), detailing potential modifications relating to the objections as well as requiring the claimant to file documentation stating their position on the recommendations in the Memo and the potential modifications detailed in the Order. The Order stated that "[i]f nothing is filed, it will be viewed as agreement with the recommendations and modifications discussed above and a Master's Report will be issued". Nothing was filed in response to the Order.

## FINDINGS OF FACT

1. Claim 41S 139624-00 was decreed with the following issue remarks: FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.

## PRINCIPLES OF LAW

- 1. The Montana Water Court has the authority to determine the extent of all water rights in the state as they existed prior to July 1, 1973. *Fellows v. Saylor*, 2016 MT 45, ¶ 25, 382 Mont. 298, 367 P.3d 732; §§ 85-2-233, -102(13), MCA.
  - 2. A properly filed Statement of Claim for Existing Water Right is prima facie

proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R.

3. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. §§ 85-2-227, -231(2), MCA.

## **CONCLUSION OF LAW**

- 1. The DNRC recommendations and modifications discussed in the Order should be adopted.
- 2. Adoption of the recommendations and modifications discussed above resolves the issue remarks and objections to the claims.

## RECOMMENDATIONS

- 1. The claims should be modified as discussed above.
- 2. Modification of the claims resolves the issue remarks and objections. The remarks should be removed from the claims and the objections should be dismissed.
