- 2. The Brewingtons were ordered to meet with a DNRC employee to address the following unresolved issue remarks decreed on claims in this Case:


5. **Claim 41S 48874-00:** Based on available information, the Specialists recommended the following modifications to claim 41S 48874-00 to address the issue remarks:



6. Claim 41S 48875-00: The Specialists were unable to confirm the existence of the headgate described by point of diversion ID #2. The Specialists indicated that without assistance from the Claimants, the point of diversion issue remark decreed on claim 41S 48875-00 can't be resolved. Based on the information provided by the Specialists, together with the record, it appears the following modifications should be made to claim 41S 48875-00:



- 7. Claim 41S 48876-00: The Specialists were unable to confirm the existence of the dike described by claim 41S 48876-00. The Specialists explained a ditch is present and they identified irrigation at the claimed place of use in a 1962 aerial photograph. However, it is unclear if the 19.50 acres of irrigation identified by the Specialists is from the dike described by claim 41S 48876-00. Without additional information from the Brewingtons to identify the conveyance system, it appears claim 41S 48876-00 should be dismissed.
- 8. **Claim 41S 48877-00:** Based on available information, the Specialists recommended the following modifications to claim 41S 48877-00 to address the issue remarks:

- 9. **Claim 41S 132870-00:** The Specialists were able to identify the surface water reservoir described by claim 41S 132870-00 and they recommended the reservoir issue remark be removed from claim 41S 132870-00.
- 10. Claim 41S 132880-00: Based on available information, the Specialists recommended the following modifications to claim 41S 132880-00 to address the issue remarks:



- 11. **Claim 41S 132882-00:** The Specialists were unable to confirm irrigation using the resources available to them. The Specialists recommend dismissal of claim 41S 132882-00.
- 12. A deadline was set for the Brewingtons to agree or disagree that claims 41S 48873-00, 41S 48874-00, 41S 48875-00, 41S 4887-00, and 41S 132880-00 be modified as described in this Order to address the unresolved issue remarks and that claims 41S 48876-00 and 41S 132882-00 be dismissed.

13. On May 29, 2024, the Brewingtons responded and agreed with the changes proposed for claims 41S 48873-00, 41S 48874-00, 41S 48875-00, 41S 4887-00, and 41S 132880-00 and the proposed dismissal of claims 41S 48876-00 and 41S 132882-00. (Doc. 4.00).

PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court must address all issue remarks decreed on a claim. Section 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 3. In addition to the issue remarks already discussed, claims 41S 48873-00, 41S 132870-00, and 41S 132880-00 were decreed with notice-type issue remarks. As no Objections were filed, no further proceedings are needed.

RECOMMENDATIONS

- 1. Claim 41S 48873-00 should be modified as described in Finding of Fact No. 4; claim 41S 48874-00 should be modified as described in Finding of Fact No. 5; claim 41S 48875-00 should be modified as shown in Finding of Fact No. 6, claim 41S 4887-00 should be modified as shown in Finding of Fact No. 8; and claim 41S 132880-00 should be modified as shown in Finding of Fact No. 10.
 - 2. Claims 41S 48876-00 and 41S 132882-00 should be dismissed.
