# **MASTER'S REPORT**

# FINDINGS OF FACT

- 1. Clark A. Brevig and Charles A. Brevig are the record co-owners of claims 41S 5005-00, 41S 5006-00, 41S 139607-00, and 41S 139608-00.
- 2. In December 1984, after the objection period closed for the Basin 41S Temporary Preliminary Decree, Joan K. Brevig filed late objections to claims 41S 500500, 41S 5006-00, 41S 139607-00, and 41S 139608-00 indicating the following:

The foregoing objections pertaining to priority dates, places of use, acres irrigated, sources, and points of diversion are primarily due to the division of the Brevigs irrigation water rights in Big Spring Creek into four separate water rights.

The Brevigs' water right in Spring Creek arises from a valid appropriation of 400 miners' inches from the creek by their predecessor in interest on July 16, 1893. The Brevigs contend that their irrigation water right should be decreed under a single water right with a priority date of July 16, 1893. The irrigated acres of each separate water right should be combined to total 149.2 acres, and the place of use for the right should be extended to the total 149.2 acres.

Also, the Brevigs have only one point of diversion on Spring Creek, which consists of a headgate located at NW\nE\nE\nE\n\, Section 28, Township 16 North, Range 17 East, County Fergus. Consequently, the point of diversion under the single water right should be so designated.

The Brevigs have also objected to the volume or flow rate of their irrigation water rights. The Brevigs contend that the flow rate for the combined irrigated water right should be set at 10 CFS, and the volume set at 1620 acre feet per year. The Brevigs will establish upon hearing that this is the amount of water put to beneficial use by their prior appropriation.

Because the objections were late, an issue remark was added to the claims ensuring the Objections could be addressed during the Preliminary Decree in Basin 41S. The Preliminary Decree was issued on August 18, 2022.

- 3. Claims 41S 5005-00, 41S 5006-00, 41S 139607-00, and 41S 139608-00 were decreed with the following DNRC issue remark:
  - ON 12/18/1984 JOAN K. BREVIG FILED AN OBJECTION TO THE PRIORITY DATE, PLACE OF USE, ACRES IRRIGATED, SOURCE, POINT OF DIVERSION, VOLUME, AND FLOW RATE. THIS IS A LATE OBJECTION AND CANNOT BE HEARD UNTIL AFTER PROPER NOTICE ON THE NEXT OBJECTION LIST.

Claim 41S 139607-00 was also decreed with the following DNRC issue remarks:

- FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.
- THE FERGUS COUNTY WATER RESOURCES SURVEY ( 1970 ) APPEARS TO INDICATE 0.00 ACRES IRRIGATED.
- USDA AERIAL PHOTOGRAPH NO(S). 30027-278-18, DATED 09/25/1979, APPEARS TO INDICATE 12.70 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.
- THE MAXIMUM COMBINED ACRES FOR THIS GROUP OF SUPPLEMENTAL CLAIMS MAY REQUIRE MODIFICATION PENDING RESOLUTION OF MAXIMUM IRRIGATED ACRES ISSUE.

And claim 41S 139608-00 was also decreed with the following DNRC issue remarks:

- FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.
- THE FERGUS COUNTY WATER RESOURCES SURVEY ( 1970 ) APPEARS TO INDICATE 0.00 ACRES IRRIGATED.
- USDA AERIAL PHOTOGRAPH NO(S). 30027-278-18 , DATED 09/25/1979 , APPEARS TO INDICATE 9.00 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.
- SOURCE NAME WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.
- THE MAXIMUM COMBINED ACRES FOR THIS GROUP OF SUPPLEMENTAL CLAIMS MAY REQUIRE MODIFICATION PENDING RESOLUTION OF MAXIMUM IRRIGATED ACRES ISSUE.
- 4. An Order was issued to determine if Joan K. Brevig would pursue the late Objections and Ordering Claimants Clark A. Brevig and Charles A. Brevig to meet with the DNRC to address unresolved issue remarks. (Doc. 13.00).
- 5. On July 22, 2024, Clark A. Brevig filed a statement indicating he intends to assume and pursue the late objections filed by Joan K. Brevig. (2.00).
- 6. On July 23, 2024, an Order was issued setting two sets of deadlines. First, an August 18, 2024 deadline was set for Clark A. Brevig to indicate how the late Objections filed in this Case should be resolved. Second, Claimants Clark A. Brevig and Charles A. Brevig were ordered to contact the DNRC to address the unresolved issue remarks decreed on claims 41S 139607-00 and 41S 139608-00. (Doc. 3.00).

- 7. On August 8, 2024, Gail Brevig filed a Statement and attached the Affidavits of Clark A. Brevig and herself, along with a Statement from Clark A. Brevig. (Doc. 4.00). It appeared the August 8, 2024 filing was a proposal to resolve the late Objections that Clark A. Brevig assumed. However, the proposal was not entirely clear. It appeared Clark A. Brevig proposed changing the point of diversion for claims 41S 5005-00, 41S 139607-00, and 41S 139608-00, matching claim 41S 5006-00. Additionally, it appeared Clark A. Brevig proposed changing the source for claims 41S 5005-00, 41S 139607-00, and 41S 139608-00 to Big Spring Creek, also matching claim 41S 5006-00.
- 8. On August 16, 2024, DNRC Water Resources Specialist Carli Bluhm filed a Memorandum indicating she reviewed claims 41S 139607-00 and 41S 139608-00 and she recommended the issue remarks be removed without changing the elements of the claims. (Doc. 5.00).
- 9. On August 20, 2024, another deadline was set for Clark A. Brevig to indicate how the Objections to claims 41S 5005-00, 41S 5006-00, 41S 139607-00, and 41S 139608-00 should be resolved. (Doc. 6.00).
- 10. On November 20, 2024, Clark A. Brevig responded to the August 20, 2024 deadline by filing a statement indicating the following:
  - Clark A. Brevig does not wish to pursue the 1984 late Objection to claims 41S 5005-00 and 41S 139607-00.
  - Clark A. Brevig proposes the maximum acres and place of use be increased for claim 41S 5006-00, reflecting the reflect 143.30 acres and the guideline flow rate.
  - Clark A. Brevig proposes the place of use legal land description be modified.

(Doc. 9.00). A technical letter from consultant Scott Irvin of Big Sky Water Rights, LLC was attached to the Response, along with maps and proposed abstracts.

11. An Order was issued to verify Claimant Charles A. Brevig agreed with the modifications proposed by Clark A. Brevig and that the modifications proposed by Clark A. Brevig resolved his Objections. (Doc. 10.00). The Order indicated that if nothing were filed by the deadline, this Water Master would conclude Charles A. Brevig agreed with the November 20, 2024 filing and that the November 20, 2024 filing resolved Clark A. Brevig's Objections. Nothing was filed by the deadline.


- 12. **Claim 41S 5005-00:** Pursuant to the record, no modifications are needed to the elements of the claim.
- 13. Claim 41S 5006-00: Consultant Irvin reported that he conducted a site inspection on October 4, 2024; additionally, he reviewed water right files, aerial imagery, the Fergus County Water Resources Survey, and consulted with Clark and Gail Brevig regarding historical water use and site conditions. Mr. Irvin stated:

However, the acreage noted on the Statement of Claim form is not accurate. It appears the accounting of acres on the claim form understated the irrigated area.

. .

Based on the combination of data sources and your explanation of irrigation practices, I find 143.3 acres (ArcGIS Pro calculation) to be historically irrigated under 41S 5006.

Mr. Irvin recommended adjusting the flow rate to the DNRC's 17.00 gallon per minute flow rate guideline and changing the volume from a quantified volume to the standardized remark for direct flow claims. Based on the record, the following modifications should be made to claim 41S 5006-00:



- 14. **Claim 41S 139607-00:** Pursuant to the record, no modifications are needed to the elements of the claim and the issue remarks can be removed according to Ms. Bluhm.
- 15. Claim 41S 139608-00: The place of use for claim 41S 139608-00 was originally claimed in the NESE of Section 20, Township 16 North, Range 17 East, Fergus County. A DNRC data entry error entered the place of use for claim 41S 139608-00 in the

**NW**SE of Section 20. Pursuant to the record, the place of use for claim 41S 139608-00 should be:


According to Ms. Bluhm, the issue remarks can be removed from claim 41S 139608-00.

# PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court must address all issue remarks that appear on a claim as well as any objections the claim receives. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 3. Pursuant to Rule 22, W.R.Adj.R., if a claimant, objector, or intervenor fails to appear at a scheduled conference or hearing or fails to comply with an order issued by the Water Court, the Water Court may issue such orders of sanction with regard thereto as are just.
- 4. The issue remarks decreed on claims 41S 1439607-00 and 41S 1439608-00 indicating the "maximum combined acres for this group of supplemental claims may require modification..." is not relevant because supplemental rights remarks on claims no longer include a quantified acreage figure. The remark can be removed from both claims.
- 5. The source name issue remark decreed on claim 41S 139608-00 is a notice-type issue remark. As the only objection has been resolved, no further proceedings are required.
