MASTER'S REPORT

The United States of America (Bureau of Land Management) objected to this claim. On December 9, 2024 the claimant filed a Motion To Amend Claim 42C 30137104. This is a settlement document rather than a motion to amend filed pursuant to section 85-2-233(6),

MCA. On December 13, 2024 the United States' Notice Of Resolution Of Objections was filed. These settlement documents are viewable in the Court's FullCourt Enterprise case management system.

APPLICABLE LAW

A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content pursuant to section 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect including for claimants objecting to their own claims. Rule 19, W.R.Adj.R.

FINDINGS OF FACT

1. The Interlocutory Decree includes multiple entries for the point of diversion and place of use. One of the entries is section 28, T1N, R44E, ROSEBUD. This entry for the entire section should be removed and the following should be added to the point of diversion and place of use:

2. This claim appeared in the Interlocutory Decree for this Basin with the following remark:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 41E DECREE ISSUED 02/28/2008. This remark provides notice that the claim was not included in the Preliminary Decree. The remark does not raise an unresolved issue which needs to be addressed. There are no proceedings required for this remark. The remark should be removed as having served its notice purpose.

CONCLUSION OF LAW

The settlement filed by the parties is sufficient to contradict and overcome the prima facie claim.

RECOMMENDATIONS

Based upon the above Findings of Fact and Conclusion of Law, this Master recommends that the Court make the changes specified in the Findings of Fact to correct the Interlocutory Decree for this Basin. A Post Decree Abstract of Water Right Claim is served with this Report to confirm the recommended changes have been made in the state's centralized record system.
