MASTER'S REPORT

FINDINGS OF FACT

1. Claim 76N 216212-00 appeared in the Basin 76N Preliminary Decree issued November 14, 2024. It received an objection from the United States Forest Service.

2. Claim 76N 216212-00 received a DNRC issue remark stating: THE PRIORITY DATE IS MISSING.

The Court is required by statute to address and resolve all DNRC issue remarks appearing on claims.

3. A status conference was held on October 9, 2024, to discuss the issues related to claim 76N 216212-00. The claimants Valerie Borgmann and Walter Borgmann did not appear. A filing deadline was set for the Borgmanns to respond to the United States' Objection and to address the issue remark appearing on the claim. Nothing was filed by the deadline.

4. On December 6, 2024, the Court issued a Show Cause Order setting a final deadline for the claimants to provide evidence that claim 76N 216212-00 was put to use prior to July 1, 1973. The Order explained that if water was not put to use prior to July 1, 1973, it is not considered an existing water right and would need to be dismissed from the adjudication. Nothing was filed by the deadline. Claim 76N 216212-00 should be dismissed from the adjudication.

CONCLUSIONS OF LAW

1. A properly filed claim of an existing right or an amended claim of existing right is prima facie proof of its content. § 85-2-227, MCA. However, only water uses put to use prior to July 1, 1973 are considered existing water rights. § 85-2-102(13), MCA.

2. All issue remarks to claims that are not resolved through the filing of an objection must be resolved pursuant to § 85-2-248, MCA. § 85-2-248(2), MCA. Priority Date is an essential element of a water right. § 85-2-234(7)(d), MCA. There is no evidence before the Court to show that claim 76N 216212-00 was put to use prior to July 1, 1973.

3. If a claimant fails to comply with an order issued by the water court, the water court, upon motion, or its own initiative, may issue such orders of sanction with regard thereto as are just. Sanctions applied against claimants may include termination of the claim; or modification of the claim to conform with data provided by the department, information obtained by the court, or information included in an objection. Rule 22, W.R.Adj.R. The Claimants failed to attend to a scheduled status conference, did not respond to an initial filing deadline, and failed to respond to a show cause order. There is no evidence to support that claim 76N 216212-00 was put to use prior to July 1, 1973. The claim should be dismissed from the adjudication.

RECOMMENDATIONS

1. Claim 76N 216212-00 should be dismissed from the adjudication.

A Post Decree Abstract of Water Right Claim is served with the Report to confirm that the claim has been dismissed.
