MASTER'S REPORT

Bull Mountain Grazing Company stock claim <u>41G</u> 30128692 appeared in the Preliminary Decree with the following remark:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 41E DECREE ISSUED 06/20/1985.

Basin 41G is the Jefferson River. This claim is not an interbasin transfer between the two Basins, so this remark and the inclusion of this claim in the 41E Boulder River Preliminary Decree made no sense. To determine if this claim was erroneously classified as 41G rather than 41E, this Case was consolidated and a scheduling conference was held to discuss the claim with the claimant.

On April 14, 2025 the claimant filed its Motion To Resolve Issues With Water Right 41G 30128692 ["Motion"]. This Motion is viewable in the Court's FullCourt Enterprise case management system.

APPLICABLE LAW

A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content pursuant to section 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect including for claimants objecting to their own claims. Rule 19, W.R.Adj.R.

FINDINGS OF FACT

- 1. The Preliminary Decree states that the source is SPRING, GROUNDWATER. The Motion confirms that the spring is a tributary to the Jefferson River, so 41G is the correct Basin code for this claim. In addition, the source name is clearly erroneous and should be corrected as stated in the Motion. The source name should be SPRING, UNNAMED TRIBUTARY OF JEFFERSON RIVER, and the following clarification remark should be added: ALSO KNOWN AS TRAIL SPRING.
- 2. This claim was not included in the Basin 41G Preliminary Decree issued on February 15, 2018. It will be included in the future Basin 41G Interlocutory Decree. The remark should be modified so it references the Basin 41G Decree rather than the Basin 41E Decree:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 41G DECREE ISSUED 02/15/2018.

CONCLUSION OF LAW

The information provided by the claimant is sufficient to resolve the issue raised by the remark without evidentiary hearing. Sections 85-2-248(3) and (11), MCA.

RECOMMENDATIONS

Based upon the above Findings of Fact and Conclusion of Law, this Master recommends that the Court make the changes specified in the Findings of Fact to correct the Preliminary Decree for this Basin. A Post Decree Abstract of Water Right Claim is served with this Report to confirm the recommended changes have been made in the state's centralized record system.
