# **MASTER'S REPORT**

The above-captioned claims appeared in the Preliminary Decree for the Missouri River above Holter Dam (Basin 41I) issued on June 24, 2022. The following claims are owned by Montana Environmental Trust Group LLC. The claims received issue remarks. Issue remarks are notations identifying potential legal or factual issues with water rights and the Water Court is required to resolve these potential issues.

# FINDINGS OF FACT

# 41I 46238-00

1. Claim 41I 46238-00 was decreed as a flood irrigation claim from Prickly Pear Creek. The claim was decreed with the following place of use:



- 5. Claim 41I 46238-00 also received the following priority date issue remark: THE PRIORITY DATE MAY BE QUESTIONABLE. THIS CLAIM IS FOR A DECREED ON PRICKLY PEAR CREEK WITH A PRIORITY DATE 06/26/1984 CASE NO. 00964. LEWIS AND CLARK COUNTY.
- 6. There is no evidence before the Court that the claimed priority date is

historically inaccurate.

# 41I 89105-00 and 41I 89106-00

7. Claim 41I 89105-00 was decreed as a domestic claim for a single home and two acres of irrigation that diverts groundwater via a well. Claim 41I 89106-00 was

decreed as a stock claim from the same well. Both claims received the following issue

remark:

THE PRIORITY DATE IS IN QUESTION. THE SUBMITTED FORM GW2, NOTICE OF COMPLETION OF GROUNDWATER APPROPRIATION, WAS NOT FILED AT THE COURTHOUSE AS REQUIRED BY THE 1961 GROUNDWATER CODE.

# 8. The claims also received the following issue remarks:

9. 41I 35461-00 is a groundwater certificate with a priority date of August 20,

1981. The well logs and invoices from Lindsay Drilling in both files are identical. 411 35461-00 represents the following uses: Domestic (1.5 acre-feet, includes a presumed 0.2

acres of irrigation) and Stock (2.25 acre-feet, includes 150 cattle and horses). Together, claims 411 89105-00 and 411 89106-00 duplicate groundwater certificate 411 35461-00.

 Claimant filed their *Response Relating to Issue Remarks*. (Doc.<sup>1</sup> 5.00).
Claimant's *Response* states that they will withdraw Groundwater Certificate 41I 35461-00.

11. The *Response* also states that Claimant was unable to locate a GW2 form filed during the applicable time period. (Doc. 5.00). Therefore, Claimant requests that the priority date of each claim be modified to the date the statements of claim were filed, April 30, 1982, and the type of right be modified to "filed". *Id*.

# 41I 89109-00, 41I 89110-00, 41I 89117-00, and 41I 89118-00

12. Claims 41I 89109-00, 41I 89110-00, 41I 89117-00, and 41I 89118-00 were decreed as supplemental claims for flood irrigation claims of 188.00 acres as follows:



16. Claim 89110-00 also received the following issue remark:

CAUSE NO. 15537, LEWIS & CLARK CO., PROVIDES TESTIMONY THAT INDIVIDUALS WITH DECREED RIGHTS FROM CASE NO.4643 LEWIS & CLARK CO., HAVE HISTORICALLY USED THE HIGH, FLOOD AND SURPLUS WATERS OF PRICKLY PEAR CREEK IN ADDITION TO THIER DECREED RIGHTS.

17. This issue remark was added during adjudication of the Basin 411

Temporary Preliminary Decree, however it should have been added as an information remark not an issue remark:

3. The following clarification remark should be added to

the abstracts of flood right claims 41I-W-089109-00 and

41I-W-089110-00:

CAUSE NO. 15537, LEWIS & CLARK CO., PROVIDES TESTIMONY THAT INDIVIDUALS WITH DECREED RIGHTS FROM CASE NO. 4643, LEWIS & CLARK CO., HAVE HISTORICALLY USED THE HIGH, FLOOD AND SURPLUS WATERS OF PRICKLY PEAR CREEK IN ADDITION TO THEIR DECREED RIGHTS.

18. Finally, the claims 41I 89109-00 and 41I 89110-00 also received the

following notice-type issue remark:

THE TIMELY FILED OBJECTION OF UNITED STATES OF AMERICA WAS AMENDED BY AGREEMENT TO INCLUDE PRIORITY DATE BECAUSE THESE ELEMENTS WERE NOT INCLUDED ON THE OBJECTION LIST, ANY WATER USER WHOSE RIGHTS MAY BE ADVERSELY AFFECTED BY ENFORCEMENT OF THESE CHANGES MAY PETITION THE APPROPRIATE COURT FOR RELIEF OR MAY FILE AN OBJECTION AT THE PRELIMINARY DECREE.

19. The claims did not receive objections, and the remark served its notice

purpose.

# PRINCIPLES OF LAW

1. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA; Rule 10, W.R.Adj.R.

2. Prima facie proof may be contradicted and overcome by a preponderance of the evidence. Rule 19, W.R.Adj.R.

3. A preponderance of the evidence is evidence that shows a fact is "more probable than not." *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 438, 240 P.3d 628.

4. If prima facie status is overcome, the burden shifts back to the claimant to demonstrate historical use. *79 Ranch v. Pitsch*, 204 Mont. 426, 432-33, 666 P.2d 215, 218 (1983).

5. Section 85-2-248(2), MCA, requires that the Water Court resolve all issue remarks that are not resolved through the objection process. *See also* Rule 7, W.R.Adj.R.

6. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. Sections 85-2-227, -231(2), MCA.

7. When resolving issue remarks, the Water Court must weigh the information resulting in the issue remark and the issue remark against the claimed water right. Section 85-2-247(2), MCA. The factual evidence on which an issue remark is based must meet the preponderance of evidence standard before the prima facie status of a claim is overcome. 43Q 200996-00 et al., Order Establishing Volume and Order Closing Case, at 18, June 8, 2015.

8. If a claimant agrees to reduce or limit a claim, the Water Court may accept the reduction or limitation without reviewing further evidence, unless an unresolved issue remark remains. Rule 17(c), W.R.Adj.R.

# CONCLUSIONS OF LAW

# 41I 46238-00

1. The issue remarks overcome the prima facie status of claim 41I 46238-00. The evidence submitted with the amendment shows the historical place of use is 138.00 acres as described above. This is a reduction to the claimed elements and resolves the issue remarks.

2. The priority date issue remark does not overcome the prima facie status of claim 411 46238-00. There is no evidence supporting the issue remark.

# 41I 89105-00 and 41I 89106-00

3. The priority date issue remark overcomes the prima facie status of claims 411 89105-00 and 411 89106-00. Claimant's request to reduce the priority date to match the filing date of the statement of claim resolves the issue remark and is a reduction to the claimed element. Groundwater Certificate 411 35461-00 should be withdrawn as soon as possible if it has not already been withdrawn.

# 41I 89109-00, 41I 89110-00, 41I 89117-00, and 41I 89118-00

4. The issue remarks overcome the prima facie status of claims 41I 89109-00, 41I 89110-00, 41I 89117-00, and 41I 89118-00. The evidence submitted with the amendments shows the historical place of use for all four claims is 80.00 acres as described above. This is a reduction to the claimed elements and resolves the issue remarks.

5. The priority date issue remark that appeared on claim 411 89110-00 is an information remark that was accidentally coded as an issue remark.

6. The notice-type issue remark on claims 411 89109-00 and 411 89110-00 served its notice purpose.

# **RECOMMENDATIONS**
