
MASTER'S REPORT

On December 12, 2024, Roger Erickson filed a request to correct the section number of the point of diversion for claim 41P 178131-00.

FINDINGS OF FACT

1. Claim 41P 178131-00 is a multiple domestic claim that diverts water from Aldrich Spring.

- 2. The statement of claim originally claimed the point of diversion in the NWNENW of Section <u>26</u>, T27N, R4W, Teton County.
- 3. During their initial review of the claim, the DNRC modified the point of diversion to the NWNENW of Section 2, T27N, R4W:



- 4. All other water rights that divert water from Aldrich Spring claim one point of diversion the NWNENW of Section 26, T27N, R4W, Teton County.
- 5. The DNRC originally modified the claimed point of diversion to the SWNENW of Section 2, T27N, R4W. The DNRC then corrected its modification to reflect the point of diversion as originally claimed. Although the quarter sections were corrected, the section number was mistakenly left as 2 instead of 26.

PRINCIPLE AND CONCLUSION OF LAW

- 1. The Court may correct a clerical mistake found in a judgment, order, or other part of the record on motion or on its own, with or without notice. Rule 60(a), M.R.Civ.P.
- 2. The DNRC made a clerical mistake when it failed to restore the originally claimed section number for the point of diversion.

RECOMMENDATION

1. The point of diversion for claim 41P 178131-00 should be corrected to the NWNENW of Section **26**, T27N, R4W, Teton County.

A post decree abstract of the water right claim reflecting this recommendation is attached to this Report.
