FINDINGS OF FACT

- 1. Buffalo Creek Grain, LLC, Daniel J. Horan, Leo J. Horan, Julie Walton, Sam Walton, Kristine U. Wichman, and Thomas J. Wichman (the Claimants) are the record owners of claims 41S 132885-00, 41S 132886-00, 41S 132887-00, 41S 132889-00.
- 2. Claims 41S 132885-00, 41S 132886-00, 41S 132887-00, 41S 132888-00, and 41S 132889-000 were decreed with DNRC issue remarks:

41S 132885-00:

- FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.

- THE CLAIMANT DID NOT IDENTIFY THE PERIOD OF DIVERSION FOR THIS RIGHT. A PERIOD OF DIVERSION HAS BEEN ADDED TO MATCH THE PERIOD OF USE. IF NO OBJECTIONS ARE RECEIVED TO THE PERIOD OF DIVERSION OR PERIOD OF USE, THOSE ELEMENTS WILL BE DECREED AS SHOWN ON THIS ABSTRACT AND THIS ISSUE REMARK WILL BE REMOVED FROM THIS CLAIM.
- RESERVOIR RECORD WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA
 WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS
 CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND
 THE REMARK WILL BE REMOVED FROM THE CLAIM.
- THE MAXIMUM COMBINED ACRES FOR THIS GROUP OF SUPPLEMENTAL CLAIMS MAY REQUIRE MODIFICATION PENDING RESOLUTION OF MAXIMUM IRRIGATED ACRES ISSUE.
- 3. The Claimants were ordered to meet with a DNRC employee to address the unresolved issue remarks. (Doc. 11.00).
- 4. DNRC Water Resources Specialist Carli Bluhm filed a Memorandum on January 28, 2025. (Doc. 3.00). Ms. Bluhm reported that she met with Leo Horan on January 8, 2025. Ms. Bluhm stated she reviewed the Judith County Water Resource Survey field notes, and aerial photos to prepare the Memorandum.

Although the issue remarks on the claims varied slightly, the issues Ms. Bluhm was asked to address were similar – all the claims described the same reservoir and the same place of use. Consequently, the recommendations Ms. Bluhm made were identical for each of the claims.

Volume:

Ms. Bluhm indicated the following regarding claims 41S 132885-00, 41S 132886-00, 41S 132887-00, 41S 132888-00, and 41S 132889-00:

The DNRC estimated the holding capacity of the reservoir to be 53.14 AC-FT. Following the DNRC's 2.5 fills per year per guideline, the DNRC estimated the volume to be 132.85 AC-FT.

5. Orders were issued to determine if the Claimants agreed or disagreed with the recommendations made by Ms. Bluhm. (Docs. 4.00 and 5.00). The Orders indicated that if nothing were filed by the February 28, 2025 deadline, this Water Master would conclude the Claimants agreed with the recommended modifications. The following language was included in the Order:

Failure to comply with the terms of this Order may result in sanctions, <u>up to and including entry of default and termination of a water right claim or dismissal of objections</u>. Rule 22, W.R.Adj.R.

Nothing was filed.

PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court must address all issue remarks decreed on a claim. Section 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.

- 3. The period of diversion and reservoir record issue remarks decreed on the claims in this Case are notice-type issue remarks. As no objections were filed, no further proceedings are required.
- 4. The issue remarks decreed on claims 41S 132885-00, 41S 132886-00, 41S 132887-00, 41S 132888-00, and 41S 132889-00 indicating the "maximum combined acres for this group of supplemental claims may require modification..." is not relevant because supplemental rights remarks on claims no longer include a quantified acreage figure.

RECOMMENDATIONS

- 1. The volume for claims 41S 132885-00, 41S 132886-00, 41S 132887-00, 41S 132888-00, and 41S 132889-00 should be modified to 132.85 acre-feet.
- 2. The maximum acres and place of use for claims 41S 132885-00, 41S 132886-00, 41S 132887-00, 41S 132888-00, and 41S 132889-00 should be modified to:
