MASTER'S REPORT

FINDINGS OF FACT

1. Claims 41S 105519-00, 41S 105520-00, 41S 105533-00, 41S 115261-00, 41S 115263-00, 41S 119072-00, 41S 119073-00, 41S 119074-00, 41S 119075-00, 41S 119076-00, 41S 119077-00, 41S 119080-00, 41S 119081-00, and 41S 119082-00 are owned by variations of the following claimants: Donald F. Jenni, Nancy L. Jenni, Scott W. Jenni, Thaddeus F. Jenni, Gary D. Jenni, Kathryn K. Jenni, Jamie L. Longtine, and Ray M. Longtine (hereinafter “claimants”).

2. Claims 41S 105519-00, 41S 105520-00, 41S 105533-00, 41S 115261-00, 41S 115263-00, 41S 119072-00, 41S 119073-00, 41S 119074-00, 41S 119075-00, 41S 119076-00, 41S 119077-00, 41S 119080-00, 41S 119081-00, and 41S 119082-00 were decreed with remarks placed on the claims by the Montana Department of Natural Resources (DNRC) noting potential factual or legal issues (“issue remarks”). All issue remarks must be addressed.

3. Crowley Ditch Co. filed a Notice of Intent to Appear (“NOIA”) as to claim 41S 105520-00. The Notice of Intent to Appear was withdrawn on May 2, 2025. (Doc.¹5.00).

4. The Claimants were ordered to meet with a DNRC employee to address the unresolved issue remarks. (Doc.1.00).

5. DNRC Water Resources Specialist Brandon Ahlgren filed a Memorandum on March 26, 2025. (Doc. 3.00). Mr. Ahlgren reported that Claimant Gary Jenni contacted him and discussed the Case. Mr. Ahlgren stated he reviewed the Fergus County Water Resource Survey and aerial photos to prepare the Memorandum.

6. **Claims 41S 105519-00 and 41S 105520-00** (Claimants Donald F. Jenni, Nancy L. Jenni, Scott W. Jenni, and Thaddeus F. Jenni; Notice of Intent to Appear Party – claim 41S 105520-00, Crowley Ditch Co.): Claims 41S 105519-00 and 41S 105520-00 were decreed with the following issue remarks:

Mr. Ahlgren explained that he identified 111.86 acres of irrigation in a 1975 aerial photograph for claims 41S 105519-00 and 41S 105520-00. The proposed abstracts Mr. Ahlgren attached to the Memorandum for claims 41S 105519-00 and 41S 105520-00 varied slightly – he did not include legal land description modifications for claim 41S 105520-00 – but it seems that was oversight. Based upon available information, it appears Mr. Ahlgren recommended the following modifications to claims 41S 105519-00 and 41S 105520-00 to address the issue remarks:

7. **Claim 41S 105533-00** (Claimants Donald F. Jenni, Scott W. Jenni, and Thaddeus F. Jenni):

Claim 41S 105533-00 was decreed with an issue remark:

THE TYPE OF HISTORICAL RIGHT AND PRIORITY DATE MAY BE QUESTIONABLE. DOCUMENTATION TO SUPPORT THE TYPE OF HISTORICAL RIGHT AND PRIORITY DATE WAS NOT SUBMITTED WITH THIS CLAIM.

A filed Declaration of Vested Groundwater Rights form was attached to the Statement of Claim for claim 41S 105533-00. The form indicated the priority date for claim 41S 105533-00 was “about 1884.” Mr. Ahlgren recommended the priority date for claim 41S 105533-00 be modified to December 31, 1884 and the issue remark be removed.

8. **Claim 41S 115261-00** (Claimants Gary D. Jenni and Kathryn K. Jenni): Claim 41S 115261-00 was decreed with the following issue remarks:

Mr. Ahlgren identified the 68.00 acres of historical irrigation at the claimed place of use for claim 41S 115261-00, and recommended the following modifications be made, addressing the issue remarks:

9. **Claim 41S 115263-00** (Claimants Gary D. Jenni, Kathryn K. Jenni, Jamie Longtine, and Ray M. Longtine): Claim 41S 115263-00 was decreed with the following issue remarks:

FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.
THE POINT OF DIVERSION MAY BE INCORRECT. THE LOCATION OF THE HEADGATE CANNOT BE IDENTIFIED FROM AVAILABLE DATA.
THE FERGUS COUNTY WATER RESOURCES SURVEY (1970) APPEARS TO INDICATE 0.00 ACRES IRRIGATED
USDA AERIAL PHOTOGRAPH NO(S). 30027-278-16 , DATED 09/25/1979 , APPEARS TO INDICATE 0.00 ACRES IRRIGATED.

Mr. Ahlgren did not identify any historical irrigation at the claimed place of use and he recommended claim 41S 115263-00 be dismissed.

10. **Claim 41S 119072-00** (Claimants Gary D. Jenni and Kathryn K. Jenni): Claim 41S 119072-00 was decreed with an issue remark:

THIS CLAIM AND WATER RIGHT NO. 41S 39172-00 APPEAR TO BE DUPLICATE FILINGS. IT APPEARS ONLY ONE WATER RIGHT IS INVOLVED.

Regarding claim 41S 119072-00, Mr. Ahlgren explained:

This claim appears to duplicate Groundwater Certificate (GWC) 41S 39172-00 which was filed by Floyd Jenni on December 16, 1981. On both the claim form and GWC form, the date of first use is written as "Sept. 1970". Statements of Claim that include a groundwater development with first use between 1962 and 1973, must adhere to the 1961 Groundwater Code. The claim would need a Groundwater (GW) Form associated with it, in accordance with the 1961 Groundwater Code, to keep the claimed September 1970 priority date. Without this GW Form, the priority date would be made the date of filing. The DNRC could not find and the claimant did not supply a GW Form for this development. The DNRC will recommend the claim be dismissed. The reason for dismissal is that the groundwater development already has a water right in the form of the GWC with a priority date of December 16, 1981, and without a GW form, the priority date on this claim would be changed to February 19, 1982, a more inferior priority date to the GWC.

Mr. Ahlgren recommended claim 41S 119072-00 be dismissed because it duplicates groundwater certificate 41S 39172-00.

11. **Claim 41S 119073-00** (Claimants Gary D. Jenni and Kathryn K. Jenni): Claim 41S 119073-00 was decreed with an issue remark:

THIS CLAIM AND WATER RIGHT NO. 41S 39171-00 APPEAR TO BE DUPLICATE FILINGS. IT APPEARS ONLY ONE WATER RIGHT IS INVOLVED.

Regarding claim 41S 119073-00, Mr. Ahlgren explained:

This claim appears to duplicate Groundwater Certificate (GWC) 41S 39171-00 which was filed by Floyd Jenni on December 16, 1981. On both the claim form and GWC form, the date of first use is written as "Aug 30, 1968". Statements of Claim that include a groundwater development with first use between 1962 and 1973 must adhere to the 1961 Groundwater Code. This claim would need a Groundwater (GW) Form associated with it, in accordance with the 1961 Groundwater Code, to keep the claimed August 30, 1968, priority date. Without this GW Form, the priority date would be made the date of filing. The DNRC could not find, and the claimant did not supply a GW Form for this development. The DNRC will recommend the claim be dismissed. The reason for dismissal is that the groundwater development already has a water right in the form of the GWC with a priority date of December 16, 1981, and without a GW form, the priority date on this claim would be changed to February 18, 1982, a more inferior priority date to the GWC.

Mr. Ahlgren recommended claim 41S 119073-00 be dismissed because it duplicates groundwater certificate 41S 39171-00.

12. **Claim 41S 119074-00** (Claimants Gary D. Jenni and Kathryn K. Jenni): Claim 41S 119074-00 was decreed with an issue remark:

THIS CLAIM AND WATER RIGHT NO. 41S 39169-00 APPEAR TO BE DUPLICATE FILINGS. IT APPEARS ONLY ONE WATER RIGHT IS INVOLVED.

Regarding claim 41S 119074-00, Mr. Ahlgren explained:

This claim appears to duplicate Groundwater Certificate (GWC) 41S 39169-00 which was filed by Floyd Jenni on December 16, 1981. The GWC form has no information on date of first use. The claim form listed "Oct 1, 1973" and DNRC edited to "Spring of 1973". Statements of Claim that include a groundwater development with first use between 1962 and 1973 must adhere to the 1961 Groundwater Code. This claim would need a Groundwater (GW) Form associated with it, in accordance with the 1961 Groundwater Code, to keep the claimed 1973 priority date. Without this GW Form, the priority date would be made the date of filing. The DNRC could not find, and the claimant did not supply a GW Form for this development. The DNRC will recommend the claim be dismissed. The reason for dismissal is that the groundwater development already has a water right in the form of the GWC with a priority date of December 16, 1981, and without a GW form, the priority date on this claim would be changed to February 18, 1982, a more inferior priority date to the GWC.

Mr. Ahlgren recommended claim 41S 119074-00 be dismissed because it duplicates groundwater certificate 41S 39169-00.

13. **Claim 41S 119075-00** (Claimants Gary D. Jenni and Kathryn K. Jenni): Claim 41S 119075-00 was decreed with an issue remark:

THIS CLAIM AND WATER RIGHT NO. 41S 39170-00 APPEAR TO BE DUPLICATE FILINGS. IT APPEARS ONLY ONE WATER RIGHT IS INVOLVED.

Regarding claim 41S 119075-00, Mr. Ahlgren explained:

This claim appears to duplicate Groundwater Certificate (GWC) 41S 39170-00 which was filed by Floyd Jenni on December 16, 1981. On both the claim form and GWC form, the date of first use is written as "Oct. 1, 1972". Statements of Claim that include a groundwater development with first use between 1962 and 1973 must adhere to the 1961 Groundwater Code. This claim would need a Groundwater (GW) Form associated with it, in accordance with the 1961 Groundwater Code, to keep the claimed October 1, 1972, priority date. Without this GW Form, the priority date would be made the date of filing. The DNRC could not find, and the claimant did not supply a GW Form for this development. The DNRC will recommend the claim be dismissed. The reason for dismissal is that the groundwater development already has a water right in the form of the GWC with a priority date of December 16, 1981, and without a GW form, the priority date on this claim would be changed to February 18, 1982, a more inferior priority date to the GWC.

Mr. Ahlgren recommended claim 41S 199075-00 be dismissed because it duplicates groundwater certificate 41S 39170-00.

14. **Claim 41S 119076-00** (Claimants Gary D. Jenni and Kathryn K. Jenni): Claim 41S 119076-00 was decreed with an issue remark:

THIS CLAIM AND WATER RIGHT NO. 41S 39173-00 APPEAR TO BE DUPLICATE FILINGS. IT APPEARS ONLY ONE WATER RIGHT IS INVOLVED.

Regarding claim 41S 119076-00, Mr. Ahlgren explained:

This claim appears to duplicate Groundwater Certificate (GWC) 41S 39173-00 which was filed by Floyd Jenni on December 16, 1981. On both the claim form and GWC form, the date of first use is written as "Sept. 30, 1971". Statements of Claim that include a groundwater development with first use between 1962 and 1973 must adhere to the 1961 Groundwater Code. This claim would need a Groundwater (GW) Form associated with it, in accordance with the 1961 Groundwater Code, to keep the claimed September 30, 1971, priority date. Without this GW Form, the priority date would be made the date of filing. The DNRC could not find, and the claimant did not supply a GW Form for this development. The DNRC will recommend the claim be dismissed. The reason for dismissal is that the groundwater development already has a water right in the form of the GWC with a priority date of December 16, 1981, and without a GW form, the priority date on this claim would be changed to February 18, 1982, a more inferior priority date to the GWC.

Mr. Ahlgren recommended claim 41S 199076-00 be dismissed because it duplicates groundwater certificate 41S 39173-00.

15. **Claim 41S 119077-00** (Claimants Gary D. Jenni and Kathryn K. Jenni): Claim 41S 119077-00 was decreed with an issue remark:

THIS CLAIM AND WATER RIGHT NO. 41S 39174-00 APPEAR TO BE DUPLICATE FILINGS. IT APPEARS ONLY ONE WATER RIGHT IS INVOLVED.

Regarding claim 41S 119077-00, Mr. Ahlgren explained:

This claim appears to duplicate Groundwater Certificate (GWC) 41S 39174-00 which was filed by Floyd Jenni on December 16, 1981. On both the claim form and GWC form, the date of first use is written as "Oct. 1965". Statements of Claim that include a groundwater development with first use between 1962 and 1973 must adhere to the 1961 Groundwater Code. This claim would need a Groundwater (GW) Form associated with it, in accordance with the 1961 Groundwater Code, to keep the claimed October 1965 priority date. Without this GW Form, the priority date would be made the date of filing. The DNRC could not find, and the claimant did not supply a GW Form for this development. The DNRC will recommend the claim be dismissed. The reason for dismissal is that the groundwater development already has a water right in the form of the GWC with a priority date of December 16, 1981, and without a GW form, the priority date on this claim would be changed to February 18, 1982, a more inferior priority date to the GWC.

Mr. Ahlgren recommended claim 41S 199077-00 be dismissed because it duplicates groundwater certificate 41S 39174-00.

16. **Claim 41S 119080-00** (Claimants Gary D. Jenni and Kathryn K. Jenni): Claim 41S 119080-00 was decreed with the following issue remarks:

THE MAXIMUM NUMBER OF ACRES CLAIMED ON THE ORIGINAL STATEMENT OF CLAIM IS 300.00 ACRES.
THE DNRC'S RE-EXAMINATION WAS OF THESE ORIGINAL CLAIMED ACRES.
THE FLOW RATE IS MISSING.
THE CLAIMED POINT OF DIVERSION IS IN QUESTION. THE LOCATION OF THE HEADGATE CANNOT BE IDENTIFIED FROM AVAILABLE DATA.
THE FERGUS COUNTY WATER RESOURCES SURVEY (1970) APPEARS TO INDICATE 0.00 ACRES IRRIGATED.
USDA AERIAL PHOTOGRAPH NO(S). 30027-278-16 , DATED 09/25/1979 , APPEARS TO INDICATE 119.70 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.

Mr. Ahlgren referenced Water Court modifications to claim 41S 119080-00 making it a subirrigation claim (an Order in 1983 and an "authorization" in 2001). The record showed no Water Court modifications to the elements of claim 41S 119080-00. However, documentation in the claim indicated the DNRC received authorization to modify the claim to subirrigation in 1983:

*From water master, John Chaffin, authorizes
a change to sub-irrigation O.K. DA 9-7-83*

and

*NOTE:
Water Masters J. Chaffin + S. Arnett authorized
changing this right to subirrigation. See GENERAL
REMARKS on verification abstracts.*

Mr. Ahlgren recommended claim 41S 119080-00 be further modified based on information available to him, reflecting natural subirrigation:

Flow Rate: FF004 NO FLOW RATE HAS BEEN DECREED FOR THIS USE OF NATURAL SUBIRRIGATION.

17. **Claim 41S 119081-00** (Claimants Gary D. Jenni, Kathryn K. Jenni, Jamie Longtine, and Ray M. Longtine): Claim 41S 119081-00 was decreed with DNRC issue remarks:

FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.

THE FERGUS COUNTY WATER RESOURCES SURVEY (1970) APPEARS TO INDICATE 101.00 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.

USDA AERIAL PHOTOGRAPH NO(S). 30027-278-16 , DATED 09/25/1979 , APPEARS TO INDICATE 98.50 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.

Mr. Ahlgren identified 101.00 acres of historical irrigation and recommended the following modifications to claim 41S 119081-00, addressing the issue remarks:

18. **Claim 41S 119082-00** (Claimants Donald F. Jenni, Nancy L. Jenni): Claim 41S 119082-00 was decreed with issue remarks:

FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.

THE FERGUS COUNTY WATER RESOURCES SURVEY (1970) APPEARS TO INDICATE 101.00 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.

USDA AERIAL PHOTOGRAPH NO(S). 30027-278-16 , DATED 09/25/1979 , APPEARS TO INDICATE 98.50 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.

Mr. Ahlgren did not identify historical irrigation at the claimed place of use for claim 41S 119082-00, and he recommended the claim be dismissed.

19. An Order was issued to determine if Claimants Donald F. Jenni, Nancy L. Jenni, Scott W. Jenni, Thaddeus F. Jenni, Gary D. Jenni, Kathryn K. Jenni, Jamie L. Longtine, and Ray M. Longtine agreed or disagreed with the recommendations made by Mr. Ahlgren; the Order also set a deadline for Crowley Ditch Co. to indicate whether its NOIA concerns are resolved. (Doc. 4.00). The Order indicated that if nothing were filed by the deadline, this Water Master would conclude the Claimants agreed with the recommended modifications. The following language was included in the Order:

Failure to comply with the terms of this Order may result in sanctions, up to and including entry of default and termination of a water right claim or dismissal of objections. Rule 22, W.R.Adj.R.

Nothing was filed by the Claimants and Crowley Ditch Co. withdrew its NOIA on May 2, 2025.

PRINCIPLES AND CONCLUSIONS OF LAW

1. The Water Court is required to resolve the issues raised by each issue remark. Section 85-2-248, MCA.

2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.

3. Pursuant to Rule 22, W.R.Adj.R., if a claimant, objector, or intervenor fails to appear at a scheduled conference or hearing or fails to comply with an order issued by the Water Court, the Water Court may issue such orders of sanction with regard thereto as are just.

4. The issue remarks decreed on claims 41S 105519-00 and 41S 105520-00 indicating the “maximum combined acres for this group of supplemental claims may

require modification...” is not relevant because supplemental rights remarks on claims no longer include a quantified acreage figure.

RECOMMENDATIONS
