CLOSING ORDER

The Water Court included water rights claims 43BV 30137222, 43BV 30137291, 43BV 30137314, 43BV 30137315, 43BV 30137317, and 43BV 30137724 in the Preliminary Decree for the Sweet Grass Basin (43BV) issued on May 25, 2021. Each claim describes a right to use water from an unnamed spring that is a tributary of Sweet Grass Creek for stock water use. The claims were filed as "exempt" rights under the provisions of House Bill 110 ("HB 110") passed by the 2017 Montana Legislature (codified at § 85-2-222, MCA). HB 110 authorized owners of certain exempt claims the option of filing the claims prior to a June 30, 2019 filing deadline.

The Department of Natural Resources and Conservation ("DNRC") examined the claims pursuant to its claim examination rules. Based on the DNRC examination, the following issue remark was included on the preliminary decree abstract for each claim:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43BV DECREE ISSUED 12/19/1984.

Greg H. Langford and Vickie L. Langford, through their counsel, Christopher T. Scoones, filed objections to all elements of the claims with an emphasis on priority dates.

On August 3, 2023, the Court consolidated the claims into this case to address the issue remark and the Langford objections. At the time of consolidation, JC Cattle Inc. ("JC Cattle") owned each of the claims.

Various proceedings have occurred in this case, but ultimately the parties reached a stipulation ("Stipulation"). The Stipulation proposes to resolve the Langford objections by modifying the priority dates so they reflect land patent dates. Each of the modified priority dates is junior to the dates claimed. Counsel for both parties represented to the Court that the Stipulation is accepted by their clients and they also filed signature pages.

Since the date the parties filed the Stipulation, the ownership of claims 43BV 30137222, 43BV 30137291, 43BV 30137314, and 43BV 30137315 evidently has been conveyed to Hannah Cremer and Justin Cremer. However, the Stipulation provides it is binding on successors and assigns. As the Stipulation provides for more junior priority dates, the limited evidence provisions of W.R.Adj.R. Rule 17(c) apply and nothing further is required to accept the terms of the Stipulation.

As for the issue remark, the remark gives notice that the claims did not appear in the temporary preliminary decree ("TPD") for Basin 43BV, which the Water Court issued in 1985, because the TPD predated the exempt claim filing deadline. The claims did not receive any objections other than the Langford's during the preliminary decree objection or counterobjection periods. Absent any objection, the remarks on the claims do not raise any factual or legal issues that need to be addressed. No further proceedings are required to resolve the remark and the remark will be removed from the abstract of each claim in this case.

ORDER

Therefore, it is ORDERED that (1) the Stipulation is APPROVED; (2) claims 43BV 30137222, 43BV 30137291, 43BV 30137314, 43BV 30137315, 43BV 30137317, and 43BV 30137724 are modified to reflect the more junior priority dates set forth in the

Stipulation with the issue remarks removed; (3) The Langford objections are DISMISSED as resolved; and (4) this case is CLOSED.

Post-decree abstracts of the claims are included with this Order to confirm the modifications have been made in the State's centralized water rights record system. A copy of this Order is provided to Hannah Cremer and Justin Cremer as successor owners of claims 43BV 30137222, 43BV 30137291, 43BV 30137314, and 43BV 30137315.
