MASTER'S REPORT

FINDINGS OF FACT

- 1. Ward & Parker Ranch, LLC (Ward & Parker) is the record owner of claim 43BV 138985-00.
 - 2. Claim 43BV 138985-00 was decreed with DNRC issue remarks:

THE CLAIMED FLOW RATE EXCEEDS THE 17 GPM PER ACRE GUIDELINE AND CANNOT BE CONFIRMED DUE TO LACK OF DATA. THE FLOW RATE EQUALS 48.00 GPM PER ACRE.

THE CLAIMED PRIORITY DATE MAY BE QUESTIONABLE. THE PRIORITY DATE ON THE SUBMITTED DECREE IS 11/16/1931.

All issue remarks must be addressed.

- 3. The United States of America (USDA Forest Service) objected to claim 43BV 138985-00.
- 4. John R. Cosgriff, of Ward & Parker Ranch, LLC, filed a statement on a Counterobjection form:

The statement appears to be a response to the Forest Service Objection, not a Counterobjection.

5. Documents settling the Objection in Case 43BV-0358-R-2024 were filed on April 10, 2025. (Doc. 17.00). The *Stipulation to Resolve Objections* indicates the Forest Service's Objection to claim 43BV 138985-00 will be resolved if the following modification is made to the point of diversion legal land description:

6. The *Stipulation to Resolve Objections* did not address the issue remarks decreed on claim 43BV 138985-00.

As claim 43BV 138985-00 is a decreed claim, the flow rate issue remark does not require further attention – it will be removed from the claim.

7. Nothing was filed addressing the priority date issue remark. Information in the claim suggested the priority date for claim 43BV 138985-00 should be November 16, 1931:

An Order was issued setting a deadline for Ward & Parker to agree or disagree that the priority date for claim 43BV 138985-00 should be modified from April 20, 1930 to November 16, 1931, resolving the priority date issue remark. (Doc. 8.00). On April 30, 2025, John R. Cosgriff filed a Statement on behalf of Ward & Parker indicating agreement with the proposed November 16, 1931 priority date for claim 43BV 138985-00. (Doc. 9.00).

PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court must address all issue remarks that appear on a claim as well as any objections the claim receives. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right

claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.

The information in the record is sufficient to overcome the prima facie status of the claim as to the priority date and point of diversion of claim 43BV 138956-00. Claim 43BV 138956-00 should be modified to correct the priority date and point of diversion as discussed in the Findings of Facts.

RECOMMENDATIONS

1. The point of diversion for claim 43BV 138985-00 should be modified, resolving the Forest Service Objection:

- 2. The priority date for claim 43BV 138985-00 should be modified from April 20, 1930 to November 16, 1931.

 - 4. John R. Cosgriff's Counterobjection should be dismissed.
