Rule 23, Water Right Adjudication Rules; Rule 6, Montana Rules of Civil Procedure. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

These Antelope Ranch Inc. claims appeared in the Interlocutory with various issue and/or notice remarks. The United States of America, DOI Bureau of Land Management filed a notice of intent to appear for each of these claims. On September 18, 2025 Antelope Ranch Inc.'s Statement And Unopposed Motion To Amend Claims To Resolve Issue Remarks And Objections ["Unopposed Motion"] was filed. As all the requested changes are to elements already at issue by issue remark or objection, this is not a motion to amend filed pursuant to

section 85-2-233(6), MCA. On September 30, 2025 the United States' Notice Of Resolution Of Notice Of Intent To Appear Concerns was filed. These documents are viewable in the Court's FullCourt Enterprise case management system.

APPLICABLE LAW

"All issue remarks to claims that are not resolved through the filing of an objection as provided in 85-2-233 must be resolved as provided in this section." Section 85-2-248(2), MCA.

A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content pursuant to section 85-2-222, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect including for claimants objecting to their own claims. Rule 19, W.R.Adj.R.

FINDINGS OF FACT

1. Claim 40O 30134601 appeared in the Interlocutory Decree with the following remarks:

THE OWNERSHIP OF THIS RIGHT MAY BE QUESTIONABLE. PART OR ALL OF THE PLACE OF USE APPEARS TO BE ON FEDERAL LAND.

A PORTION OF THE CLAIMED POINT OF DIVERSION AND PLACE OF USE DOES NOT MEET THE DEFINITION OF AN EXEMPT RIGHT UNDER 85-2-222, MCA, AND INVOLVES AN ON-STREAM RESERVOIR.

THIS CLAIM DOES NOT APPEAR TO MEET THE DEFINITION OF AN EXEMPT RIGHT UNDER SECTION 85-2-222(1), MCA.

The first remark provides notice that this exempt claim was not in the 1995 Preliminary Decree.

The second remark provides notice of possible issues to be pursued by objection or notice of intent to appear. These remarks should be removed as having served their notice purposes.

As requested in the Unopposed Motion, the following remark should be added to the place of use:

The third remark concerning ownership should be removed as addressed and resolved.

There is no reservoir included on this claimed right. The fourth and fifth remarks concerning a reservoir and the exempt nature of this claim should be removed as irrelevant.

2. Claim 40O 30134602 appeared in the Interlocutory Decree with the following remarks:

ALL OR A PART OF THE PLACE OF USE CONSISTS OF FEDERAL PUBLIC LANDS. THE WATER RIGHT USED ON THE PUBLIC LANDS IS APPURTENANT TO THE FOLLOWING PRIVATE LANDS: S2SE SECTION 22, TOWNSHIP 29N, RANGE 38E.

The third remark concerning ownership should be removed as addressed and resolved.

3. Claims 400 30134609 and 400 30134610 each appeared in the Interlocutory Decree with the following remarks:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 400 DECREE ISSUED 05/24/1995.

THE OWNERSHIP OF THIS RIGHT MAY BE QUESTIONABLE. PART OR ALL OF THE PLACE OF USE APPEARS TO BE ON FEDERAL LAND.

The first remark provides notice that this exempt claim was not in the 1995 Preliminary Decree. It should be removed as having served its notice purpose.

As requested in the Unopposed Motion, the following remark should be added to the place of use:

ALL OR A PART OF THE PLACE OF USE CONSISTS OF FEDERAL PUBLIC LANDS. THE WATER RIGHT USED ON THE PUBLIC LANDS IS APPURTENANT TO THE FOLLOWING PRIVATE LANDS: S2SE SECTION 22, TOWNSHIP 29N, RANGE 38E.

The second remark concerning ownership should be removed as addressed and resolved.

CONCLUSION OF LAW

The settlement filed by the parties is sufficient to contradict and overcome the prima facie claims and to resolve the issue remarks without evidentiary hearing. Section 85-2-248(3), (11), MCA.

RECOMMENDATIONS

Based upon the above Findings of Fact and Conclusion of Law, this Master recommends that the Court make the changes specified in the Findings of Fact to correct the Interlocutory Decree for this Basin. A Post Decree Abstract of Water Right Claim for each claim is served with this Report to confirm the recommended changes have been made in the state's centralized record system.
