MASTER'S REPORT

FINDINGS OF FACT

- 1. The record owners of domestic claim 41S 100175-00 and stock claim 41S 100181-00 are Leon E. Olson and Virginia A. Olson ("the Claimants").
- 2. Claims 41S 100175-00 and 41S 100181-00 are multiple uses of the same historical right. Both claims were decreed with the following DNRC issue remark:

THE TYPE OF HISTORICAL RIGHT, PRIORITY DATE, AND FLOW RATE MAY BE QUESTIONABLE. THE CLAIMS FOLLOWING THIS STATEMENT USE THE SAME FILED APPROPRIATION TO DOCUMENT THE RIGHT. THE COMBINED FLOW RATE FOR THIS GROUP OF CLAIMS EXCEEDS THE TOTAL OF THE ORIGINAL APPROPRIATION. 41S 100175-00, 41S 100181-00.

3. The documentation supporting claims 41S 100175-00 and 41S 100181-00 is a GW3, Notice of Completion of Groundwater Appropriation Without a Well, which was attached to the Statements of Claim. The GW3 states the amount of water claimed is "20 to 30 gals per minute."

Conflicting information was provided on the individual Statements of Claim; both claims were claimed and decreed with 40.00 gallon per minute (gpm) flow rates.

- 4. During examination of the claims, the DNRC examiner added the over-filed notice of appropriation issue remark to the claims because they overclaim the 20.00 to 30.00 gpm indicated on the GW3 form. Based on the information available, it appears the flow rate for both claims should be reduced to 30.00 gpm.
- 4. An Order was issued setting a deadline to determine if Claimants Leon E. Olson and Virginia A. Olson agree or disagree that the flow rates for claims 41S 100175-00 and 41S 100181-00 should be reduced to 30.00 gpm. (Doc. 11.00). The Order indicated that if nothing were filed by the deadline, it would be determined that the Claimants agree with the proposed resolution and a Master's Report was issued. Nothing was filed by the November 7, 2025 deadline.

PRINCIPLES OF LAW

- 1. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Mont. Code Ann. § 85-2-227 (2025); Rule 10, W.R.Adj.R. Prima facie proof may be contradicted and overcome by a preponderance of the evidence. Rule 19, W.R.Adj.R. A preponderance of the evidence is evidence that shows a fact is "more probable than not." *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 438, 240 P.3d 628.
- 2. If prima facie status is overcome, the burden shifts back to the claimant to demonstrate historical use. *79 Ranch v. Pitsch*, 204 Mont. 426, 432-33, 666 P.2d 215, 218 (1983).
- 3. Section 85-2-248(2), MCA, requires that the Water Court resolve all issue remarks that are not resolved through the objection process. *See also* Rule 7, W.R.Adj.R.
- 4. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. §§ 85-2-227, -231(2), MCA.
- 5. When resolving issue remarks, the Water Court must weigh the information resulting in the issue remark and the issue remark against the claimed water right. § 85-2-247(2), MCA. The factual evidence on which an issue remark is based must meet the preponderance of evidence standard before the prima facie status of a claim is overcome. 43Q 200996-00 et al., Order Establishing Volume and Order Closing Case, at 18, June 8, 2015.

CONCLUSION OF LAW

1. The information in the record overcomes the prima facie status of claims 41S 100175-00 and 41S 100181-00 and the flow rates for the claims should be modified be modified to 30.00 gpm, consistent with the GW3 form attached to the Statement of Claim.

RECOMMENDATIONS

1. The flow rate for claims 41S 100175-00 and 41S 100181-00 should be reduced from 40.00 gpm to 30.00 gpm.

2. The issue remarks should be removed from the claim abstracts.
