MASTER'S REPORT

FINDINGS OF FACT

- 1. Sherri A. Olson and Virginia R. Olson (the Olsons) are the record owners of claim 41S 20689-00.
 - 2. Claim 41S 20689-00 was decreed with the source listed as:

Source Name: SPRING, UNNAMED TRIBUTARY OF FRAZIER CREEK

3. The following issue remark was decreed on claim 41S 20689-00:

ON 12/19/1986 THE MONTANA DEPARTMENT OF NATURAL RESOURCES AND CONSERVATION FILED A MEMORANDUM STATING THAT THE SOURCE SHOULD BE SPRING, UNNAMED TRIBUTARY OF SEVEN SPRING COULEE. THIS WILL BE HEARD AFTER PROPER NOTICE ON THE NEXT OBJECTION LIST.

4. An Order Consolidating and Order Setting Filing Deadlines was issued on October 6, 2025 setting a deadline for Claimants **Sherri A. Olson and Virginia R. Olson** to file a statement agreeing or disagreeing with modifying the source name for claim 41S 20689-00 as follows:

Source Name: SPRING, UNNAMED TRIBUTARY OF FRAZIER-CREEK SEVEN SPRING COULEE

(Doc. 11.00). On November 3, 2025, the Olsons filed a Response indicating in part:

Sherri A. Olson and Virginia R. Olson request the following modifying Source Name: "SPRING, UNNAMED TRIBUTARY OF FRAZIER GREEK SEVEN SPRING COULEE ROSS FORK CREEK" based on the USGS topographic maps. ROSS FORK CREEK is the next named downstream source NOT Frazier Creek or Seven Spring Coulee.

(Doc. 2.00).

- 5. An Order Setting Deadlines Pursuant to Section 85-2-248(5), MCA was issued ordering the Claimants to work with the DNRC to address the DNRC issue remark. (Doc. 3.00).
- 6. On November 18, 2025, DNRC Water Resources Specialist Brandon Ahlgren filed a Memorandum indicating his agreement with the Claimants. Mr. Ahlgren stated that the correct source name for claim 41S 20689-00 is "Spring, Unnamed Tributary of Ross Fork Creek." (Doc. 4.00).

PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court must address all issue remarks decreed on a claim. Mont. Code Ann. § 85-2-248 (2025).
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. § 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard

of proof applies to objectors and claimants objecting to their own water right claims.

Rule 19, W.R.Adj.R.; Nelson v. Brooks, 2014 MT 120, ¶ 34, 375 Mont. 86, 329 P.3d 558.

RECOMMENDATIONS

- 1. The source name for claim 41S 20689-00 should be modified to "Spring, Unnamed Tributary of Ross Fork Creek."
 - 2. The issue remark should be removed from 41S 20689-00
