

MASTER'S REPORT

FINDINGS OF FACT

- 1. The record owner of domestic claim 41S 30105999 is Sparks Brothers, LLC (Claimant).
- 2. Claim 41S 30105999 was decreed with a Montana Department of Natural Resources and Conservation ("DNRC") issue remark:
 - THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 41S DECREE ISSUED 05/17/1984

The remark provided notice that claim 41S 30105999 was not included the previous decree in the Basin.

4. Sparks Brothers objected to the place of use/maximum acres and point of diversion/means of diversion for claim 41S 30105999, indicating:

The Place of Use and Point of Diversion legal descriptions are incorrect. They lie on the neighbor's property.

The correct legal description for the Well should be the NW1/4NE1/4NE1/4 of section 20, T17N, R16E.

The legal description was incorrectly listed in the Statement of Claim for Exempt Domestic Use filed March 19th, 2016.

5. Presently, the point of diversion and place of use for claim 41S 30105999 is situated on property neighboring the Sparks Brothers property and is not consistent with

the map attached to the Statement of Claim. As noted in the Objection, it appears a clerical error may have been made when the claim was filed.

- 6. An Order was issued to verify that the Objection will be resolved if the point of diversion and place of use are modified to reflect the legal land description on the Sparks Brothers property in the **NWNE**NE of Section 20, Township 17 North, Range 16 East, Fergus County. (Doc. 11.00).
- 7. On October 24, 2025, counsel for Spark Brothers, LLC confirmed the proposed modification resolves the Objection to claim 41S 30105999. (Doc. 2.00).

PRINCIPLES OF LAW

- 1. Section 85-2-248(2), MCA, requires that the Water Court resolve all issue remarks that are not resolved through the objection process. *See also* Rule 7, W.R.Adj.R.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Mont. Code Ann. § 85-2-227 (2025); Rule 10, W.R.Adj.R.
- 3. Prima facie proof may be contradicted and overcome by a preponderance of the evidence. Rule 19, W.R.Adj.R. A preponderance of the evidence is evidence that shows a fact is "more probable than not." *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 438, 240 P.3d 628.
- 4. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. §§ 85-2-227, -231(2), MCA.

CONCLUSION OF LAW

- 1. The information in the record overcomes the prima facie status of claim 41S 30105999 and it is appropriate to modify the point of diversion and place of use reflect the legal land description on the Sparks Brothers property.
- 2. The issue remark decreed on claim 41S 30105999 is a notice-type issue remarks. As no objections were filed, no further proceedings are required.
