NOTICE OF FILING OF MASTER'S REPORT

This Master's Report was filed with the Montana Water Court on the above-stamped date.

Please review this report carefully.

You have **13 days** from the service date of the notice of filing of this report to file a written objection or request an extension of the objection period. Rule 23, Water Right Adjudication Rules; Rule 6, Montana Rules of Civil Procedure. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

Montana State Board of Land Commissioners - Forestry and Trust Lands Division ["Trust Lands"] objected to each of these claims. Claims 43QJ 35076-00 and 43QJ 136208-00 have

issue remarks which need to be addressed and resolved.

Each objection includes an attached Verified Motion To Amend Water Right Claim to address and resolve the objection and issue remark(s) on the claim. As the elements requested for amendment are already included in the objection, these are not motions to amend filed pursuant to section 85-2-233(6), MCA. The objections and attached motions are viewable in the DNRC Water Right Query System at http://wrqs.dnrc.mt.gov.

APPLICABLE LAW

"All issue remarks to claims that are not resolved through the filing of an objection as provided in 85-2-233 must be resolved as provided in this section." Mont. Code Ann. § 85-2-248(2) (2025).

A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content pursuant to section 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect including for claimants objecting to their own claims. Rule 19, W.R.Adj.R.

FINDINGS OF FACT

1. For claim 43QJ 35042-00, the Second Preliminary Decree states that the legal description for the point of diversion, reservoir location, and place of use is the NWNWSW section 16, T1S, R17E, SWEET GRASS. The legal description should be the NENWSW section 16, T1S, R17E, SWEET GRASS.

The Second Preliminary Decree also includes the following notice remark:

POINT OF DIVERSION WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

The remark should be removed as having served its notice purpose.

2. For claim 43QJ 35076-00, the Second Preliminary Decree includes the following issue remarks:

THE FLOW RATE IS MISSING.

THE CLAIMED POINT OF DIVERSION IS IN QUESTION. THE LOCATION OF THE DEVELOPED SPRING CANNOT BE IDENTIFIED FROM AVAILABLE DATA.

The Second Preliminary Decree does not include a flow rate. The flow rate should be 5.00 GPM. The flow rate issue remark should be removed as addressed and resolved.

The marked map and aerial photograph copies attached to the objection and motion confirm that the legal description for the point of diversion is correct. The point of diversion issue remark should be removed as addressed and resolved.

3. For claim 43QJ 136208-00, the Second Preliminary Decree includes the following issue remark:

DUE TO BEING A LIVESTOCK DIRECT CLAIM, POINT OF DIVERSION #1 INDICATES THE PLACE OF USE ALSO INCLUDES THE N2SE OF SECTION 22 , TOWNSHIP 1N, RANGE 19E, STILLWATER COUNTY.

The Second Preliminary Decree states that the point of diversion and place of use is section 22, T1N, R19E, STILLWATER. The point of diversion and place of use should be:

The issue remark should be removed as addressed and resolved.

CONCLUSION OF LAW

The motions to amend filed by the claimant are sufficient to contradict and overcome the prima facie claim and to resolve the issue remark without evidentiary hearing. § 85-2-248(3), (11), MCA.

RECOMMENDATIONS

Based upon the above Findings of Fact and Conclusion of Law, this Master recommends that the Court make the changes specified in the Findings of Fact to correct the Second Preliminary Decree for this Basin. A Post Decree Abstract of Water Right Claim is served with this Report to confirm the recommended changes have been made in the state's centralized record system.
