Rule 23, Water Right Adjudication Rules; Rule 6, Montana Rules of Civil Procedure. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

Statement of the case

The captioned stock claims appeared in the Preliminary Decree with issue remarks. Issue remarks result from Department of Natural Resources and Conservation ("DNRC") claims examination.

The issue remarks state the claims appear to be duplicate filings and the claims were not included in the previous Basin 41F decree. Montana law requires the Water Court to resolve objections and issue remarks.

On August 8, 2025, claimant MJS Ranch, LLC, filed its Motion to Withdraw Duplicate Claim no. 41F 30116792.

Issues

- 1. Should stock claim 41F 30116792 be dismissed?
- 2. Are the issue remarks resolved?

Finding of fact

Stock claim 41F 30116792 should be dismissed.

Principles of law

- 1. A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content. Section 85-2-227, MCA. Prima facie proof may be overcome by other evidence that proves, by a preponderance of the evidence, that an element of the prima facie claim is incorrect. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R. A preponderance of the evidence is a "modest standard" and is evidence that demonstrates the fact to be proved is "more probable than not." *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 348, 240 P.3d 628.
- 2. The Montana Water Court is permitted to use information submitted by the Department of Natural Resources and Conservation, the statement of claim, information from approved compacts, and any other data obtained by the Court to evaluate water right claims. Section 85-2-231(2), MCA.

- 3. When resolving issue remarks, the Montana Water Court must weigh the information resulting in the issue remark and the issue remark against the claimed water right. Section 85-2-247(2), MCA.
- 4. The Montana Water Court has the authority to resolve issue remarks when the claim file and information available to the Court provide a sufficient basis to do so. Section 85-2-248(3), MCA.

Analysis

The DNRC Database identifies MJS Ranch, LLC as the current claimant of the captioned claims. The Montana Cadastral Database located at https://svc.mt.gov/msl/mtcadastral, identifies MJS Ranch, LLC as the current property owner of the place of use identified by the captioned claims. MJS Ranch, LLC agrees stock claim 41F 30116792 duplicates stock claim 41F 30116791.

Stock claim 41F 30116791 appeared in the decree with a duplicate claim issue remark and the following notice issue remark:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 41F DECREE ISSUED 7/25/1984.

Water users were given the opportunity to review the claim and file an objection. The deadline to file objections expired. No objections were filed to the claim.

Conclusions of law

The request to withdraw stock statement of claim 41F 30116792 is properly filed. The request to withdraw statement of claim 41F 30116792 resolves the duplicate claim issue remark appearing on claim 41F 30116791. The referenced issue remark appearing on claim 41F 30116791 noting lack of the claim's inclusion in the previous decree served its notice purpose.

Recommendations

Stock claim 41F 30116792 should be dismissed. The dismissal of the claim moots the issue remarks appearing on the claim.

The issue remarks should be removed from the abstract of stock claim 41F 30116791.

Post Decree Abstracts of Water Right Claim accompany this report to confirm implementation of the recommendations in the state's centralized water right record system.
