MASTER'S REPORT

The above-captioned claims appeared in the Preliminary Decree for the Judith River (Basin 41S) with substantive issue remarks.

The claims were consolidated into Case 41S-0412-R-2024 on August 22, 2024 and the claimant was ordered to work with the Montana Department of Natural Resources and Conservation ("DNRC") to resolve the issue remarks. On October 7, 2024 Water Resources Specialist Carli Bluhm filed a Memorandum ("Memo") (Doc. 1 3.00) making recommendations to resolve the issue remarks. On October 11, 2024, an Order Setting Filing Deadline was issued requiring the claimant to file documentation stating their position on the recommendations in the Memo. Nothing was filed by the deadline.

PRINCIPLES OF LAW

- 1. The Montana Water Court has the authority to determine the extent of all water rights in the state as they existed prior to July 1, 1973. *Fellows v. Saylor*, 2016 MT 45, ¶ 25, 382 Mont. 298, 367 P.3d 732; §§ 85-2-233, -102(13), MCA.
- 2. A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R.
- 3. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. §§ 85-2-227, -231(2), MCA.
