Rule 23, Water Right Adjudication Rules; Rule 6, Montana Rules of Civil Procedure. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

FINDINGS OF FACT

- 1. The record owners of claims 41S 121146-00 and 41S 121147-00 are Darrell J. Johnson, Lois Johnson, and the Clarence W. Rogge Irrevocable Trust (Claimants).
- 2. Claims 41S 121146-00 and 41S 121147-00 were decreed with DNRC issue remarks:
 - BASED ON INFORMATION PROVIDED TO THE LEWISTOWN REGIONAL OFFICE IN
 JUNE 2018, THE POINT OF DIVERSION IS INCORRECT. THE POINT OF DIVERSION IS
 ACTUALLY LOCATED IN THE NESESE SEC 35 TWP 16N RGE 19E FERGUS CO. SEE
 CLAIM FILE FOR MORE INFORMATION.
 - BASED ON INFORMATION PROVIDED TO THE LEWISTOWN REGIONAL OFFICE IN JUNE 2018, THE PLACE OF USE IS INCORRECT. THE PLACE OF USE IS ACTUALLY LOCATED IN THE NESESE SEC 35 TWP 16N RGE 19E FERGUS CO. SEE CLAIM FILE FOR MORE INFORMATION.

Based on notes in the claim files, it appears the issue remarks resulted from a conversation a DNRC employee had with Lois J. Johnson while Ms. Johnson was performing research and discovered point of diversion and place of use legal land description errors. The DNRC employee was unable to modify the legal land descriptions and instead added issue remarks. All issue remarks must be addressed.

3. On January 25, 2023, Lois J. Johnson objected to claim 41S 121146-00, stating:

4. An Order was issued setting deadlines for Lois J. Johnson, as Objector, to file a statement agreeing or disagreeing that the following modifications to the point of diversion and place of use legal land descriptions will resolve her Objection to claim 41S 121146-00:

The Order also required Objector Lois J. Johnson to file a map showing the location of the spring described by claims 41S 121146-00 and 41S 121147-00. (Doc. 1.00). The Order also set a deadline for Claimants Darrell J. Johnson, Lois Johnson, and the Clarence W. Rogge Irrevocable Trust to file a statement agreeing or disagreeing that the point of diversion and place of use legal land descriptions for claims 41S 121146-00 and 41S 121147-00 should be modified as follows:

5. On October 6, 2025, Lois J. Johnson filed a Response to the Order. (Doc. 2.00). The Response indicates that Lois J. Johnson agrees with the proposed point of diversion and place of use legal land description modifications proposed for claims 41S 121146-00 and 41S 121147-00; a map was included showing the location of the spring:



Lois J. Johnson indicated in the Response that Clarence W. Rogge was her father, and he passed away in March, 2015; Lois J. Johnson indicated she is the trustee of the Clarence W. Rogge Irrevocable Trust. Additionally, Lois J. Johnson indicated that J. Darrell Johnson was her husband, and he passed away in May of 2023. (Doc. 3.00).

On October 21, 2025, Lois J. Johnson filed an Affidavit of Trustee showing that she is the trustee of the Clarence W. Rogge Irrevocable Trust and Letters of Appointment showing that she is the personal representative of the estate of Jimmy Darrell Johnson. (Doc. 4.00).

PRINCIPLES OF LAW

- 1. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Mont. Code Ann. § 85-2-227 (2025); Rule 10, W.R.Adj.R.
- 2. Prima facie proof may be contradicted and overcome by a preponderance of the evidence. Rule 19, W.R.Adj.R.
- 3. A preponderance of the evidence is evidence that shows a fact is "more probable than not." *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 438, 240 P.3d 628.
- 4. If prima facie status is overcome, the burden shifts back to the claimant to demonstrate historical use. *79 Ranch v. Pitsch*, 204 Mont. 426, 432-33, 666 P.2d 215, 218 (1983).
- 5. Section 85-2-248(2), MCA, requires that the Water Court resolve all issue remarks that are not resolved through the objection process. *See also* Rule 7, W.R.Adj.R.
- 6. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. §§ 85-2-227, -231(2), MCA.
- 7. When resolving issue remarks, the Water Court must weigh the information resulting in the issue remark and the issue remark against the claimed water right. § 85-2-247(2), MCA. The factual evidence on which an issue remark is based must meet the preponderance of evidence standard before the prima facie status of a claim is overcome. 43Q 200996-00 et al., Order Establishing Volume and Order Closing Case, at 18, June 8, 2015.

CONCLUSION OF LAW

1. The information in the record overcomes the prima facie status of claims 41S 121146-00 and 41S 121147, and the claims should be modified to reflect that the legal land description of the point of diversion and place of use for both claims is in the NESESE of Section 35, Township 16 North, Range 19 East, Fergus County.

RECOMMENDATIONS

1. The point of diversion and place of use legal land description for claims

41S 121146-00 and 41S 121147-00 should be modified to reflect that they are located in the NESESE of Section 35, Township 16 North, Range 19 East, Fergus County.

2. The issue remarks should be removed from the claim abstracts.
