### **MASTER'S REPORT**

## FINDINGS OF FACT

- 1. Linda J. Eklund is the record owner of irrigation claim 41S 139283-00. Floyd T. Forbes and Linda J. Forbes are the record owners of stock water claim 41S 216142-00.
- 2. Claims 41S 139283-00 and 41S 216142-00 were decreed with Montana Department of Natural Resources and Conservation ("DNRC") issue remarks:

#### 41S 139283-00:

- THE WATER RIGHTS LISTED FOLLOWING THIS STATEMENT ARE FILED ON THE SAME FORMERLY DECREED WATER RIGHT. THE SUM OF THE CLAIMED FLOW RATES EXCEEDS THE 90 MINER'S INCHES DECREED IN CASE NO. 982, FERGUS COUNTY. 41S 139283-00, 41S 216142-00.
- THE JUDITH BASIN COUNTY WATER RESOURCES SURVEY (1963) APPEARS TO INDICATE 24.00 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.
- FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.
- DITCH NAME WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.
- THE MAXIMUM COMBINED ACRES FOR THIS GROUP OF SUPPLEMENTAL CLAIMS MAY REQUIRE MODIFICATION PENDING RESOLUTION OF MAXIMUM IRRIGATED ACRES ISSUE.

#### 41S 216142-00:

- THE WATER RIGHTS LISTED FOLLOWING THIS STATEMENT ARE FILED ON THE SAME FORMERLY DECREED WATER RIGHT. THE SUM OF THE CLAIMED FLOW RATES EXCEEDS THE 90 MINER'S INCHES DECREED IN CASE NO. 982, FERGUS COUNTY. 41S 139283-00, 41S 216142-00.
- CLAIM FILED LATE 06/28/1996. IN ADDITION TO BEING SUBORDINATE TO ALL INDIAN AND FEDERAL RESERVED WATER RIGHTS AND ALL VALID TIMELY FILED CLAIMS BASED ON STATE LAW, THIS RIGHT MAY ALSO BE SUBORDINATE TO CERTAIN PERMITS AND RESERVATIONS OF WATER. SEE SECTION 85-2-221 MCA.
- 3. A Status Conference was conducted on October 23, 2025 to address the issue remarks decreed on claims 41S 139283-00 and 41S 216142-00. Water Master Anika M. Stern was present. Linda J. Eklund was present along with James Noel and Floyd D. Forbes and Linda J. Forbes were present.

The parties discussed the issue remarks and agreed the following modifications should be made to the claims, resolving the decree exceeded (claims 41S 139283-00 and 41S 216142-00) and place of use/maximum acres and associated flow rate issue remarks (41S 139283-00):

# PRINCIPLES OF LAW

- 1. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Mont. Code Ann. § 85-2-227 (2025); Rule 10, W.R.Adj.R.
- 2. Section 85-2-248(2), MCA requires the Water Court to resolve all issue remarks that are not resolved through the objection process. The Montana Water Court has the authority to resolve issue remarks when the claim file and information available to the Court provide a sufficient basis to do so. § 85-2-248(3), MCA.


## CONCLUSIONS OF LAW

1. Claims 41S 139283-00 and 41S 216142-00 are both based on the March 1, 1882 J.C. Huntoon right for 90.00 miner's inches (2.25 cubic feet per second (cfs)) from the Judith River. The addition of flow rate information remark to claims 41S 139283-00 and 41S 216142-00, limiting the claims to 2.25 cfs (90.00 miner's inches) combined, addresses the decree exceeded issue remarks decreed on both claims in this Case.

- 2. The proposed maximum acres/place of use modifications to claim 41S 139283-00, consistent with the 1963 Judith Basin County Water Resources Survey, resolves the place of use issue remark decreed on the claim.
- 3. The information in the record overcomes the prima facie status of claims 41S 121146-00 and 41S 121147, and the claims should be modified to reflect that the legal land description of the point of diversion and place of use for both claims is in the NESESE of Section 35, Township 16 North, Range 19 East, Fergus County.
- 4. The ditch name issue remark decreed on claim 41S 139283-00 is a notice-type issue remark. As no objections were filed, no further proceedings are required.
- 5. Claim 41S 139283-00 was also decreed with a remark indicating "the combined acres" for the group of supplemental claims may need to be adjusted. Supplemental rights remarks no longer included a quantified acreage figure; the remark is obsolete and can be removed.
- 6. Claim 41S 216142-00 is a late claim. The late claim issue remark decreed on the claim gave notice that the claim could be subordinate, and therefore junior, to certain permits and reservations of water. Any party asserting a superior claim to water based on a permit or reservation was required to file an objection to that late claim during the Basin 41S objection period. Because no such objections were filed, the remark can now be removed from the late claim.

# RECOMMENDATIONS

1. Claim 41S 139283-00 should be modified as follows:



2. Claim 41S 216142-00 should be modified as follows:

CMFI: CLAIMS 41S 139283-00 AND 41S 216142-00 ARE LIMITED TO 2.25 CFS, COMBINED.

3. The issue remarks should be removed from claims 41S 139283-00 and 41S 216142-00, as the remarks are resolved.
