ORDER ON PENDING MOTION AND CLOSING CASE

This case addresses issue remarks and objections for six claims that describe rights to use water from Suce Creek in Park County. Suce Creek is a tributary of the Yellowstone River in Basin 43B that flows out of the Absaroka Mountains south of Livingston. The claimed water rights are appurtenant to property owned by several parties. These parties filed a joint motion to resolve the issue remarks and objections. For the reasons stated in this Order, the Court grants the motion, reconsolidates one of the claims into a new case, authorizes an implied claim, and closes the remainder of the claims, as modified.

BACKGROUND

The Water Court issued the Preliminary Decree for the Yellowstone River Basin, above and including Bridger Creek (Basin 43B) on May 9, 2019. The Preliminary Decree included abstracts for the following six claims, with the following pertinent elements and current owners:

The places of use for these claims describe several subdivided parcels of property along Suce Creek. The claims identify a headgate and the Skillman-Carter Ditch as the means to convey Suce Creek water to the various parcels. Stock claim 43B 143293-00 also identifies livestock direct from source as a point and means of diversion.

The claims received one or more issue remarks and objections, which include:

• All of the claims with an April 6, 1882 priority date received decree exceeded issue remark stating:

THE WATER RIGHTS LISTED FOLLOWING THIS STATEMENT ARE FILED ON THE SAME FORMERLY DECREED WATER RIGHT. THE SUM OF THE CLAIMED FLOW RATES EXCEEDS THE 120 MINER'S INCHES DECREED IN CASE NO. 6130, PARK COUNTY.

• Claims 43B 143290-00, 43B 29061-00, 43B 6287-00 each received the following overlapping place of use remark:

THE WATER RIGHTS LISTED FOLLOWING THIS STATEMENT WERE FILED BY DIFFERENT PARTIES WHO CLAIM OVERLAPPING PLACES OF USE.

• Claim 43B 7053-00 received the following prior objection resolution remark:

THE TIMELY FILED OBJECTION OF DONALD FRANK WAS AMENDED BY THE CLAIMANT TO INCLUDE POINT OF DIVERSION BECAUSE THESE ELEMENTS WERE NOT INCLUDED ON THE OBJECTION LIST, ANY WATER USER WHOSE RIGHTS MAY BE ADVERSELY AFFECTED BY ENFORCEMENT OF THESE CHANGES MAY PETITION THE APPROPRIATE COURT FOR RELIEF OR MAY FILE AN OBJECTION AT THE PRELIMINARY DECREE.

- Claims 43B 143290-00 and 43B 143293-00 received remarks regarding ownership. The claims also received P88 point of diversion or means of diversion notice-only remarks.
 - Claim 43B 195253-00 received the following two additional remarks:

THE TIMELY FILED OBJECTION OF BRIAN PRIEST WAS AMENDED BY BRIAN PRIEST TO INCLUDE POINT OF DIVERSION . BECAUSE THIS ELEMENT WAS NOT INCLUDED ON THE OBJECTION LIST, ANY WATER USER WHOSE RIGHTS MAY BE ADVERSELY AFFECTED BY ENFORCEMENT OF THIS CHANGE MAY PETITION THE APPROPRIATE COURT FOR RELIEF OR MAY FILE AN OBJECTION AT THE PRELIMINARY DECREE.

THE POINT OF DIVERSION APPEARS TO BE INCORRECT. THE POINT OF DIVERSION APPEARS TO BE IN THE SENESW SEC 17 TWP 3S RGE 10E PARK COUNTY.

• Talia Munn, Nolan Zimmerman, and Vicki Zimmerman self-objected to claim 43B 7053-00.

• The United States of America, Department of Interior, Bureau of Land Management ("United States") objected to claim 43B 143293-00. The United States based its objection on the legal description for portions of the place of use and points of diversion including federal land. The United States also generally referenced and incorporated the issue remarks into its objection.

PROCEDURAL BACKGROUND

The Court initially consolidated the claims in this case on August 13, 2024. The Court then put the case on a hearing track. Following various filings to update ownership and other matters, the parties filed a Joint Unopposed Motion to Modify Claims and Reconsolidate Claim 43B 7053-00 on August 8, 2025. (Doc. 37.00).

In addition to its other terms, the motion states the United States had informed the other parties that the proposed modifications to claim 43B 143293-00 would resolve the United States' objection. Although the United States did not formally join the motion, it likewise did not file a response objecting to the motion.⁴ At the request of the Court, the parties filed supplemental information clarifying several items. (Docs. 42.00 and 43.00).

DISCUSSION

A. Motion Terms.

The primary issue in this case is resolution of the decree exceeded issue remark. All of the claims with April 6, 1882 priority dates received the remark because they all cite as their evidentiary basis a 120 miner's inch (3.00 cfs) right decreed to T.O. and Eugene Carter in the district court case *Chris Jensen and Otto Truener v. Jerome Cobb, et al.*, Case 6130, Mont. Sixth Jud. Dist., Park County (Mar. 1, 1928). The irrigation claims based on the Carter decreed right total 2.5 cfs, which does not exceed the decreed right. However, the Department of Natural Resources and Conservation ("DNRC") evidently assumed the unquantified stock water claim caused the decree exceeded issue because the claim does not have a multiple use remark, references multiple landowners,

and also is partially owned by Janet Bernthal and several other co-owners. Some of these parties also co-own irrigation claim 43B 143290-00, which has a more junior priority date of August 30, 1902.

Under the terms of the motion, the parties jointly propose to resolve the decree exceeded issue by asking the Court to modify the claims as follows:

- Add a multiple use remark to each of the irrigation claims with April 6, 1882 priority dates to reflect that stock use is not in addition to the decreed irrigation use, but instead is a multiple use of the same right;
- Add a multiple use remark to stock claim 43B 143293-00 indicating the claim is a multiple use of three irrigation claims with April 6, 1882 priority dates (claims 43B 6287-00, 43B 29061-00, and 43B 195253-00);
- Create an implied stock claim with an August 30, 1902 priority date based on claim 43B 143293-00, the irrigation claim with the same priority date. This stock claim would be limited to the same place of use (Lots 5, 6, 7, 8, 10, 11, 12, 13 and 14) as claim 43B 143293-00;
- Limit the point of diversion and means of diversion for claim 43B 143293-00 to only the Skillman-Carter Ditch, to mirror the other claims;
- Add a remark to claim 43B 143293-00 to indicate it only is used on private land;
- Reduce the places of use for the various abstracts so the place of use is limited to the parcels of property actually owned by the claim owners;
- Correct ownership to match place of use land descriptions;
- Correct claim 43B 195253-00 point of diversion land description to match that specified in the issue remark;
- Remove claim 43B 7053-00 from this case and reconsolidate it in a new case to resolve the objections of Robert S. Pappert.

B. Analysis and Conclusions.

The modifications set out in the motion address the decree exceeded issue by the combination of adding multiple use remarks and creating an implied stock water claim

with a more junior August 30, 1902 priority date, which mirrors the priority date for irrigation claim 43B 143290-00. As modified, the combined flow rate of the April 6, 1882 decreed rights (including the Munn/Zimmerman claim 43B 7053-00) is 2.5 cfs, which resolves the issue remark.

The motion also meets the standard to authorize an implied stock water claim with an August 30, 1902 priority date. The implied claim essentially is a split of claim 43B 143293-00, with the split portion allocated to the parties owning land within the place of use of irrigation claim 43B 143290-00, which also has an August 30, 1902 priority date. The implied claim is based on the same decreed right as forms the basis for claim 43B 143290-00, and more accurately reflects the two sets of multiple use rights without increasing the burden on the source. As such, it satisfies the Court's implied claim test. *In re Foss*, Case 76HF-580, 2013 Mont. Water LEXIS 17 (Jan. 31, 2023).

The remaining issue remarks also are resolved. No party asserts any unresolved objections to the claims remaining in this case. Likewise the modifications also respond to the legal land description concerns raised by the issue remark for claim 43B 195253-00 and the United States' objection to claim 43B 143293-00.

Finally, while sometimes claim reconsolidation results in piecemeal litigation, reconsolidating claims also can promote efficiency by avoiding having resolved claims languish while remaining issues for a single claim remain unresolved. Reconsolidating claim 43B 7053-00 into a new case to resolve the objection of Robert S. Pappert promotes such efficiency. Other than the flow rate, the issues raised by the Pappert objection do not overlap with the issues being resolved by the motion. The flow rate overlap can be resolved by limiting the flow rate to not more than 1.5 cfs, which no one seems to dispute.

ORDER

Therefore, it is ORDERED:

⁵ Because each irrigation right is owned separately, three separate multiple use remarks are included on claim 43B 143293-00, each specific to a specific irrigation right and the more extensive stock water right.

- 1. The Joint Unopposed Motion to Modify Claims and Reconsolidate Claim 43B 7053-00, as clarified, is GRANTED.
- 2. Claims are modified as provided in this Order, with all issue remarks removed and all objections resolved.
- 3. Implied claim 43B 30172118 is authorized based on claim 43B 143293-00, split as proposed, with an August 30, 1902 priority date.
- 4. Claim 43B 7053-00 is reconsolidated into case 43B-1294-R-2025, with the decree exceeded remark resolved; provided that no increase to the flow rate will be authorized.

Post-decree abstracts of the claims are included with this Order to confirm the modifications to the claims have been made in the State's centralized water rights record system.
