Jordahl Cattle Company LLC stockwater claims 43QJ 33898-00, 43QJ 33901-00, 43QJ 33905-00, 43QJ 33906-00, 43QJ 33907-00, 43QJ 33908-00, 43QJ 33909-00, 43QJ 33910-00, 43QJ 33911-00, 43QJ 33913-00, 43QJ 33914-00, 43QJ 33915-00, 43QJ 33917-00, 43QJ 33918-00, 43QJ 33919-00, 43QJ 33920-00, 43QJ 33921-00, 43QJ 33922-00, 43QJ 33923-00, 43QJ 33924-00, 43QJ 33925-00, 43QJ 33926-00, 43QJ 33927-00, 43QJ 33928-00, 43QJ 33929-00, 43QJ 33930-00, 43QJ 33931-00, and 43QJ 33932-00 each appeared in the Second Preliminary Decree with the following issue remark:

THE FLOW RATE IS MISSING.

Claim 43QJ 33915-00 also has the following issue remark:

THE CLAIMED POINT OF DIVERSION IS IN QUESTION. THE LOCATION OF THE DEVELOPED SPRING CANNOT BE IDENTIFIED FROM AVAILABLE DATA.

The Montana Department of Natural Resources and Conservation ["DNRC"] reviews water right claims to confirm the historical use of a claim. If the review cannot confirm some aspect of a claim, an issue remark is added to the claim. The issue remarks were not addressed through the objection process. The Water Court is required to resolve the issues raised by each issue remark. Section 85-2-248, MCA.

Under Section 85-2-248(3), MCA, information in the claim file or other information obtained by the Court can be reviewed to determine if it provides a sufficient basis to resolve the issue raised by a remark. In this instance, the Statements of Claim provide the needed information. The scanned copy of each Statement of Claim is viewable on the DNRC Water Right Query System at <http://wrqs.dnrc.mt.gov>.

APPLICABLE LAW

"All issue remarks to claims that are not resolved through the filing of an objection as provided in 85-2-233 must be resolved as provided in this section." Section 85-2-248(2), MCA.

A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content pursuant to section 85-2-227, MCA. This prima facie proof may be contradicted and

overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect including for claimants objecting to their own claims. Rule 19, W.R.Adj.R.

FINDINGS OF FACT

1. For claim 43QJ 33898-00, the Second Preliminary Decree includes the standard flow rate remark for direct from source stock use. The issue remark is erroneous and should be removed.

In addition, the following remark appears at the priority date: THIS IS AN EXISTING RIGHT. ITS POST-1973 PRIORITY DATE IS DECREED PURSUANT TO SECTION 85-2-306(4) MCA. There is no basis for adding this remark. The scanned copy of the claim file includes no documentation or rationale for adding this remark. This remark should be removed as clearly erroneous.

2. For claim 43QJ 33901-00, the Second Preliminary Decree does not include a flow rate. The flow rate should be 5.00 GPM as specified on the Statement of Claim. The issue remark should be removed as addressed and resolved.

3. For each of claims 43QJ 33905-00, 43QJ 33906-00, 43QJ 33908-00, 43QJ 33909-00, 43QJ 33910-00, 43QJ 33914-00, 43QJ 33917-00, 43QJ 33918-00, 43QJ 33919-00, 43QJ 33920-00, 43QJ 33923-00, 43QJ 33924-00, 43QJ 33925-00, 43QJ 33926-00, 43QJ 33929-00, 43QJ 33931-00, and 43QJ 33932-00, the Second Preliminary Decree does not include a flow rate. The flow rate for each claim should be 1.00 GPM as specified on each of their Statements of Claim. The issue remarks should be removed as addressed and resolved.

4. For each of claims 43QJ 33907-00, 43QJ 33911-00, 43QJ 33913-00, 43QJ 33921-00, 43QJ 33922-00, 43QJ 33927-00, 43QJ 33928-00, and 43QJ 33930-00, the Second Preliminary Decree does not include a flow rate. The flow rate for each claim should be 2.00 GPM as specified on each of their Statements of Claim. The issue remarks should be removed as addressed and resolved.

5. For claim 43QJ 33915-00, the Second Preliminary Decree does not include a flow rate. The flow rate should be 1.00 GPM as specified on the Statement of Claim. The flow rate

issue remark should be removed as addressed and resolved.

The Second Preliminary Decree also includes the following issue remark on the abstract of this claim:

THE CLAIMED POINT OF DIVERSION IS IN QUESTION. THE LOCATION OF THE DEVELOPED SPRING CANNOT BE IDENTIFIED FROM AVAILABLE DATA.

The DNRC Re-Examination worksheets document the addition of this issue remark but do not include a copy of the relevant aerial photograph substantiating the assertion that no developed spring is evident as claimed. The topographic map copy attached to the Statement of Claim is marked at the claimed point of diversion. Although the copy quality is poor, it is clear that the marking is at the head of a draw, there is a stream coming out of the draw, and that stream flows into Countryman Creek, South Fork. The point of diversion issue remark should be removed as addressed and resolved.

CONCLUSION OF LAW

The information provided on the Statements of Claim and their attachments is sufficient to resolve the issue remarks without evidentiary hearing. Sections 85-2-248(3) and (11), MCA.

RECOMMENDATIONS

Based upon the above Findings of Fact and Conclusion of Law, this Master recommends that the Court make the changes specified in the Findings of Fact to correct the Second Preliminary Decree for this Basin. A Post Decree Abstract of Water Right Claim for each claim is served with this Report to confirm the recommended changes have been made in the state's centralized record system.
