NOTICE OF FILING OF MASTER'S REPORT

This Master's Report was filed with the Montana Water Court on the above-stamped date.

Please review this report carefully.

You have **13 days** from the service date of the notice of filing of this report to file a written objection or request an extension of the objection period. Rule 23, Water Right Adjudication Rules; Rule 6, Montana Rules of Civil Procedure. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

Sunlight Ranch Co. objected to each of these claims. Some of the claims also have issue remarks. On January 8, 2025 Sunlight Ranch Co. filed its Proposed Resolution Of Objections [“Proposed Resolution”][Doc. 3]. On July 14, 2025 the Order Rejecting In Part Proposed Resolution Of Objections was entered [Doc. 7]. The “Part” that was rejected is the request to change the claimed rights from USE rights to RESERVED *Walton* Rights. On August 21, 2025 the Response To Order Setting Deadline For Filing Additional Information [“Response”] was filed [Doc. 8]. The Response reports that additional research indicates none of these claims are *Walton* Rights and should remain as USE rights. These documents are viewable in the Court’s FullCourt Enterprise case management system.

APPLICABLE LAW

“All issue remarks to claims that are not resolved through the filing of an objection as provided in 85-2-233 must be resolved as provided in this section.” Section 85-2-248(2), MCA.

“‘Implied Claim’ means a claim authorized by the water court to be separated and individually identified when a statement of claim includes multiple rights.” Rule 2(a)(33), W.R.C.E.R.

From 41P-108 “Circle S Ranch, Inc.” Order On Motion To Modify Claims 5-16-19, at 2019 Mont. Water LEXIS 8, page 5:

The Water Court recognizes implied claims in certain circumstances *In re Musselshell River below Roundup*, Case 40C-47, 1994 Mont. Water LEXIS 18, *78 (July 14, 1994). However, before the Court will recognize an implied claim, the claimant must prove that several factors exist. These include: (1) proof of two or more water rights in the original claim form or the material submitted with the claim form; (2) proof of historic use corroborating the implied claim; and (3) proof that recognizing the implied claim(s) will avoid causing a change to historic water use or increase the historic burden to other water users. *In re Foss*, Case 76HF-580, 2013 Mont. Water LEXIS 17, *32 (Jan. 31, 2013); *In re Martinell*, Case 41A-148, 2018 Mont. Water LEXIS 3, *6 (June 14, 2018). These standards assure that implied claims are not used to revive a claim that was forfeited as a matter of law by missing the filing deadline. Mont. Code Ann. § 85-2-226 (establishing conclusive presumption of abandonment of for claims not timely filed); *In re Climbing Arrow Ranch*, Case 41F-A19, 2019 Mont. Water LEXIS 1 (Mar. 6, 2019). The implied claim process also cannot be used to expand the elements of a statement of claim. *In re Eliasson Ranch Company*, Order Amending and Adopting Master’s Report, Case 40A-115, 2004 Mont. Water LEXIS 2, *6 (Jun. 28, 2004) (“*Eliasson*”).

The Montana Water Court has jurisdiction to review a motion to amend pursuant to section 85-2-233(6), MCA.

Rule 15 M.R.Civ.P. restricts the scope of the amendments to the conduct, transaction, or occurrence set forth in the original pleading or, in other words, the “same set of operative facts as contained in the original pleading.” *Sooy v. Petrolane Steel Gas, Inc.*, 218 Mont. 418, 422-423 (1985). The requested amendment “merely makes more specific that which has already been alleged.” *Prentice Lumber Company v. Hukill*, 161 Mont. 8, 15 (1972).

Notice must be published by newspaper if the requested amendments “may adversely affect other water rights.” Section 85-2-233(6)(a)(i), MCA.

A properly filed Statement of Claim for Existing Water Right is *prima facie* proof of its content pursuant to section 85-2-227, MCA. This *prima facie* proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect including for claimants objecting to or amending their own claims. Rule 19, W.R.Adj.R.

FINDINGS OF FACT

1. For claim 43P 30145299, the Interlocutory Decree includes the following issue remark:

THIS CLAIM APPEARS TO BE CLAIMING TWO(2) SEPARATE SOURCES OF WATER. MORE THAN ONE WATER RIGHT MAY BE INVOLVED.

The Interlocutory Decree states that the sources are Cottonwood Creek, Unnamed Tributary of Cottonwood Creek, and Cottonwood Creek, South Fork. The Proposed Resolution requests generation of an implied claim for the Cottonwood Creek, South Fork portions of this claim. Some of the point of diversion and place of use legal descriptions need to be adjusted to apportion them between the two claims.

2. Claim 43P 30145299 should be used for the Cottonwood Creek and Unnamed Tributary of Cottonwood Creek portion. Implied claim 43P 30172742 should be used for the Cottonwood Creek, South Fork portion. The issue remark should be removed as addressed and resolved.

3. For claim 43P 30145299, the Interlocutory Decree includes 16 points of diversion and 16 matching places of use. Two of those should be adjusted. The point of diversion and place

of use identified as the E2W2 section 30, T2N, R35E, BIG HORN should be changed to the E2NW section 30, T2N, R35E, BIG HORN. The point of diversion and place of use identified as the W2E2 section 30, T2N, R35E, BIG HORN should be changed to the NWNE section 30, T2N, R35E, BIG HORN. The source for each of these diversions should be changed from COTTONWOOD CREEK, SOUTH FORK to UNNAMED TRIBUTARY COTTONWOOD CREEK.

The following notice remark also appeared on the abstract for this claim:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43P DECREE ISSUED 01/28/2016.

This remark should be removed as having served its notice purpose.

4. The elements of implied claim 43P 30172742 should be the same as 43P 30145299 except the source should be COTTONWOOD CREEK, SOUTH FORK, and the points of diversion and places of use should be: SWNE section 30, T2N, R35E, BIG HORN, E2SE section 30, T2N, R35E, BIG HORN, and E2SW section 30, T2N, R35E, BIG HORN.

5. For claims 43P 30145300, 43P 30145301, 43P 30145302, 43P 30145303, 43P 30145304, and 43P 30145305, there are no changes to be made to the elements of these claims. The following notice remark appeared on the abstract for each claim:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43P DECREE ISSUED 01/28/2016.

This remark should be removed from each abstract as having served its notice purpose.

6. For claim 43P 30145306, the Interlocutory Decree includes 10 points of diversion and 10 matching places of use. Two more should be added to the point of diversion and place of use: N2N2 section 2, T2N, R35E, BIG HORN and NENE section 3, T2N, R35E, BIG HORN.

The following notice remark also appeared on the abstract for this claim:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43P DECREE ISSUED 01/28/2016.

This remark should be removed as having served its notice purpose.

7. For claim 43P 30145307, the Proposed Resolution requests changes to the point of diversion and place of use legal descriptions. As point of diversion and place of use are not at issue, this is deemed the claimant's motion to amend claim pursuant to section 85-2-233(6), MCA.

The changes requested in the motion to amend arise out of the same conduct, transaction, or occurrence specified on the original Statement of Claim, are based on the same operative facts specified in the original Statement of Claim, and merely make more specific that which was already claimed on the original Statement of Claim.

The Interlocutory Decree states that the point of diversion and place of use legal descriptions are:

The following remark should be added to the abstract of this claim:

THE POINT OF DIVERSION AND PLACE OF USE LEGAL DESCRIPTIONS WERE AMENDED BY THE WATER COURT PURSUANT TO SECTION 85-2-233(6), MCA.

The following notice remark also appeared on the abstract for this claim:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43P DECREE ISSUED 01/28/2016.

This remark should be removed as having served its notice purpose.

8. For claim 43P 30145308, the Proposed Resolution requests a change to the source. As source is not at issue, this is deemed the claimant's motion to amend claim pursuant to section 85-2-233(6), MCA.

The changes requested in the motion to amend arise out of the same conduct, transaction, or occurrence specified on the original Statement of Claim, are based on the same operative facts specified in the original Statement of Claim, and merely make more specific that which was already claimed on the original Statement of Claim.

The Interlocutory Decree states that the source is UNNAMED TRIBUTARY OF DEER COULEE. The source for the point of diversion in the S2 section 22, T3N, R35E, TREASURE should be DEER COULEE.

The following remark should be added to the abstract of this claim:

THE SOURCE WAS AMENDED BY THE WATER COURT PURSUANT TO SECTION 85-2-233(6), MCA.

The following notice remark also appeared on the abstract for this claim:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43P DECREE ISSUED 01/28/2016.

This remark should be removed as having served its notice purpose.

9. For claim 43P 30145309, the Interlocutory Decree includes 19 points of diversion and 19 matching places of use. One of the points of diversion and places of use should be changed. The point of diversion and place of use identified as the N2SE section 12, T2N, R35E, BIG HORN should be changed to the SE section 12, T2N, R35E, BIG HORN.

The following notice remark also appeared on the abstract for this claim:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43P DECREE ISSUED 01/28/2016.

This remark should be removed as having served its notice purpose.

10. For claim 43P 30145310, there are no changes to be made to the elements of the claim. The following notice remark appeared on the abstract for this claim:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43P DECREE ISSUED 01/28/2016.

This remark should be removed as having served its notice purpose.

11. For claim 43P 30145311, the Proposed Resolution requests changes to the point of diversion and place of use. As point of diversion and place of use are not at issue, this is deemed the claimant's motion to amend claim pursuant to section 85-2-233(6), MCA.

The changes requested in the motion to amend arise out of the same conduct, transaction, or occurrence specified on the original Statement of Claim, are based on the same

operative facts specified in the original Statement of Claim, and merely make more specific that which was already claimed on the original Statement of Claim.

The Interlocutory Decree includes 1 point of diversion and 1 matching place of use. Two more should be added to the point of diversion and place of use: S2NW section 25, T3N, R35E TREASURE and N2SW section 25, T3N, R35E, TREASURE.

The following remark should be added to the abstract of this claim:

THE POINT OF DIVERSION AND PLACE OF USE LEGAL DESCRIPTIONS WERE AMENDED BY THE WATER COURT PURSUANT TO SECTION 85-2-233(6), MCA.

The following notice remark also appeared on the abstract for this claim:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43P DECREE ISSUED 01/28/2016.

This remark should be removed as having served its notice purpose.

12. For claims 43P 30145312, 43P 30145313, 43P 30145314, 43P 30145315, and 43P 30145316, there are no changes to be made to the elements of these claims. The following notice remark appeared on the abstract for each claim:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43P DECREE ISSUED 01/28/2016.

This remark should be removed from each abstract as having served its notice purpose.

13. For claim 43P 30145317, the Interlocutory Decree includes the following issue remark:

ACCORDING TO CADASTRAL PROPERTY OWNERSHIP RECORDS, AS OF 11/07/2022 , A PORTION OF THE PROPERTY ON WHICH THIS WATER RIGHT IS USED APPEARS TO BE OWNED BY MATT J. AND SARH R NOYES, 14481 EAST SARPY ROAD, BIGHORN, MT 59010-9600 .

The Proposed Resolution states that the requested point of diversion and place of use revisions remove the Noyes property. As point of diversion is not at issue, this is deemed the claimant's motion to amend claim pursuant to section 85-2-233(6), MCA.

The changes requested in the motion to amend arise out of the same conduct, transaction, or occurrence specified on the original Statement of Claim, are based on the same operative facts specified in the original Statement of Claim, and merely make more specific that which was already claimed on the original Statement of Claim.

The Interlocutory Decree includes 11 points of diversion and 11 matching places of use. One of the points of diversion and places of use should be changed. The point of diversion and place of use identified as the NW section 22, T3N, R35E, TREASURE should be changed to the N2NW section 22, T3N, R35E, TREASURE, and the following new point of diversion and place of

use should be added: SWNW 22, T3N, R35E, TREASURE. The ownership issue remark should be removed as addressed and resolved.

The following notice remark also appeared on the abstract for this claim:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43P DECREE ISSUED 01/28/2016.

This remark should be removed as having served its notice purpose.

14. For claim 43P 30145318, the Interlocutory Decree includes the following issue remark:

THIS CLAIM APPEARS TO BE CLAIMING FOUR SEPARATE SOURCES OF WATER. MORE THAN ONE WATER RIGHT MAY BE INVOLVED.

The Proposed Resolution states that the requested point of diversion and place of use revisions make all of the points of diversion and places of use on Tullock Creek or Unnamed Tributary of Tullock Creek. The Interlocutory Decree includes 57 points of diversion and 57 matching places of use. Two of the points of diversion and places of use should be changed. The point of diversion and place of use identified as the N2SE section 30, T2N, R36E, BIG HORN should be the N2NW section 25, T3N, R35E, TREASURE. The source for this point of diversion should be UNNAMED TRIBUTARY OF TULLOCK CREEK. The point of diversion and place of use identified as the W2 section 25, T3N, R35E, TREASURE should be the S2SW section 25, T3N, R35E, TREASURE. The source for this point of diversion should be TULLOCK CREEK. The source issue remark should be removed as addressed and resolved.

The following notice remark also appeared on the abstract for this claim:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43P DECREE ISSUED 01/28/2016.

This remark should be removed as having served its notice purpose.

15. For claims 43P 30145319, 43P 30145320, 43P 30145321, 43P 30145322, and 43P 30145323, there are no changes to be made to the elements of these claims. The following notice remark appeared on the abstract for each claim:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43P DECREE ISSUED 01/28/2016.

This remark should be removed from each abstract as having served its notice purpose.

16. For claim 43P 30145324, the Interlocutory Decree includes the following issue remarks:

ACCORDING TO CADASTRAL PROPERTY OWNERSHIP RECORDS, AS OF 11/22/2022 , A PORTION OF THE PROPERTY ON WHICH THIS WATER RIGHT IS USED APPEARS TO BE OWNED BY POCKET CREEK RANCH LLC, 1350 HORSE CREEK ROAD, HYSHAM, MT 59038-9617.

THIS CLAIM APPEARS TO BE CLAIMING TWO SEPARATE SOURCES OF WATER. MORE THAN ONE

WATER RIGHT MAY BE INVOLVED.

The Proposed Resolution states that the requested point of diversion and place of use revisions exclude the Pocket Creek Ranch LLC property, and make all of the points of diversion and places of use on Bighorn River or Unnamed Tributary of Bighorn River. The Interlocutory Decree includes 26 points of diversion and 26 matching places of use. One of the points of diversion and places of use should be changed. The point of diversion and place of use identified as the E2 section 25, T2N, R34E, BIG HORN should be changed to the E2 section 25, T2N, R33E, BIG HORN. The source identified for this diversion should be changed from HOSHOW COULEE to UNNAMED TRIBUTARY OF BIGHORN RIVER. The ownership and source issue remarks should be removed as addressed and resolved.

The following notice remark also appeared on the abstract for this claim:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43P DECREE ISSUED 01/28/2016.

This remark should be removed as having served its notice purpose.

CONCLUSION OF LAW

1. For claims 43P 30145307, 43P 30145308, and 43P 30145317, the requested amendments do not adversely affect other water rights as they are corrections to the abstracts which does not make any change to the actual historical use of the claimed rights on the ground. Notice by publication of these amendments is not required. Section 85-2-233(6), MCA.
2. For claim 43P 30145311, the requested two additional points of diversion and places of use are on the same source, Rough Creek, but somewhat distant from the claimed point of diversion and place of use. The requested additions are in the S2NW and N2SW section 25, T3N, R35E, TREASURE. Another claim in this Case – 43P 30145318 – appeared in the Interlocutory Decree with the entire W2 section 25, T3N, R35E, TREASURE, source Rough Creek. That stretch of Rough Creek is being removed from claim 43P 30145318 and added to claim 43P 30145311, with more refined legal descriptions. This requested amendment does not adversely affect other water rights as it is a correction to the abstract which does not make any change to the actual historical use of the claimed right on the ground. Notice by publication of this amendment is not required. Section 85-2-233(6), MCA.
3. Each of the requested amendments “merely makes more specific that which has already been alleged.” *Prentice Lumber Company v. Hukill*, 161 Mont. 8, 15 (1972).

4. The settlement documents filed by the claimant are sufficient to contradict and overcome the *prima facie* claims, generate an implied claim, and resolve the issue remarks without evidentiary hearing. Sections 85-2-248(3) and (11), MCA.

RECOMMENDATIONS

Based upon the above Findings of Fact and Conclusions of Law, this Master recommends that the Court generate the implied claim, grant the motions to amend, and make the changes specified in the Findings of Fact to correct the Preliminary Decree for this Basin. A Post Decree Abstract of Water Right Claim for each claim is served with this Report to confirm the recommended changes have been made in the state's centralized record system.
