


Rate of children screened in for an investigation or assessment.

(per 1,000 children in population; children < age 18)




Rate of children screened in and substantiated in an investigation.

(per 1,000 children in population; children < age 18)




Rate of children entering care.











Rate of children entering care.



by race/ethnic group




Rate of AIAN children entering care by age group.

(per 1,000 children in population; children < age 18)




Entry reasons (Montana).

(children < age 18; fiscal year 2021)




Entry reasons (Team/Region).
