






**Rate of children screened in for an investigation or assessment.**  
 (per 1,000 children in population; children < age 18)




**by race/ethnic group**




**Rate of children screened in and substantiated in an investigation.**  
 (per 1,000 children in population; children < age 18)






**Rate of children entering care.**







### Rate of children entering care.



### by race/ethnic group




### Rate of AIAN children entering care by age group.

(per 1,000 children in population; children < age 18)




### Entry reasons (Montana).

(children < age 18; fiscal year 2021)




### Entry reasons (Team/Region).

### Entry reasons (AIAN; Team/Region).



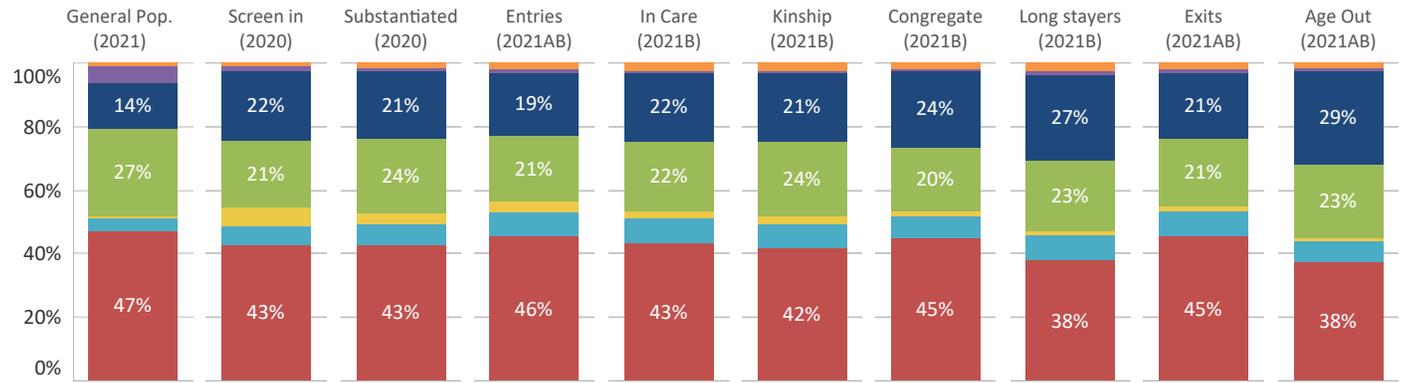

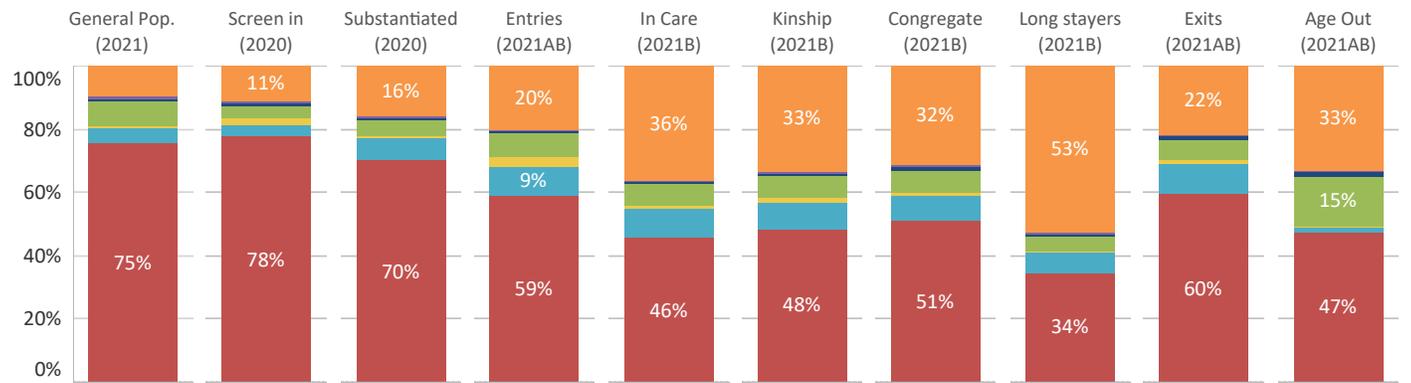
