- (3) Discussion of Seneca letters going out, seeing who responds, and perhaps sending out more periodic letters;
- (4) Difficulty in getting the timing of an ICPC correct so that it is done when you need it and has not expired;
 - (5) Making sure CASA is included early and consistently in any decision making;
 - (6) Need to talk about all possibilities for the child, not just the parents' preference, and discussion

of basis of the parents' preference; and

(7) Judge Eddy has added concurrent planning to her order outlining the status of the matter after the EPS hearing.

Regarding barriers to concurrent planning: CFS sometimes feel pressured to put all their efforts into reunification, instead of fostering concurrent planning options. Some attorneys object to concurrent plans. Family relationships aren't always easy - there may be family conflict. Family members may not support reunification or support the parents. Positive steps forward: Need to ask parent who their support person might be, and get that person involved. It changes things with the level of trust and transparency. Respite is also a piece that is missed. If we have a kinship or trusted arrangement, the respite care language is less threatening.

In the second Flathead County team, the County Attorney believes that 'concurrent planning' is a term that ought to be replaced with the term 'contingency planning' to more accurately reflect what the law is seeking to accomplish and as a more accurate descriptor of this necessary process. Both CFS and the County Attorney believe that the change in implementing 'concurrent planning' should come about with the CPS discussing with parents a backup plan at the time of removal, discussion among all of the participants with the parents at the prehearing conference of this topic, and all participants discussing with the parents at Family Engagement Meetings the need to have a 'backup plan' in the event that things don't go well with the primary plan of reunification. They believe this would also serve to encourage parents to overcome their understandable desire to avoid involving others – including close family members and acquaintances – in their troubles and in their case.
