Why was this study conducted?


- To respond to current interest in treatment courts

The treatment court model and evidence base

- Treatment courts work
- They reduce substance use and recidivism
- They offset costs and protect public safety
- Montana would benefit from increased investment in these programs



NEED FOR TREATMENT COURTS IN MONTANA



Drug-related crime

 12,187 drug-related offenses committed in Montana in 2016 that would be eligible for treatment

court

- 5,488 DUI offenses
- 4,098 sentences were imposed that placed individuals in DOC custody – the #1 offense for adult felony convictions was possession of drugs (both men and women)
- 1,639 people based on drug-related crimes alone that are likely eligible for treatment courts each year





Types of programs: Adult, DUI, Family, Veterans, Co-Occurring/Mental Health, Juvenile, Tribal

Montana Treatment Courts

- Current state funding allocation is \$1.3 Million
- 16 programs funded by state dollars
- Average funding: \$82,852 per program
- Total number of treatment courts in Montana: 36
- Number of active participants: 564 (20 on average per program)

RECOMMENDATIONS



Advocate for additional state funding

- Staff positions
- Treatment
- Team members/partner time
- Office and courtroom space
- Drug testing
- Equipment
- Evaluation





Reinstate Medicaid funds

- Continue Medicaid expansion
- Increase reimbursement rates to a feasible level
- Remove limitations that create a barrier to appropriate treatment services





Provide a grant writer

- DTCAC determines priorities for treatment court expansion and new programs
- Partner with Montana
 Healthcare Foundation
- Seek Federal funds for program startup/implementation
- Focus on building programs in urban areas



Seek federal funds to support a model approach for rural and frontier areas

- Write a statewide implementation grant
- Maintain alignment with best practices
- Develop alternative models that are cost effective and meet the needs of rural and frontier communities
- Utilize telehealth





Meet with key partners

- Supreme Court/Judicial
 Branch
- Department of Corrections
- County Attorneys
- Department of Public Health and Human Services
- Federally Qualified Health Centers





Explore resources for utilizing telehealth

- Identify places that have equipment
- Identify partners who can help with coordination
- Provide training for staff



Dedicate resources for training



- Annual training for all team members and programs
- Drug court model, roles, policies and procedures, current/new research



Establish training and resources for screening and assessment



Tools

- Training
- Use of screening and assessment for program eligibility and determination of services



Follow best practices in drug testing



- Frequent, random, observed
- Timing of samples, results, and responses
- Examine for tampering
- Use appropriate test for program, population, and substance
- Policies and procedures




Pursue inclusion of peer support for treatment courts



- Utilize peer mentors who are certified and trained in addiction, treatment, and the treatment court population
- Develop policies and procedures for hiring, supervising, and supporting mentors




Encourage program implementation of a treatment court data system





- Train appropriate program staff
- Establish a quality control system
- Use reports to monitor program effectiveness
