What is CitePayUSA

CitePayUSA is an online payment services provider used to make secure payments to the courts. CitePayUSA is available 24/7 and allows payments by all major Debit and Credit Cards (excluding American Express) and direct payments from a checking account.

CitePayUSA is used by Montana’s E-Filing courts to allow the seamless online payment of civil statutory filing fees.

How to get to CitePay

Statutory filing fees are applied to certain filing subtypes. Selecting one of these filing subtypes will prompt you to make a payment. When you have a filing with fees associated to it in your cart and you click Submit Filing, you will be automatically routed to CitePayUSA so that you can make a payment. A list of the filing subtypes which prompt for payment are listed in Appendix A.

Note: If you submitted a filing with a payment and it was rejected, use the fee waiver “Already Paid” on the Filing Information screen when you resubmit your filing so that you are not asked to pay for the filing again. When you use the fee waiver “Already Paid” provide the receipt number, the attorney’s name, and the date of the original submission.

CitePayUSA gives e-filers two options to make a payment. These options are One-Time (card) Payment or using a Wallet.

You have been forwarded to CitePayUSA to make a payment of 70.00. To complete this payment, you may either create a "Wallet" at CitePay referencing one or more credit card and/or checking accounts, which you can use to make this and future payments, or you may make a one-time payment using a credit card.

One-Time Payment

The one-time payment option allows users to make a single payment without creating a wallet. With one-time payment users must pay with a credit or debit card; direct payment from a checking account is not available with this option.

After clicking One-Time Payment fill out all the required fields on the payment screen, indicated by a *. Even though Receipt Email Address is not a required field it is recommended that you enter an email address so that you receive a receipt for your payment. Click Process Payment.

Your filing will be submitted to the clerk's office, and you will be automatically redirected back to E-Filing.

Wallet

A wallet allows you to store a credit card, debit card, and/or a checking account for making payments.

Wallets are specific to the attorney. Attorneys cannot share wallets, and if you are support staff filing on behalf of multiple attorneys you must have a separate wallet for each attorney.

Creating a Wallet

Begin creating a wallet by clicking the **Create A Wallet** button.

To complete this payment, you may either create a "Wallet" at CitePay referencing one or more credit card and/or checking accounts, which you can use to make this and future payments, or you may make a one-time payment using a credit card.

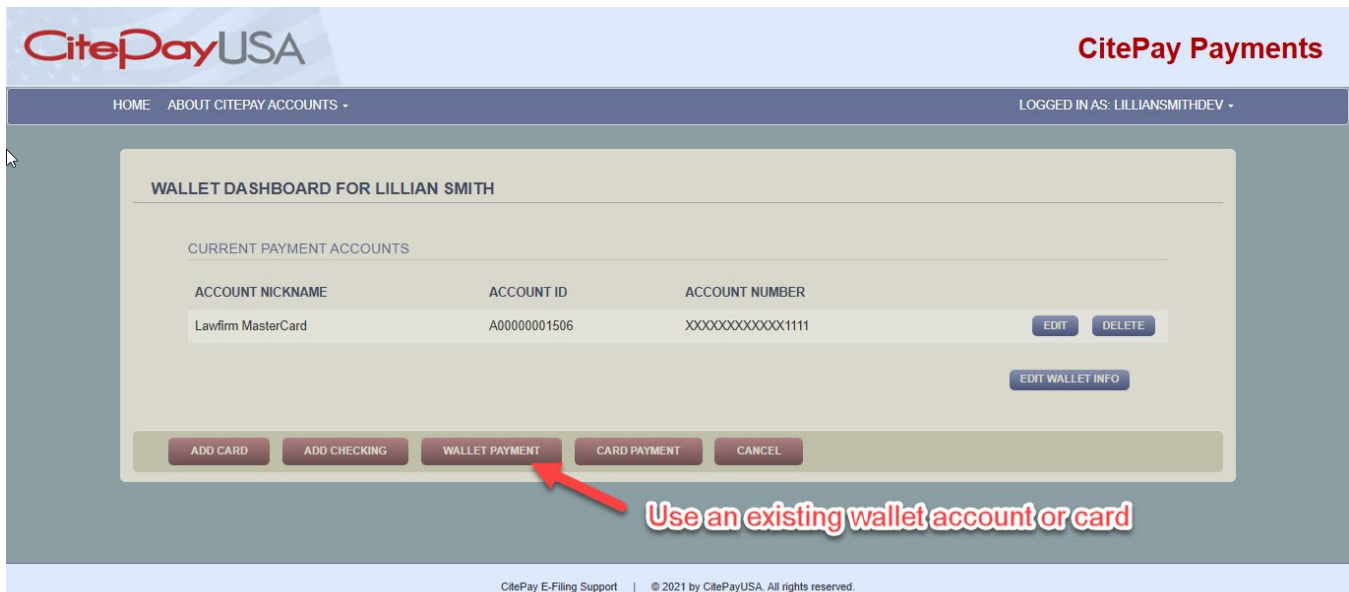

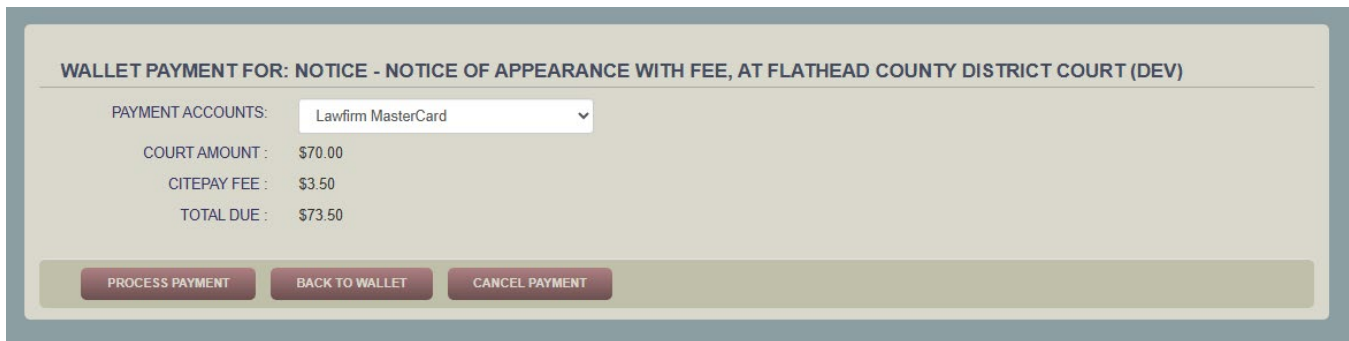

Editing a Wallet

Access the CitePayUSA payment processor portal using this link: <https://www.citepayusa.com/auths/login/auth>. Log in using your username and password you use for your wallet. Click **Edit** beside the account name to edit information on a previously saved card or checking account. Click **Edit Wallet Info** to change the email address related to your wallet. Add a new card or checking account with the **Add Card** or **Add Checking** buttons at the bottom of the screen. You can also edit your wallet after logging in to your wallet while making a payment through E-Filing

Processing Fee

The processing fee for a card payment is 5% of the fee amount. The processing fee for a direct payment from a checking account is a \$3.00 flat fee. This fee is not collected by Montana, the Judicial Branch, the court, or E-Filing. It is collected by CitePayUSA as surcharge for processing the payment.
