Executive Order amending Executive Orders 1-77 and 4-77.

I, Thomas L. Judge, in accordance with the authority vested in me as Governor by the laws and Constitution of the State of Montana, and pursuant to Section 2-15-122, MCA, do hereby amend Executive Orders No. 1-77 and 4-77.

Section 3 of Executive Orders 1-77 and 4-77 are amended to read as follows:

1. MEMBERSHIP - There shall be 18 members of the Advisory Council, who shall serve at my pleasure, as designated in Attachment 1. The members shall meet the qualifications stated in 42 USC §300 m-3(b) as amended. One of the above-appointed members shall be recommended to me by the Chief Medical Director of the Veterans Administration and this member shall serve as ex officio to represent the Veterans Administration.

Section 4 of Executive Order 1-77 is amended to read as follows:


2. MEETINGS AND ORGANIZATIONS - The Advisory Council shall have a chairman as designated in Attachment 1. The chairman shall call all meetings and organize the business of the Council. The Council shall meet at least once every quarter during the calendar year and may meet outside the City of Helena, as its activities require, if the Department of Health and Environmental Sciences indicates funds are available for such meetings.

Section 6 of Executive Order 1-77 is amended to read as follows:



3. COMPENSATION - Members of the Advisory Council shall be entitled to the compensation provided in Section 2-15-122, MCA. The compensation shall be paid by the Department of Health and Environmental Sciences.
